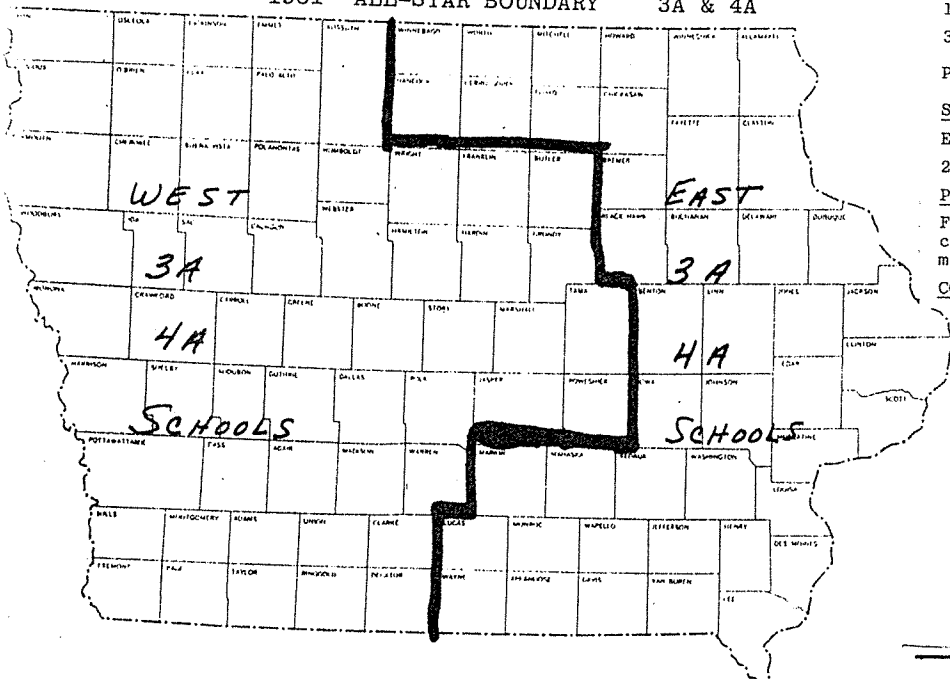

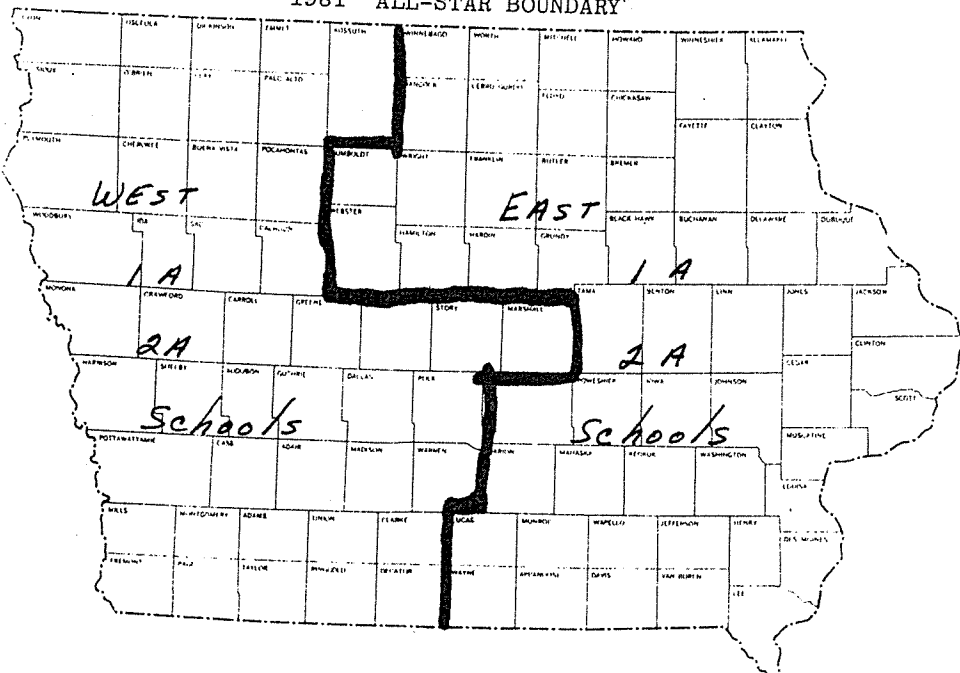

## SYNOPSIS OF THE MINUTES OF I.H.S.A.A.

**REVIEW SUMMER BASEBALL LIMITATION GUIDELINES AS IT AFFECTS REGULAR SEASON TOURNAMENTS:** First of all, correspondence from the following schools was reviewed as it affects the baseball limitation rule - specifically definition of regular season tournaments and its effect on calendar dates. School correspondence received from Urbandale, Des Moines, West Des Moines, Dowling and Johnston was reviewed by the Board. Specifically, the concern of some member schools has been the definition of a tournament as it relates to the twenty (20) playing dates for summer baseball and softball. The IGHSAU interpretation is simply a tournament counts as one of the twenty (20) playing dates regardless of the tournament length—one, two, three, four or five days; whereas the IHSAA has determined a summer baseball school could play in a tournament over a three-day period and count it as one playing date or in two, two-day tournaments, counting them as two separate playing dates within the twenty (20) date limitation each member high school summer baseball team would be permitted effective in the summer 1981. The above clarification came about as a result of previous correspondence indicating some confusion and misunderstanding on the limitation rule as it affects summer baseball and softball tournaments counting as one or two playing dates. After discussion it was moved by Rowedder, seconded by Hoenshel and adopted, to approve the current IHSAA interpretation as it affects invitational and conference tournament play for the summer high school baseball schools as stated above. It was moved by Sweet and seconded by Runyan, that the Association follow the current interpretation as it affects the limitation rule and a member school may petition to the Association to continue their interpretation as it affects the new limitation for the season 1981 and then follow the dictates of the member schools for the following seasons. Motion defeated. After further discussion, Chairman Yates instructed the Administrative Staff to design a ballot for the Board to consider at its December meeting for further discussion as it affects the definition of a tournament, providing a place for the administrator's signature.

**REVIEW BASEBALL COACHES ADVISORY COMMITTEE REPORT:** Members were previously given copies of the minutes of the meeting of the Baseball Coaches Advisory Committee held October 9, 1980. At this time they reviewed more thoroughly the Advisory Committee report. Items reviewed were: 1) Review of past Summer and Fall State Tournaments as per the committee's report. The Board was appreciative of the comments made as it affects the selection of State Tournament sites and as in the past will continue to select the State Tournament site keeping in mind the geography as it relates to a central location as well as an adequate site, noting that the Marshalltown site has been a good facility. However, the committee requested additional consideration to other good facilities in light of geography, availability, and receptiveness of wanting to hold the tournament. The Board was appreciative of the position of the Baseball Advisory Committee when they reviewed the concerns of the Mississippi Eight Athletic Directors whose thinking is that Marshalltown was not a desirable site due to inadequate parking, eating facilities, etc. The committee feels that the Marshalltown site has been a good site with adequate parking, eating facilities and if any inequities were present it would only be in lodging which is for a minimal number of people. The Advisory Committee recognizes that whereby it is difficult to secure lodging for team personnel it can be accommodated within a short distance of Marshalltown with maybe a small inconvenience but not an unsurmountable one. The fact that it is only a two-day tournament at the central site, it does not make it overly difficult for the teams involved. Likewise, the committee recognized that it is not always possible to attain the use of a professional field and there are many disadvantages in the use of the professional park insofar as scheduling, availability, etc. Additionally, it was noted that a central site for the teams was far more advantageous than the concern for the use of a professional field. Additionally, it was noted by the committee that it would be nice to have ground coverage but that it is not a very practical approach to the State Tournament where all the games are completed in a two-day stand and with rainouts—the next playable date. The cost/rental factor, maintenance, etc., were not practical matters when considering ground coverage for the field due to inclement weather. The committee also reviewed the request for consideration by the Associated Press and Des Moines Register and Tribune for the Board of Control and the Iowa Girls Athletic Union to schedule the Girls State Softball and Boys Baseball Tournaments on different weeks during the summer. The committee indicated that if they could be on different weeks that would be the best solution and recommended to the Association to continue to research the matter and if possible find a workable solution, however they do recognize the scheduling difficulty. Likewise, it is not the desire of the Advisory Committee to have the State Tournament any later in August. 2) Squad player limitation: The Board was appreciative of the Advisory Committee's position as it relates to the 18 player limitation rule for tournament activity, their thinking being it is a fair rule. Additionally, the coaches expressed briefly the coaching requirements. The Board of Control, of course, affirmed their position as it relates to the rules and regulations not only of the Association but the Department of Public Instruction that coaches, grades 7 through 12, must have a valid Iowa teacher's certificate and coaching endorsement to be in an instructional capacity. 3) Discuss baseball classification: The committee discussed the possibility of three classes for baseball. It was the general feeling of the committee, after discussion, that additional classification would be considered in the best interest of the overall baseball program. 4) Members were apprised of the committee's review of the possibility of speed up rules for baseball and recommended that two or three conferences, one in the eastern part of the state, one in the west and one in another location be permitted to experiment, should they desire, with a courtesy runner for the pitcher and catcher as feedback to the committee in another year. The Board saw no difficulty with regards to that recommendation and should there be an invitation for same the Board would approve. 5) Summer baseball limitation reviewed/clarified. The committee reviewed the summer baseball limitations rules and clarification as it relates to tournament activity. Other areas of the Baseball Advisory Committee were reviewed and the Board of Control expressed their appreciation for the feedback of the Baseball Coaches Advisory Committee as it affects the baseball program.

**APPROVE JUNIOR VARSITY BASEBALL TOURNAMENTS:** A year ago the Board of Control established a policy not permitting junior varsity baseball tournaments. The primary reason for establishing said policy a year ago was due to the non-school sponsorship and the eligibility status of student athletes involved in the tournaments. The Board reviewed several communications with regards to junior varsity school sponsored tournaments held in the past by the membership and after discussion it was moved by Sand, seconded by O'Connell and adopted, to permit junior varsity baseball tournaments with school sponsorship following the same date and tournament guidelines as varsity competition.

**BASEBALL:** Discussion was held on the current two-class system as well as pros and cons for three- or four-class systems. The Committee recommended to the Board of Control that baseball be put into four classes, the 4-A - the top 64 schools; 3-A - the next 96; 2-A - the next 128, with the 1-A having the remaining schools. Reasons validating this recommendation was to equalize competition at all levels. It would be possible to complete the season one week earlier and it would allow a more equal opportunity for competition.

**STATE BASEBALL TOURNAMENT:** The Board of Control discussed a different possibilities for this year's four-class summer baseball tournament format. The Board returned the Executive Secretary to draw up three or four plans and have them ready to be presented at the next Board meeting. Likewise, to present the proposals to the baseball coaches at their baseball clinic for input with regards to their wishes. Then at the next Board meeting a decision will be made on the format for the summer baseball tournament.

**REVIEW BASEBALL CLASSIFICATIONS AND LIMITATIONS:** Council members were apprised of the fact that the Association has had an appeal for three class baseball and to study merits of same. It was mentioned that the Board of Control has given consideration to the subject. The Coaches Advisory Committee has been consulted relative to further study and research. On a separate printout, Council members reviewed a summary of the winners from 1973 to 1980 in District, Substate and State Baseball Tournaments according to enrollments based on the top 64 enrollments compared to the next 64 in enrollment (top 128 schools). The statistics began in 1973 when the Association went to two-class summer baseball tournaments. Additionally, the survey shows the number in the top sixty-four of

each tournament compared to the field in that particular tournament. It was noted that in 1973, 18 of the 32 District winners were the larger schools, six out of the eight Substates were from large schools; four for four in the State Meet - not one of the bottom sixty-four made it to the State Tournament. Additionally, in eight years six schools out of the bottom sixty-four have made it to the State Tournaments. Qualifiers were noted likewise. In summary, in eight years 49 of the 56 qualifiers for the State Tournament were from the top 64; 7 teams in 8 years have come from the next 64. Enrollments as it relates to classification was discussed as was the comment of equal competition being the basic reason for determining classifications. Items such as the geography and decline of enrollment as it affects classification were likewise discussed. After further discussion/study, Chairman Gannon appointed the following members of the Council as a committee to study classifications for all sport programs. Chairman Leroy Kivett, James Rhode, Larry Parr, and Richard Hennessey. It was then moved by Rhode, seconded by Sapp and adopted, to recommend to the Board of Control to classify summer baseball into three classes effective for the 1981 season. The following items were discussed as they relate to baseball: a) What is the philosophy with regard to the continuance of the fall baseball program? The response was the present philosophy as it relates to fall baseball would continue - meaning that the fall baseball program for non-playing member football schools would be continued much as in the past. b) Professional baseball world series being played on Friday night and its relationship to Friday night as a high school football night traditionally across the country. Discussion followed. c) Limitation rule as it affects summer baseball. Twenty playing dates, definition of tournament regulations, etc., were discussed. d) Report of summer baseball receipts reviewed.

**BASEBALL:** Discussion was held on the current two-class system as well as pros and cons for three- or four-class systems. The Committee recommended to the Board of Control that baseball be put into four classes, the 4-A - the top 64 schools; 3-A - the next 96; 2-A - the next 128, with the 1-A having the remaining schools. Reasons validating this recommendation was to equalize competition at all levels. It would be possible to complete the season one week earlier and it would allow a more equal opportunity for competition.

**REAFFIRM SUMMER BASEBALL GAME/DATE LIMITATION:** Members reviewed and studied the results of the official ballot involving the summer baseball game/date limitation sent out to member baseball schools. Results of the official ballot are as follows:

**OFFICIAL BALLOT - SUMMER BASEBALL GAME/DATE LIMITATION**  
PLAN A: Number of playing dates.

Current Rule: After a team has practiced eight (8) calendar days, excluding Saturdays and Sundays, they may play their first game. Each member school will be permitted to play twenty (20) dates for their baseball program.

A. If a school desires to play in a three-day tournament, it will count as one date.

B. If a school desires to play in lieu of a three-day tournament in two, two-day tournaments, each one of the two-day tournaments will count as one date. Example: School X desires to play in two, two-day tournaments. They would be able to play eighteen (18) dates of competition and each tournament would count as one more date—thus twenty (20) dates.

C. Any time a school plays in a three-day tournament or in two, two-day tournaments, they can play in other tournaments but each date of the tournament played will count as one of their playing dates.

In Plan A you are to vote for the number of playing dates with the above tournament regulations.

240 - Current Rule (20) dates; 39 - 18 dates; 26 - 22 dates; 15 - 24 dates; 1 - 25 dates; 11 - 26 dates; 3 - 28 dates; 14 - 30 dates; 7 - other.

PLAN B: Number of Games

You are voting for a limitation involving the number of games which includes regular season tournaments exclusive of the IHSAA series. Each game played in a tournament counts as a game. A double-header would count as two (2) games. Vote for the number of games you prefer.
