BOB MILLER; DINNER SPEAKER: former major league pitcher, pitching in the Major for five years with the Tigers, Reds and Met organizations. He pitched in 86 games with an E.R.A. of 4.72 in 188.2. inn.. Bob has spent some time representing the American League at many banquets and clinics throughout the country. Excellent teacher of the game and dinner speaker! Bob presently is from Chicago.

GENE OLIVER: Spent 9 years in the Major Leagues, playing for the Cardinals, Braves, Phillies, Red Sox's, and with the Cubs. Gene caught in 376 games and played firstbase in 200 and played 91 in the outfield. He hit 93 homeruns in his 9 year in the bigs. Gene presently is a minor league coach for the Chicago Cubs organization.

BOB RANDALL: attended Kansas State University and signed with the Dodger organization in 1969. Bob spent 6 years with the Dodger's and was traded to the Twins in 1975. He played as a utility infielder for the Twins, retiring from baseball in 1980. Last season he was the Asst. Baseball Coach at Iowa State University.

LARRY CORRIGAN: attended Iowa State University and presently the Head Baseball Coach at Iowa State. Larry signed with the Dodger organization in 1973. He pitched and caught in the minors. He retired from pro baseball in 1979, becoming the assistant baseball coach at Iowa State, taking over in 1980.

JIM DIMICK: Baseball Coach at St. Olaf College, Northfield Minn., will be one of the feature speakers Jim has given many clinics throughout the U.S., this year at the national convention. Jim's over-all record at St. Olaf is 230-140. Jim was the recipient of the Dick Siebert Award in 1978 for contribution to baseball in Minnesota.

SYNOPSIS OF THE MINUTES OF THE MEETING OF THE BASEBALL COACHES ADVISORY COMMITTEE October 15, 1981

The Baseball Coaches Advisory Committee met in the Iowa High School Athletic Association Office Thursday, October 15, 1981, pursuant to notice. Members present were Dennis Olejniczak, Decorah; Jim Van Scoyoc, Norway; and Ed McNeil, Fort Dodge Senior High School. Members unable to attend were William Freese, Davenport, Central; and John Harris, Corning. Mr. Hartly of the Association staff was also present.

The following items were covered: (1) Review 1981-82 rules changes. Members were given a printout of the recent rule changes for the 1981-82 baseball season and also a copy of the National Federation baseball rules questionnaire results. The committee briefly reviewed the changes and discussed at length making some recommendations on the following items affecting the rules of the game: (A) The committee inquired as to the change a year ago mandating metal cleats in 1984. Mr. Hartly indicated that he would correspond with the rules body regarding rationale for same, etc. (B) "Speed-up rules." The committee spent a considerable amount of time on ways of speeding-up games in addition to rules provisions that permit for same currently. Of the items reviewed and discussed, the following determinations were made by the committee for speed-up considerations: (a) Eliminate the huddle at the pitcher's mound between pitches and/or outs in order to move the game along at a normal pace. Little is accomplished with the huddle other than delay of game. Eliminating the huddle would greatly expedite moving the game along and not detract from the game in any way, shape or form. (b) Reviewed the rule permitting the pitcher at the beginning of each inning to "warm-up" by using not more than eight (8) throws to a player or one out unless the umpire authorizes more throws because of an injury or inclement weather. As a guideline the committee feels that five (5) are normally adequate between half innings for warm-ups and that as a strong recommendation this be the guideline that all coaches and umpires follow. However, should there be a request for additional pitches or time, then the umpire with good discretion and judgment permit the necessary eight (8)

pitches or one minute for warm-up and should there be inclement weather or injury is authorized to make additional judgments should he deem it necessary. With the guideline of five (5) pitches it will eliminate a great deal of delay and move the game along without any unnecessary delay. (c) Inform coaches to have the warm-up catcher ready to go between half innings so the pitcher isn't standing out there waiting for the catcher, etc., thus eliminate delay. (d) Get the pitcher's jacket to him immediately if he should get on base. (e) Courtesy runners. The committee reviewed at length the possibility of using courtesy runners for the pitchers and/or catcher as soon as they get on base. Committee members McNeil, Van Scoyoc and Olejniczak have volunteered to review with the teams on their schedules the possibility of experimenting with the courtesy runner for the pitcher and/or catcher for the 1982 summer and fall seasons. After checking with the teams on their schedules the Association Office will be notified as to those teams agreeable to the experiment. The Association Office will approve the experiment for those teams using the following guidelines: (1) Prior to the game, the two coaches will decide whether they are going to use courtesy runners for the pitchers and/or catcher. It must be mutually agreed, if not, the courtesy runners will not be used. If agreed, the following will take place: the team at bat shall use courtesy runners for the pitchers and/or catcher as soon as they get on base. The same runner may not be used for both positions. Neither the pitcher nor the catcher will be required to leave the game under such conditions. (This will not be a substitution.) It is as indicated above - courtesy runners, without any restriction on substitution and/or reentry limitation. (2) Players who have participated in the game in any other capacity are ineligible to serve as courtesy runners. A player used as a courtesy runner for the pitcher and/or catcher can be used as a regular substitute in a later inning or later in a given half inning for a runner or batter; however, he no longer can be used as a courtesy runner once he is inserted as a substitute. Please keep in mind a courtesy runner is an individual who has not been used in any other capacity, offensively or defensively. Once they have been used in another capacity the role of the courtesy runner, much like that of the designated hitter, is terminated. (3) The same courtesy runner used for the pitcher and/or catcher in, let's say the second inning, can be used again in the fourth, fifth, sixth, etc., innings. But once he has been used as a substitute then he no longer can serve in the capacity of courtesy runner. However, any other player who has not been used as a starter or substitute can serve in the capacity of courtesy runner. The committee feels with the above guidelines for the experiment positive direction will be taken in not only speeding up baseball games but affording other players an opportunity to participate.

(2) The committee reviewed the designated hitter and reentry rules and felt that both, particularly the designated hitter rule, should be reemphasized at next year's rules meetings for the benefit of both coaches and umpires.

(3) Reviewed communication with regard to balking situation that seems to have cropped up in northeast Iowa to be clarified at rules meetings next spring. The above matters will all be reviewed at length at the 1982 spring baseball rules meetings.

(4) Review new four-class format for summer baseball. Mr. Hartly reviewed with members the summer baseball season and tournament series noting the new four-class system proved to be a positive direction for the baseball program. The move to the four-class system appears to have added a new dimension giving additional or greater opportunities for youngsters and schools in the tournament series. Members were notified that Marshalltown High School has been selected as the site for the 1982 and 1983 summer state tournaments. The committee recognizes the excellent cooperation with Marshalltown High School in hosting the previous summer's tournament and the efforts made in improvements of an already existing excellent complex. The committee looks forward to further cooperation with Marshalltown as a summer site for the 1982 and 1983 State tournaments.

(5) New Board policy regarding squad limitation in tournament play and Substate format as it affects sites. Members of the Advisory Committee were informed of the two new policies as they relate to summer high school baseball. 18-player squad rule: It was explained that in Association sponsored tournaments a maximum of eighteen (18) players is permissible for each team. This means that not more than eighteen (18) participating players may be in uniform and occupy the players' bench except the bat boy and/or team manager may also be in uniform. It was further explained that a number of violations have occurred exceeding the squad limitation in tournament play with no penalty enforcement for said violation. The new policy adopted by the Board of Control at their September 27, 28, 1981 meeting is as follows: The maximum of eighteen (18) player squad limitation be enforced on any school in violation of same will lose by forfeiture. It was emphasized that said

policy will be covered in baseball rules meetings next spring and in separate communication to the member schools. The Baseball Advisory Committee expressed agreement to the squad limitation rule in previous years and are in full support of the eighteen (18) player squad limitation rule and the enforcement of same. They appreciated the Board's position regarding the policy on the matter and reemphasized the importance of informing all member schools, etc.

Substate Tournament Games: Members were informed the new policy with regards to summer high school baseball sites as it relates to Substate tournament games is as follows: (a) For the 1982 Substate tournament games, the host school will be the school listed first in alphabetical order; however, if the distance is greater than 100 miles, the IHSAA will select a site in an effort to lessen the burden of excessive travel. The same philosophy will be followed for District tournament games where sites to be determined exist. (b) Substate tournaments involving more than one game: some Substate tournaments involve a two-game series and if one of the two teams in the final game traveled for their first-round game and the other school was at home, the team that traveled will automatically become the home school for the final game. If both teams were home for the first-round game, then the team first alphabetically will serve as the home school. If both teams were visitors for their first-round game, then the first alphabetical team will automatically be the home team. (c) When two (2) schools in the same metropolitan area play a first-round game, they will have to travel for their second-round game if their opponent for the second-round game had to travel for their first-round game. Metropolitan areas will be considered as follows:

For an example, if Cedar Falls and Waterloo, Central played a first-round game in Waterloo and their next opponent would be Marshalltown who had to travel and won their first-round game, the winner of the Cedar Falls-Waterloo, Central game would travel to Marshalltown for their next game. Members were appreciative of knowing said policy as it relates to Substate tournament games and Districts and are in support of same, recognizing the fairness involved.

SUMMER BASEBALL PROGRAM REVIEW: Assistant Executive Secretary, David Harty, reviewed with members of the Board the summer high school baseball tournament program. The following items were reviewed: a) The summer season was a successful season, noting that rules inquiries into the office were at a minimum, however it was noted there were more coach ejections than in the previous two years. b) The new tournament format, 1-A, 2-A, 3-A and 4-A was very successful, noting a number of rain dates were necessary at the lower level tournaments for all classes. The elimination of consolation play at the State Tournament and the new format of 1-A, 2-A, 3-A and 4-A played a significant part in a very successful summer tournament series. c) District and substate sites to be determined. It was reported in a few cases a greater amount of distance was traveled than necessary and the staff desires to recommend that the Board consider a new policy when the distance is in excess of 100 miles, the Association determine the site between the two competing teams. In addition, when there are two substate games to play in a given class, adopt a policy similar to football play-offs whereas if one team is host and their second opponent traveled on their first game, they then would be the host on the second substate game so no given school would have to travel on both occasions. The two above considerations will be submitted to the Board for consideration at one of the next regular scheduled meetings. d) The attendance at the State Tournament was up considerably over any previous year. Actual figures have not yet been finalized, however it appears it will be a record attendance at this year's State Summer Tournament, largely due to the schools involved and closer proximity to the central site of Marshalltown for some. e) The Association reported the appreciation of the great coverage the media afforded the youth and schools during this summer's high school championships. Moving baseball and softball off the same week created a better situation for the media in reporting, for which the Association and its member schools are most appreciative. f) Mr. Harty reported that Marshalltown has improved their facilities greatly over previous years with cyclone fence completely enclosing the field with near book rule coverage as far as rules are concerned. The parking, seating, etc., are all adequate. Marshalltown has advised the Association of its continued improvements with the facility likewise. A more thorough report of the attendance figures will be given the Board when all reports are received and compiled by the bookkeeping department. Members will review the site for the following year's State Baseball Tournament at one of its next regular scheduled meetings.

FALL BASEBALL POLICY: The Board on prior occasions has discussed the merits of continuing the fall baseball season, the number of schools participating, etc. It was explained that the fall baseball program has been a program for the nonplaying football schools in that it did offer a program for those schools who do not offer football as a program to their students. On one or two previous occasions a football playing school participated in the program; however, since that time until this fall it has not been necessary for a written policy regarding the above matter. This fall, Kee High School, Lansing, in their initial year of football desired to continue in the fall baseball program which was permitted. Recognizing the concern for a policy and after discussion, it was moved by Rowedder, seconded by Runyan and adopted, to establish the written policy stating that only nonplaying member football schools be permitted to participate in the fall baseball program effective beginning with the 1982-83 school year.

SUMMER BASEBALL REPORT AND ADOPTION OF BOARD POLICIES REGARDING SQUAD LIMITATION IN TOURNAMENT PLAY AND SUBSTATE FORMAT AS IT AFFECTS SITES: Members reviewed the success of the new four class format for summer baseball, the attendance at sectional, district, substate and state tournament levels, and took action as it affects summer baseball regulations in the following three areas: a) It was explained that in an Association-sponsored tournament a maximum of 18 players is permissible for each team. This means that not more than 18 participating players may be in uniform and occupy the players' bench except the bat boy and/or team manager may also be in uniform. It was further explained that a number of violations have occurred exceeding the squad limitations in tournament play with no penalty enforcement for said violation. After discussion, it was moved by Runyan, seconded by Rowedder and adopted, that the maximum of 18 player squad limitation be enforced and any school in violation of same will lose by forfeiture. It was emphasized that said policy be covered in baseball rules meetings next spring and in separate communications to the member schools. b) Adopt policy for summer high school baseball tournament sites as it relates to substate tournament games. It was moved by O'Connell, seconded by Sweet and adopted, to approve the following policy: Substate tournament games: (a) For the 1982 Substate tournament games, the host school will be the school listed first in alphabetical order; however, if the distance is greater than 100 miles the IHSAA will select a site in an effort to lessen the burden of excessive travel. The same philosophy will be followed for District tournament games where sites to be determined exist. (b) Substate tournaments involving more than one game: Some Substate tournaments involve a two-game series and if one of the two teams in the final game traveled for their first-round game and the other school was at home, the team that traveled will automatically become the home school for the final game. If both teams were home for the first-round game, then the team first alphabetically will serve as the home school. If both schools happened to be visitors for their first-round game, then the first alphabetical team will automatically be the home team. (c) When two (2) schools in the same metropolitan area play a first-round game, they will have to travel for their second-round game if their opponent for the second-round game had to travel for their first-round game. Metropolitan areas will be considered as follows:

For an example, if Cedar Falls and Waterloo, Central played a first-round game in Waterloo and their next opponent would be Marshalltown who had to travel and won their first-round game, the winner of the Cedar Falls-Waterloo, Central game would travel to Marshalltown for their next game.

Members expressed their appreciation for the fine job many host managers do in putting together tournament programs for the Sectional, District and Substate level tournaments. Samples of some were reviewed by the Board.

APPROVE MARSHALLTOWN AS STATE SUMMER TOURNAMENT SITE FOR THE 1982 AND 1983 SUMMER STATE BASEBALL TOURNAMENT: Members reviewed the State tournament site of Marshalltown in regard to improvement in facilities, management, location, etc. At the conclusion of the discussion, it was moved by Rowedder, seconded by Sand and adopted, that Marshalltown be the site for the 1982 and 1983 State Summer High School Baseball Championship and directed the Executive Secretary to negotiate the terms with Athletic Director George Funk.

REVIEW BASEBALL COACHES ADVISORY COMMITTEE MINUTES: Members had an opportunity to review the Baseball Coaches Advisory Committee minutes of October 15, 1981. After discussion, it was moved by Parkin, seconded by Sand and adopted, that the following "speed-up" rules go into effect for the 1981-82 summer and fall baseball programs: 1) Eliminate the huddle at the pitcher's mound between pitches and/or outs in order to move the game along at a normal pace. 2) As a guideline, five (5) throws are adequate between half innings for warm-ups; however, should there be a request for additional pitches or time, then the umpire would use good discretion and judgment and permit the necessary eight (8) pitches or one (1) minute for warm-up as per rule. Should there be inclement weather or injury the umpire is authorized to make additional judgments should he deem necessary. 3) Inform coaches to have the warm-up catcher ready to go between half innings so the pitcher isn't standing out there waiting for the catcher, etc., thus eliminate delay. Get the pitcher's jacket to him immediately if he should get on base. 4) Courtesy runners. Approve experimentation with courtesy runners for the pitchers and/or catcher as soon as they get on base. Specifics regarding same will be found within the content of the Coaches Advisory Committee minutes found in the December, 1981 bulletin. Members reviewed at length the recommendation of the Advisory Committee's request for a change in the following baseball program regulations: a) starting date; b) first contest date; c) number of playing dates and the rationale for same. The Board also received copies of a proposal from the Big 8 Conference as it affects the first playing date from conference representative Jack Steinberg, Athletic Director at Mason City, and in turn reviewed the official ballot sent to the membership regarding summer baseball games date limitation which was compiled in the membership of 1980. The Board acknowledged receipt of the Advisory Committee's recommendations, having discussed them at length; however, feel that the baseball regulations as they affect the above matter will be better tested and reviewed at the completion of a two-year period and at the end of that period determine the advantages and disadvantages of those limitations and at that time poll the membership as to the future direction for any modifications or changes as per the Advisory Committee's recommendations. The Board is appreciative of the input from the Advisory Committee; however feels that a two-year period on the existing rules and regulations is necessary prior to the complete reevaluation of same. The 1981-82 school year will mark the second year of the current regulations.

***** Cont.

(6) Review junior varsity/varsity game limitation as it affects player personnel. The following summer baseball program regulations regarding starting of practice, number of games and tournament regulations were reviewed. They are as follows: (1) Starting of practice: (a) Pitchers and catchers-May 1. (b) All other players May 18, 1981. (c) Schools must practice 8 days before their first game. Saturdays and Sundays do not count as practice days. The first possible game date is May 28, 1981. (2) Number of games you can play. (a) 20 dates will be the number of dates a school is permitted to play. If a school plays 2 games in one day, it counts only as one date.

Tournament Regulations: (a) If a school wants to play in a three-day baseball tournament, it counts as one of their dates; or (b) A school may elect to play in only one two-day tournament and it will count as one date; or (c) A school may elect to play in two, two-day tournaments and it will count as two dates; or (d) A school may want to play in more tournament competition than listed above. If so, each day the school plays in a tournament counts as a date. The junior varsity has the same rules and regulations as listed above.

(7) Discussion and recommendations regarding starting dates, game limitations, etc. The Advisory Committee discussed at length starting dates for practice, games and number of contests, and reviewed correspondence from the Big 8 Conference regarding a proposal. The following recommendations and considerations were made by the committee for Board of Control consideration. It is the desire of the Advisory Committee to in no way serve as a pressure group but would appreciate very much the Board of Control's review and consideration of the following matters. As representatives of the baseball coaches, the committee recommends consideration of the following: (a) A May 1 starting date for all players. (b) First contest date at the conclusion of District track. (c) 25 dates rather than the current 20. Rationale for above recommendations is as follows: (1) Greater exposure to the entire student body prior to school dismissal for the summer months and allow for more preseason practice time with the entire squad. (2) The above recommendations make it more feasible to schedule non-conference games, a difficulty many of the schools appear to have as a result of the new regulations. (3) It is the thinking of the committee that the above regulations would aid in eliminating the "cheaters" and other problems associated with the current regulation of pitchers and catchers only starting May 1. (4) The Committee does not feel it would create a great problem with the track program. (5) The above recommendations would aid greatly in discouraging a move that is increasing at the current time - "More Legion and nonschool programs."

In summary, the committee will be most appreciative of the Board of Control's review and consideration of the above recommendations and make same, recognizing all the benefit of approval for many of the past considerations afforded the baseball program by Board of Control decisions.

A number of ideas to hold clinic cost in line were presented.

A suggested idea that the Treasurer or Vice-President should serve as chairman of the membership committee.

Recommended appointment of an ad hoc committee to investigate the possibility of a Vince Meyer Memorial.

Suggested the Association could improve its financial situation by investments in the money market.

Hall of Fame Committee Chairman Jim Jagim reported that his committee is in need of nominations. Suggested that the Hall itself should propose 2 nominees a year.

Membership Committee: Jim Kloewer volunteered to work on the membership rolls.

All State Rating Poll Committee: Accuracy of the poll was applauded. Need for all coaches to report game scores--win or lose.

radio, TV, Coaches, Booster Clubs, even the players themselves. Called for recognition of coaches who really work at obtaining sponsors. Asked for criteria in selection of All-Star coaches. Challenged the I.H.S.B.C.A. to be innovative in selection and presentation.

Umpire Committee: Will meet as a group in December. Would like an Umpire of the Year selected and honored. They will work out their portion of the clinic. Suggest that coaches get "their" umpires to the clinic.

Steering Committee: Will recommend criteria for All-Star coaches.

Clinic Report: "Teaching" baseball should be the focus of the clinic. The need for a "name" cannot be overlooked--but it might be well to look to good college coaches for the bulk of the message.

Communications: Requested by Stanwood-Lincoln to move from the Southeast District to the Northeast District; Carlyle and Norwalk to move from the Southwest District to the Central District; Clarence Lowden to move from the Southeast District to the Northeast District. Ray Antisdell moved that the District changes be approved. Seconded by Jim Scholten. Carried.

New Business: Jim Ellwanger named to chair an ad hoc committee to initiate a Vince Meyer Memorial.

I.H.S.B.C.A. to pay for 1 box lunch and the ticket to the I.S.U. football game. Motion for approval by Jim Scholten. Seconded by Bob Sapp. Carried.

Increase membership dues for the 1982-83 year from the present \$10.00 to \$15.00 with provision for free admission to the All-Star games and the All-Star Clinic. Motion to approve above was made by Pinky Primrose, Seconded by Al Seabrooke, Carried.

Mr. Don Nau of Cedar Rapids invited to handle surplus funds to increase the financial return for the I.H.S.B.C.A.. Motion to approve by Vern Bredeson, seconded by Terry Heald, Carried.


Al Seabrooke moved that the Vice-President should act as the chairman of the membership committee. Seconded by Jim Mahoney. Carried.

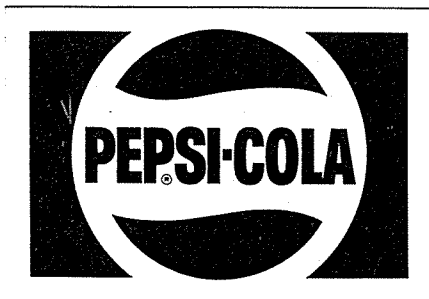
