GENE OLIVER RETURNS: By popular reguest Gene will be back with us. He spent 9 years in the major leagues, playing for the Cardinals, Braves, Phillies Red Sox's and with the Cubs. Collgiate team that toured the world and played in the World Amateur Baseball Games in Korea. He also coach

BOB SYMONDS--TRITON COLLEGE: Bob has established a diamond dynasty at Triton College in River Grove, II. In 12 years at Triton, Symonds has taken the Trojans to 10 straight conference championships, five state titles and three trips to the NJCAA World Series in the last 4 years. During that time he has compiled a record of 380-136, averaging over 31 wins a year. His conference has honored him six times as the Coach of the Year and Triton has only been in the N4C for seven years.

Symonds' has the pro's coming every year, 25 of his players have been drafted and 55 of his players have gone on to four year schools. He's developed nine All-Americans, including two on his 1982 squad that went 57-12 and finished fifth in the JUCO World Series. Bob was raised on a farm in Iowa, and went

to College at Wayne State.

DAVE HUCKELBERRY: Baseball Coach at Muscatine Community College, has been coaching for 17 years. Dave was a graduate of Westmar college in LeMars. He has been coaching football, basketball and baseball over the past 17 years. Dave started his coaching career at Shelby, Iowa then moved to Victor Valley, California and returned to Muscatine in 1977. At Muscatine he has been very successful winning almost 70% of his games.

## SYNOPSIS OF THE MINUTES OF THE MEETING OF THE BASEBALL COACHES ADVISORY COMMITTEE September 28, 1982 The Baseball Coaches Advisory Committee met in the lowe High School Athletic Associ-

ation Office Tuesday, September 28, 1982, pursuant to notice. Members present were: Ed McNeil, Fort Dodge High School; Dennis Olejniczak, Decorah High School; William Freese, Devenport, Central High School; Jim Van Scoyoc, Norway High School; Marvin Thelen, Remsen, St. Mary's High School; and David Jauron, Essex High School. The following items

1) Discussion and recommendation regarding starting dates, game limitations, etc.: The 1) Discussion and recommendation regarding starting dates, game limitations, etc.:The Advisory Committee discussed at length the starting date for practice, games and number of contests. The following recommendations were made by the committee for the Board of Control's consideration, a) May 1 starting date for all players; b) First contest date at the conclusion of District Track; c) 25 dates rather than the current 20 (the request for additional 5 playing dates was to allow for rain dates and the opportunity for additional players to participate and not to exceed a total of 40 games.) Primary rationale for the above recommendation is as follows: 1) Greater exposure to the entire student body prior to student dismissal for the summer months and to allow more pre-season practice time with entire squad, 2) The above recommendations make it more feasible to schedule non-iference games, a difficulty many of the schools appear to have as a result of the current

ference games, a difficulty many of the schools appear to have as a result of the current place.

Julation. 3) It is the thinking of the committee that the above regulation would aid in iminating the "chesters" and other problems associated with the current regulation of pitchers and catchers starting May 1, 4) The committee does not feel that it would create a great problem with regards to the track program. 5) The above recommendation would aid greatly in discouraging a move that is increasing at the current time-more Legion and non-school programs.

2) It is the consensus of the committee that a great deal more time is being taken than is necessary when taking infield prior to a ball game by a lot of high school teams. Customarily a 10-minute infield is felt to be very adequate; however, it was noted that it is becoming more prevalent for a given team(s) to take infield with two and three players per position. Taking the time to make the necessary throws to each base, etc., by all player personnel, making a travesty of the game when taking "infield." It is the desire of the group the practice not be tolerated and to be emphasized at the baseball rules meetings in the spring and in turn at the Baseball Coaches Clinic(s).

3) The committee reviewed the use of courtesy runners for the pitcher and catcher as per experimentation by the member conference schools of which committee member Dennis Olejniczak, Decorah, is a member. He reported reasonable success with the experimentation and the coaches got along with it real fine. It gave additional players an opportunity to participate. The experimentation incorporated a small deviation from the national rules coverage as it permits courtesy runners for the pitchers and catchers. The conference experi-ment involved the use of the courtesy runner as an option; whereas, national rules provide for mandatory use of the courtesy runners for the pitcher and catcher when they reach base. Discussion followed with the consensus of the committee not favoring adopting courtesy runners as per the rule book coverage primarily due to the requirement of mandatory use of courtesy runners when the pitcher or catcher reach base. The national rule is only by state

association adoption, lowe had not adopted the provision.

4) Fall baseball program, Mr. Harty reviewed the status of the fall baseball program to date, the number of schools participating, number of regular season contests played per school and the effect of the cooperative sharing programs on the fall baseball program likewise. Considerable amount of discussion followed and it was the consensus of the committee that the Association continue with the current fall baseball program sponsoring the state series of tournements and if absolutely necessary, to do any refinement or curtailment but permit the schools currently playing fall baseball to continue playing even though perhaps the state series of tournaments would not be sponsored. The committee recognized the problem surfacing with regards to fall basebell and the cooperative sharing programs but are in hopes the Association will continue the same direction as has been in the past with regards to fall baseball unless placed in a position of where a change or a modification is

5. Line-up cards; Committee member Freese submitted a sample line-up card which was well received by the committee members as a possible modification to the one currently used, permitting greater flexibility in the use of substitutes and aiding the umpire in making his necessary recordings, etc. The consensus of the group was favorable toward the card and Mr. Harty indicated that more study will be given to the card and the possibility of using an

adeptation of same or the identical card when the current supply is exhausted.

6. Review basketbell summer leagues, football passing leagues and other nonschool team participation in the summer months as it affects baseball. In short, "a conflict of interest" in nonschool programs as it affects the summer high school baseball program. The committee

reviewed the recent changes affecting the summer camp regulations and the new rewrite of the "Coaching Rule" as it affects all sports programs.

7) Brief review of the rule change mandating elimination of metal cleats beginning in 1984. Mr. Harty reviewed rationale on behalf of the national rules body for making the change, disseminating copies of that rationale to each committee member and likewise exhibiting a pair of baseball shoes carrying the same characteristics and/or similarities of the metal cleats, however not made of metal but hard nylon.

8) Mr. Harty reviewed briefly with the committee the Kee High, Lansing irregularities as It affects the baseball regulations.

9) Members reviewed the possibility of portions of innings to be played by players and not counting as a full game and/or date in order to make a more flexible schedule for player personnel. The committee was not certain as to how a rule or regulation could be written so as not to cause a great record keeping procedure and/or undue policing and/or penalizing of schools. The committee members are going to research the item in their own thinking and if possible come up with a suggestive idea or ideas as to how a regulation and/or a rule can be written clearly enough to make possible a limitation with regard to number of innings played as it relates to contests, dates and/or game limitation rule.

10) The committee summarized the meeting with a brief review of tournament sites, umpire selections, school recommendation cards for recommending officials desirous of being considered for tournament activity.

In summery, the committee is most appreciative of the Board of Control's review and consideration of the above recommendations and recognizes all the benefits for many of the past considerations afforded the baseball program by the Board of Control's decisions.

FALL BASEBALL REPORT: Members were apprised of the number of fall baseball schools participating to date, number of games played this fall by the 44 schools that are participating. Members were also given a printout of schools playing in Sectional tournament series from the year 1944 to the current date in spring, summer and fall baseball for study and review as it pertains to the baseball program. After review of the fall program, the Board directed the staff to place the matter as it pertains to the future of fall baseball on the next Representative Council agenda for discussion.

REVIEW KEE HIGH, LANSING BASEBALL PROGRAM WITH SCHOOL ADMINISTRATION: Eastern Allamakee School District's Superintendent Marvin Hyde and Principal Terry Stevens were present to review the Lansing, Kee High baseball program of this past summer, 1982, and violations. The Board had a very thorough review relative to the Kee High beseball program at their July 26, 1982 meeting. Discussion evolved around the alleged violations. Legal Counsel Courter reviewed the court action and proceedings regarding the above matter. As a summation the administration: (1) assured Board of Control members that they have a clear understanding and knowledge of the rules and strict adherence to same will be followed with enforcement. (2) Principal Stevens understands and is very clear as to any future action regarding rules and regulations as it affects the summer baseball program. Inquiry was made as to the coach's status as it affects the probationary period, noting that it is the assumption on behalf of some that the IHSAA placed Coach period, noting that it is the assumption on behalf of some that the IHSAA placed Coach Schultz on probation whereas it was in agreement between Legal Counsels of both parties that the coach would be placed on probation by his school. After further discussion, it was moved by O'Connell, seconded by Schmidt and adopted to table any action regarding Eastern Allamakee Community School District pending further information from Kee High regarding action of the local Board of Education. (For detailed information regarding Lansing, Kee High summer baseball violation, please refer to the July 26, 1982 Board of Control minutes found in your November, 1982 bulletin.)

REPORT ON 1982 SUMMER BASEBALL PROGRAM AND TOURNAMENT SERIES: It was explained to the members that the summer program and early rounds of the tournament series experienced many rain-outs, thus postponements, but in general a very successful program. Members were given a preliminary printout with regards to the ticket sales at the Sectional, District, Substate and State level tournaments, noting that there are three tournament reports outstanding, thus the final report will be determined upon receipt of those tournament reports. A final report will be made at a later date to be included in bulletin copy. Members were also informed of the lawsuit filed resulting from a personal injury to a fan when falling in the restroom at the State Summer Baseball Tournament. The Board instructed the Secretary to place the claim in the hands of Legal Counsel for followREVIEW FALL BASEBALL AS IT RELATES TO COOPERATIVE SHARING CONCEPT: The Board of Control affirmed their previous policy (June 27, 1982 Board minutes) as it affects the cooperative eligibility rule as adopted by the State Board of Public Instruction and licensing procedure for activities organizations to permit limited number of schools cooperative activities for the school year 1982-83. Members reviewed the following policy as it relates to fall baseball when combining with another school for football purposes. A fall baseball school combining with another school for football purposes is permitted to finish its initial year (1982) in the fall baseball program due to scheduling reasons; however, scheduling fall baseball programs in the following years would not be permitted fall baseball when they currently have a football program. It was pointed out that fall baseball, by policy, is for the nonplaying football schools and that it does provide a program for the young people in those schools. The addition of football then would replace that program if a fall baseball school desires combining with another school for the purposes of football. A letter of clarification was sent to member schools, All member schools have previously received copies of the letter clarifying the status of the licensing process for "pilot programs for the 1982-83 school year." Continued sponsorship of the fall State Baseball Tournament series was discussed at length with no action in the June 27, 1982 Board meeting. At this time the Board had the opportunity to review the above policy with Superintendent Al Huisman, Goldfield and Superintendent Byron Hofmeister, Clarion. Goldfield's Board of Education/Administration inquiry was asking the Board of Control to consider permitting the continuance of fall baseball schools to play fall baseball. Superintendent Hofmeister, Clarion, supersed a concern for the schools who desire a complete sharing program with Clarion students being permitted to go to Goldfield for fall baseball. Discussion follo

ESTABLISH POLICY FOR LATE ENTRANTS IN SUMMER BASEBALL TOURNAMENT PROGRAM: Members were informed that a few summer baseball tournament late
entries arrive after the pairings and sites have been determined and the necessity of establishing a policy for the late entrants in the pairings. It was noted there was not a great number
of late entrants but a policy needs to be established as to the placement of the given team(s)
in the pairing system once they are established. Summer programs are somewhat different
than other sport programs in that a school is not always confident they will have a summer
program prior to school dismissal for the summer months and in a few cases that decision is
determined only at the last moment prior to summer recess. It was moved by Runyan,
seconded by Schmidt and adopted, that the administrative staff be permitted discretion in
the placement of late entrants in the pairings. This procedure would be in accordance with

YOUTH BASEBALL TALENT SEARCH UNDERWAY: An extensive search is now underway for the best 18 year old baseball players in the nation born between January 1-December 31, 1965. The National Federation Interscholastic Coaches Association, in cooperation with the United States Baseball Federation, the national governing body for amateur baseball in the United States, is coordinating the selection system by which top baseball prospects in each state can be identified.

Many of these selected players will be afforded the opportunity to participate in Olympic developmental programs this summer, such as the USOC's National Sports Festival V, to be held in Colorado Springs, Colorado, and the World Friendship Baseball Series II, which will be hosted by John stown, Pennsylvania. Ultimately, some players could be selected to the United States Olympic Baseball Team, which will compete against the world's best amateur baseball teams in the 1984 Olympic Games at Dodger Stadium in Los Angeles, California.

A Player Profile Form (a form used to gather biographical information and player statistics, as well as the results of objective skill tests) will be sent to virtually every high school, junior college, college and university baseball coach in the country. Furthermore, various youth baseball agencies such as Pony, American Legion, American Amateur Baseball Congress and Babe Ruth will be distributing the forms to their coaches. In order for a prospect to be eligible for consideration, a Player Profile Form must be submitted on his behalf to the appropriate state coordinator by April 1, 1983.


All of the examples can be given points. The team with the most points will play for 1st place game. The team with the second highest points will also play for 1st place game.



CEDAR RAPIDS----Five new names, including three coaches, an umpire and a player, will be inducted into the Hall of Fame of the Iowa High School Baseball Coaches Association at its annual clinic banquet Friday, March 11.

The inductees, to be honored at Cedar Rapids Washington High School cafeteria, are coaches Jim Ellwanger of Sioux City, Jarold Lister of North Tama of Traer, Dennis Olejniczak of Decorah; umpire Bob Vrbicek of Cedar Rapids and player Denis Menke of Bancroft.

The five inductees bring to 82 the number of Hall of Fame members. The honor roll includes 54 coaches, 11 players, 12 umpires and five contributors.

JIM ELLWANGER has been a baseball fixture as a successful coach in Northwest Iowa since 1964. He led a Babe Ruth All-Star team to the runner-up spot in the 1965 state tournament and has been climbing the success ladder ever since. From his start as prep coach at Newell-Providence, he moved to Granville to lead Spalding to the fall state title in 1971. In addition, he guided the Granville Legion team to the 1968 state meet. His record at Spalding (58-15) earned him the Northwest Iowa Coach of the Year Award. Following his stint at Granville he moved to Fort Dodge, where from 1972-77 he led the St. Edmond Gaels to a 114-46 mark and fourth place in the 1977 Class AA state tournament. He was honored as both Central District and Class AA Coach of the Year in 1977. A graduate of Buena Vista College in 1966, Ellwanger spent one year as a graduate assistant at the University of Iowa before taking the head coaching job at Briar Cliff College in Sioux City. He owns a 71-74 record there, where he is presently athletic director. Credited with starting the Briar Cliff baseball program, he was named NAIA District 15 Coach of the Year in 1981. Has coached five players who have signed or were drafted by professional baseball, and continues to host youth clinics and camps in northwest Iowa and northeast Nebraska.

JAROLD LISTER has won over 500 games as a high school coach since 1951. A graduate of Promise City High School in 1945, Lister has coached at two Warren County Schools-Beech Consolidated and Milo Independent-where he led those teams to a total of three sectional, two conference championships and two runners-up. In 1962 he moved to North Tama of Traer where he expanded a seven-game schedule in 1963 to 49 games in 1971. Established baseball as a major sport from standpoint of interest at North Tama, helping 21 players move on to college baseball. From 1963-1981, North Tama won 72 percent of its games in the North Iowa Cedar Conference. Lister has led the Redhawks to six league titles, including a 36-game conference winning streak from 1964-67. From 1964-66, his teams were unbeaten in league play. The Redhawks, under his guidance, won six sectional and two district championships, qualified for the sub-state meet in 1965, losing to eventual champion Boone, and in 1971 advanced to the state tournament before losing to eventual champion Davenport Central. Lister is a 1951 graduate of Druke.

DENNIS OLEJNICZAK can best be described as "Mr. Baseball" in Decorah. From 1963 to the present, he owns  $\overline{a}$  554-176 record and eight sectional, 10 district, two sub-state, three state runner-up and one champion-ship finish in the state tournament. His 1970 Vikings team captured the summer championship; while his clubs in 1968,1970 and 1972 were runners-up in the spring state meet. Since the Northeast Iowa Conference was organized in 1967, Olejniczak has led Decorah to either the championship or co-championship 12 out of the 16 years. The other four years the Vikings were runner-up. He pioneered the Town Team baseball program in Decorah, which is one of the most successful amateur organizations in Iowa. His town team used almost exclusively Viking alumni. He is a charter member of the I.H.S.B.C.A., has twice been named district coach of the year and once as Iowa Coach of the Year. A graduate of Tripoli High School and Iowa State Teachers College where he was a three-year letterman.

BOB VRBICEK is one of the most respected officials in Iowa collegiate and prep baseball. A graduate of the University of Northern Iowa in 1951, he has been a tireless owrker in all levels state baseball programs. Named the Umpire of the Year in 1980 by the I.H.S.B.C.A., he begins his 31st season behind the plate this year. This season also marks his 25th year as a college umpire, working Big Ten, Big Eight Iowa Conference, Midwest Conference and junior college games. Vrbicek has led state rules meetings since 1976, and umpired the state tournament series 11 years. A graduate of Wilson High School in Cedar Rapids, he played center field on the 1947 state summer championship team. He was a three year letter-winner at UNI, and later played two years in the Iowa State semi-pro league in Fonda. He began his umpiring career in 1953 as a part-timer in the Sconer State Professional Class D League at Fort Sill, Okla. After serving his term in the service, he was head baseball coach at Wilson in 1955, and remained there as junior high school coach when Jefferson and Washington High opened. He is a member of the 200-win club of the IHSBCA, past president of the Cedar Rapids Kid League, past president of the C.R. Officials Assc., and currently coordinator and assistant general manager of the Iowa Shrine Football Game.

DENIS MENKE is one of the most highly successful players to have graduated from an Iowa high school. A product of the renowned prep program at St. John's of Bancroft, Menke signed a professional contract in 1958 with the Milwaukee Braves and cracked into the major leagues in 1962. Since then, he has tasted the best the game has to offer, including playing in the 1972 World Series while with the Cincinnation Reds. Until his retiring from the game as a player in 1974, he played with the Braves, Houston Astrosand Reds organizations. In 1970 as a shortstop for Houston, he tied a major league record for double play assists in a game (5), and most intentional walks (3). He batted .304 that year, including driving in 92 runs, hitting 13 home runs. In 1977, Menke managed Class A Burlington of the Midwest League to the league's playoff championship; and from 1978-79 managed in the Florida State League. He has been first base coach for Toronto (1980-81), hitting instructor for Houston's minor leagues in 1982 and presently is major league hitting instructor for the Astros. A lifetime member of the National Assc. of Professional Baseball, Menke is also a former Cedar Rapids Reds player from 1958-59. In addition to his World Series experience, he has also enjoyed being a member of the National League All-Stars in 1969 and 1970.
