The Fifteenth Annual All Star Games will be held in Iowa City, Aug. 9-10-11, 1991. Any coach who feels he has a player or two who should be playing in the All Star Games should fill out the Player Recommendation sheet that is enclosed in this Newsletter. Please enclose a photo of your player (if available) on the recommendation sheet. The guidelines for the All Star selection can be found on this sheet. All the advance information we can get on the best ball players in the state would help in the selection of the best All Stars.

The Board of Directors passed a policy that any player or coach selected to participate in the All Star Series must have a minimum of \$ 100.00 of sponsors' fees. More would help to defray the cost of the All Star Series. It will be the high school coach's responsibility to get the player's sponsors if he wishes him to play in the All Star games. This policy is necessary in order to offset the high

cost of putting on the All Star series. If you have any questions about this policy, contact any officer or director in your area; they will explain it to you. Sponsor names and fees must be paid to Executive Secretary no later than Monday, August 5, if your player is selected.

1/Players will come in Thursday, August 8th. Individual pictures for inclusion in the program will be taken after check in.

2/Small Schools East will report by 12:00 p.m. Large Schools East will report at 12:15 p.m.

3/Players from Large Schools West will report at 12:30 p.m. and players from Small Schools West will report at 12:45 p.m.

4/Practice for all teams will start at 2:00 p.m..

Practice sites: Large East--City High Diamond; Large West--West High diamond; Small School East--West Branch High and Small School West--Regina High School.

5/Team meetings will also be held Thursday evening.

6/Practice (if desired) for East Schools Friday morning will be 9:00 a.m.. and West Schools will practice at 9:30 a.m..

7/First 7 inning game will be at 12:30 p.m. Friday, Iowa University diamond, Small Schools East vs. Large schools East, followed by Large Schools West vs. Small Schools West.

8/At 7:15 p.m. Friday, Honors Banquet will be held at the Westfield Motel.

9/Saturday morning session will begin at 10:00 a.m.. Small Schools West vs. Small Schools East followed by Large Schools East vs. Large Schools West

10/ Saturday afternoon games will begin at 2:30 p.m. Small Schools West vs. Small Schools East followed by Large Schools East vs. Large Schools West

11/ Meals will be served at the Motel and Church services will be provided at Hotel.

12/ Sunday at 12:00 p.m. the two teams with poorest records will play for 3rd and 4th place.

13/ The two teams with best records will play for 1st and 2nd place following the first game

14/ M.V.P. players will be announced after each game on Sunday.

WHAT ARE SOME OF THE RULES:

- 1/ All players chosen must play.
- 2/ The pitchers can pitch a full game.
- 3/ All games will be 7 innings in length unless extra innings are necessary.
- 4/ Tie breaker system will be announced in advance for who will play for 1st and 2nd place. Example: Head to Head competition, most runs scored, least runs given up, most hits, least hits given up.

All of the examples can be given points. The two teams with the most points will play for 1st place.

This system will give more boys an opportunity to play and show what they can do. We will not restrict a pitcher on amount of innings he can pitch in one day.

Coaches were picked by the Steering committee! They filled out an application that was found in the last newsletter.

*****Players who do not make the All District Team will still be eligible to play in the All Star Series. ****

If a coach fills out a player profile form that is found in this newsletter and sends it in, this player will have the same opportunity as a player on the All District Team. This system was necessary because of a number of good ball players being left off the All Star Squads, because a coach could not get enough votes for his player at the All District Selection meeting.

ALL STAR SQUAD REGULATIONS:

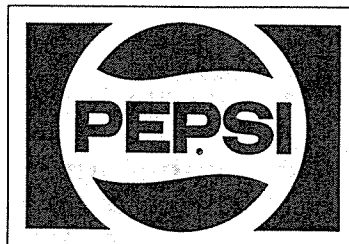
Each squad will consist of 16 players (2 catchers, 5 pitchers, 5 infielders and 4 outfielders).

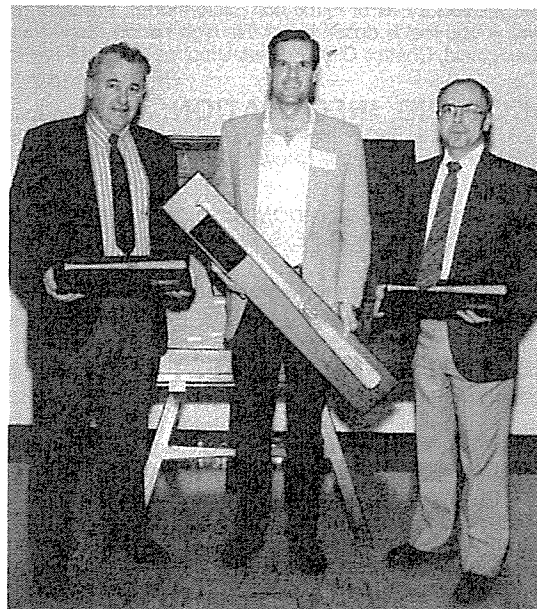

IOWA HIGH SCHOOL BASEBALL COACHES ASSOCIATION

MARCH 14, 1991

The Spring 1991 Iowa High School Baseball Coaches Association Meeting of March 13 was called to order by President John Zahn.

I. Introductions of all present and a welcome by Executive Secretary Pinky Primrose.

II. Motion to approve minutes of November 17, 1990--moved by Craig Collison and second by Jack Leabo. Approved.

III. Financial Report--Jim Brems; Total cash on hand as of March 11, 1991 \$ 15,375.53 Moved by Don Taylor and seconded by Dick Core that the financial report be accepted. Approved.

IV. Steering Committee--Andy McGaffin

1. Discussed possible candidates for selection from the Northwest District to become association officer.

2. Reviewed All-Star coach selections and will contact these people.

3. Talked about the 1993 All-Star site. Council Bluffs would like to host series at Rosenblatt Stadium. committee recommends this site for 1993.

4. Reviewed dues of association and rising costs.

B. Executive Secretary Report (Pinky Primrose)

All speakers are contacted and coming. Three hundred fifty banquet meals ordered, 275 lunches. Door assignments at the clinic, district rep. meetings, awards program at the banquet, exhibitors, and operations of mini clinics were discussed by Pinky. 1991 All-Star series will be in Iowa City, players staying at Westfield Inn Motel, rooms available for parents. Pinky explained some of the duties of the various committees and how they were doing. The Fall meeting will be in Iowa City, Banks hosting. Pinky also discussed honoring ball players who went on to become distinguished persons and that we should review the qualifications for district contributors. He suggested the Hall of Fame committee really look at recognizing players who have distinguished themselves in the country.

C. Hall of Fame Committee (Lou Koenigsfeld)

Look for former players and contributors. Anyone with 20 years + experience should be considered.

D. All-District Committee (Eugene Meister).

Select a super team and then have committees to select 4A, 3A and 1A-2A all state teams. Look at selecting more players on All-State Teams. Look realignment of districts.

E. Awards Committee (Ed Feyen).

New award---District Ass't Coach of the Year. Same criteria as District Coach of the year. Nominate at District meeting.

F. All-Star Committee (Don Taylor).

In the process of contacting people for the 1991 All-Star program. Encourage coaches to nominate good players in their area for All-Star Game.

1993 All Star Series--Lee Toole has started process for hosting 1993 Series.

G. Umpire Committee (Gary Paulsen).

Recruit new head for Umpire's Clinic. Coaches should encourage umpires to join association.

H. Vince Meyer Award Committee (John Zahn).

Make sure nominations are sent in.

I. Audit Committee (Fr. Craig Collison)

Books appear to be in order. Moved to accept books as approved by committee. Moved by Watson and second by Heald to approve. Carried.

J. Rating Poll Committee (Bob Watson). No Report

K. Membership Committee (Phil Lebo).

Letters sent to all association schools. 431 schools, 336 are members.

L. Constitution Committee (Rich Stoffers). No report.

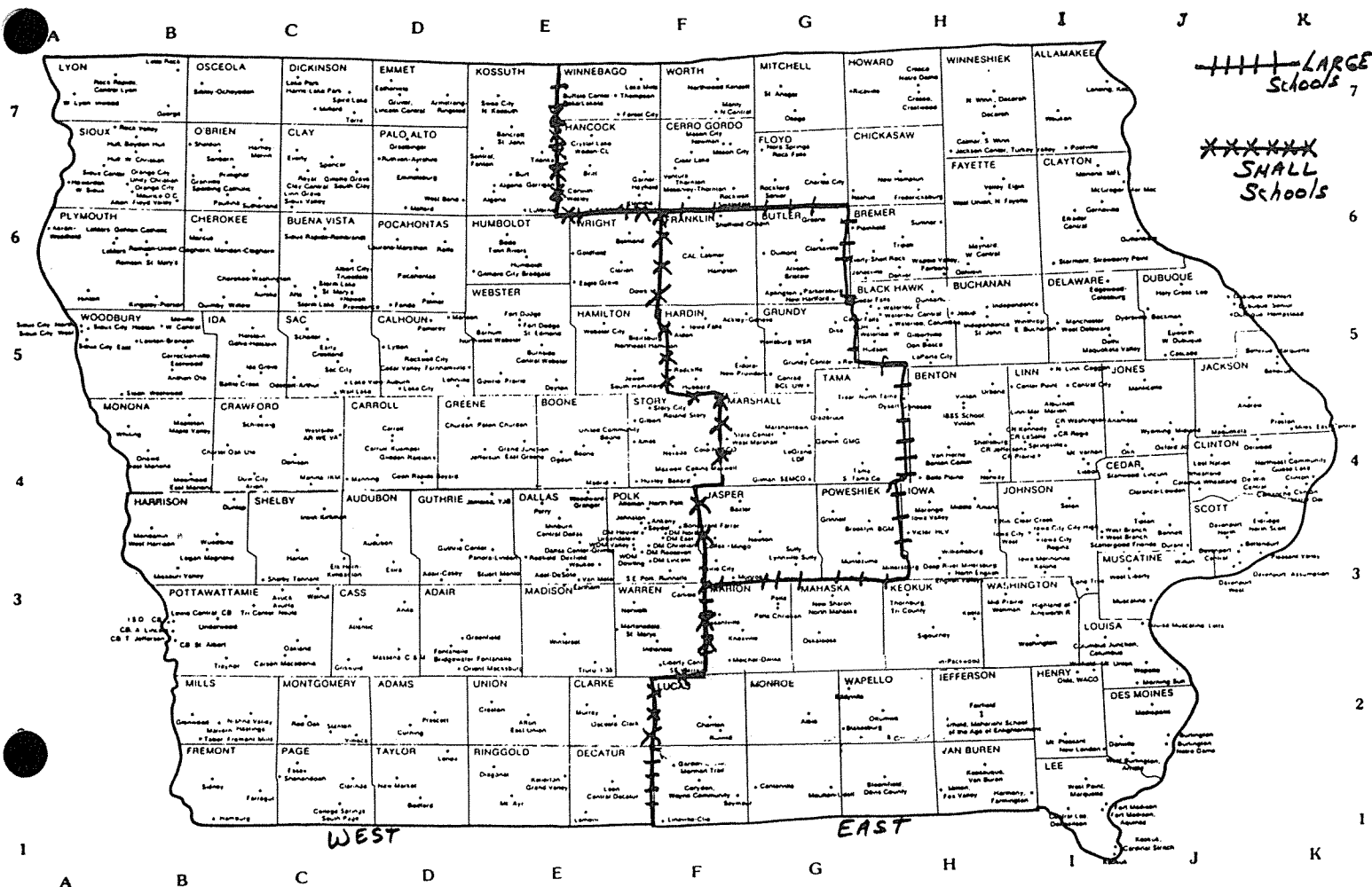

COACHES CODE OF ETHICS



NATIONAL FEDERATION OF STATE HIGH SCHOOL ASSOCIATIONS

The function of a coach is to properly educate students through participation in interscholastic competition. The interscholastic program is designed to enhance academic achievement and should never interfere with opportunities for academic success. Each child should be treated as though they were the coaches' own and their welfare shall be uppermost at all times. In recognition of this, the following guidelines for coaches have been adopted by the NFCA Board of Directors.

The coach must be aware that he or she has a tremendous influence, either good or bad, in the education of the student athlete and, thus, shall never place the value of winning above the value of instilling the highest desirable ideals of character.

The coach must constantly uphold the honor and dignity of the profession. In all personal contact with the student athlete, officials, athletic directors, school administrators, the state high school athletic association, the media, and the public, the coach shall strive to set an example of the highest ethical and moral conduct.

The coach shall take an active role in the prevention of drug, alcohol and tobacco abuse under no circumstances should authorize their use.

The coach shall promote the entire interscholastic program of the school and direct his or her program in harmony with the total school program.

The coach shall be thoroughly acquainted with the contest rules and is responsible for their interpretation to team members. The spirit and letter of rules should be regarded as mutual agreements. The coach shall not try to seek an advantage by circumvention of the spirit or letter of the rules.

Coaches shall actively use their influence to enhance sportsmanship by their spectators working closely with cheerleaders, pep club sponsors, booster clubs, and administrators.

Contest officials shall have the respect and support of the coach. The coach shall not indulge in conduct which will incite players or spectators against the officials. Public criticism of officials or players is unethical.

Before and after contests, rival coaches should meet and exchange friendly greetings to set the correct tone for the event.

A coach shall not exert pressure on faculty members' to give student athletes special consideration.

It is unethical for coaches to scout opponents by any means other than those adopted by the league and/or state high school athletic association.

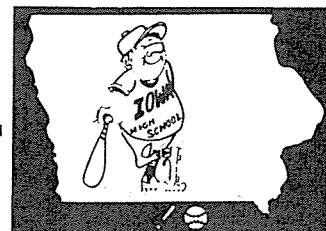

MEETING MINUTES

APPROVED BASEBALL ADVISORY COMMITTEE RECOMMENDATIONS.

Members had previously received copies of the Baseball Advisory Committee minutes and at this time took same under advisement. (MMS-Dyer, Williams) that the following recommendations be approved:

1. To adopt the pitching limitation rule as experimented with during the 1990 summer season and penalty for violation be forfeiture of contest.
2. The following items be emphasized at the IHSAA's baseball rules meetings prior to the 1991 season.

A. Throwing of bats and helmets

B. Umpires reporting use of smokeless tobacco by players and coaches

C. Umpires be directed to call the real strike zone and give the pitchers the upper half of the strike zone

D. Umpires can be a major factor in a game moving quickly or dragging along

3. Adopt May 1 as the starting date for all players and eliminating the April 15th date for the working with any four players. If May 1 falls on a Friday or Saturday, the following Monday will be the starting date of practice.

4. Follow the National Federation High School baseball rules which provides as an option metal or non-metal cleats with the understanding that the Iowa High School Athletic Association recommends the use of non-metal cleats.

5. Approved experimentation by conferences desiring to speed up the game of baseball using three balls and two strikes for the 1991 season. Written permission is required.

6. A general topic be placed in the baseball manual relative to the safety of playing facilities and liability of same.

Motion carried unanimously.

Members tabled any official action with reference to the Committee's recommendation for classification changes so they are consistent with the classification used in basketball. If changes take place the Committee desires consistency with other sport classifications.

ISSUES OF CONCERN / PROPOSED SOLUTIONS (IHSBCA) 3/15/91

The Iowa High School Baseball Coaches met at it's annual business session on Friday, March 15, at 10:45 a.m. Several business items were discussed; however, a majority of discussion focused on concerns faced by baseball programs at present in the state as well as the recent letter sent out by the Iowa High School Athletic Association pertaining to it's present guidelines of May 1 starting date for all players with no coaches involvement, facility use or school equipment use prior to May 1.

After considerable discussion about concerns facing baseball, the following general list of problems was recorded:

- A. Out of season camps/clinics
- B. Equity of sports (starting/stopping - off-season guidelines)
- C. All-star contests
- D. Overlap of seasons
- E. Limitations on the use of facilities and equipment
- F. A.A.U. sports
- G. Jobs
- H. Specialization of athletes

These concerns are certainly not new to anyone who has been dealing with baseball in Iowa, and it was agreed that rather than turning our meeting into a "gripe" session, we should focus on some possible solutions to these concerns, keeping in mind that the student athlete's welfare should be our #1 Priority!

Our first step was to poll our coaches at the meeting as to which of three proposals drafted at our business meeting they felt would deal with these concerns keeping the student athlete's welfare as our top priority. A copy of the survey is enclosed.

199 surveys were returned: they can be broken down as follows....

A segment of the survey provided for comments or suggestions. A summary is as follows:

- Proposal 3 allows flexibility in a district as to how many games may be played while school is in session. Should allow you to drop 25 date limitation but retain 40 game limit.
- Problem with game length is a problem of pitching depth. If you want to speed games up--drop date limitation and allow single games to be spread out with J.V. competition included. This would be in kids best interest. 3-2 count is a band-aide approach to a deeper problem!
- Very disappointed in IHSAA letter stating: "The gymnasium was not built for baseball practice." Was it built for track and golf?
- If Proposal #2 is adopted there should be no ISHAA events during baseball. No basketball all-star games, team camps, etc. Eligibility sanctions should be given for violations.

As can be seen from the summary of comments and suggestions, there is a wide variety of opinions that exist. Throughout the variety of opinions expressed, however, two things stand out loud and clear.

1. Our student athletes are being faced with tremendous pressures from a wide variety of fronts, whether they are in large or small schools.
2. A distinct majority of baseball coaches, those who must face and deal with many of these issues together with the student athlete, feel that a version of Proposal #3 would address many of these concerns.

We as a coaches association would appreciate the opportunity, through our advisory group, to discuss these options and suggest a proposal that will deal equitably with concerns we face, keeping in mind our student/athletes and the demands they face.

We know that any one proposal will not make all parties "happy," however, we feel it is time we put all selfish concerns aside and take a look at the overall picture for our student athletes.

Copies of this letter and survey are being forwarded to the Iowa High School Athletic Association and the Iowa High School Athletic Director's Association.

We are looking forward to your response and the possibility of working together to solve some of the previously mentioned concerns.

- 13 Proposal #1: Continue present guidelines:
Wednesday, May 1 starting date for all players, with season ending August 3 at the completion of the State Tournament. Games may begin May 30 -- 25 playing dates / no more than 40 games. No coaches involvement or use of facilities or school equipment prior to May 1.
- 64 Proposal #2: Practice begins April 15 (4 players only) per day. May 13 start for all players. May 30 games may begin. 25 playing dates / no more than 40 games. Season runs through August 3 with completion of the State Tournament.
- 122 Proposal #3: April 1st starting date for all players. 25 playing dates / 40 game limit. (Considering school is still in session, local districts may decide game limitations while school is in session.) Season runs through State Tournament which would be sponsored on or about July 4. Games may begin May 1.

ADDITIONAL COMMENTS OR SUGGESTIONS:

(See summary in letter.)

- Proposal 2 flies - I prefer pitchers only instead of four players.
- Proposal 1 I can buy if pitchers could begin throwing April 15.
- Smaller schools and larger schools may have different levels of satisfaction with these issues.
- Is throwing in the gym really different than shooting in the gym at any time?
- I like the idea in Proposal 3 of the possibility of three games a week, Monday-Friday; no limit on weekends.
- In the students' best interest, the IHSAA must take a look at summer basketball policy--too many young people are being forced to decide on one sport (basketball or baseball).
- I have concerns that Proposal 3 would kill track and baseball at our school. Proposal 1 does not allow baseball equity...basketball calls it open gym--we should have the same right as long as there is no instruction.
- Most schools in Iowa are small. Proposal 3 allows a limited schedule early where you can spread kid's arms out - I like it.
- Pitchers need more time early for conditioning arms to prevent injury.
- Multi-sport athletes which we all count on are not getting time to be kids. They have no time to get a break from competition...Proposal 3 seems in the best interest of all programs and kids!
- Proposal 3 would eliminate many of problems with kids wanting to go to camps. Would eliminate a lot of chances for cheating.
- No camps for anyone till after July 4th--we battle football, basketball, camps, Boy's State, all-star games, college orientation, just to name a few. We rarely have an entire squad there due to outside activities.
- Track and baseball can cooperate in Proposal 3. With more dates, flexible scheduling can take place for kids to do both.
- A.A.U. baseball is beginning to emerge in the spring. Proposal 3 would eliminate this. Let the Legion and AAU have the summer.
- Is spring a sacred time? Kids make choices in the fall, in the winter, and in the summer. Let's put things back on equal footing and let kids - not programs make their choice.
- The way it stands, the May 1 starting date is a month conflict with track, tennis, golf, etc. Let's go with Proposal 3 as it would allow kids time for some unpressured choices in the summer.
- Proposal 3 will bring kids back to the ballpark. Summer tends to alienate student support
- We have lost a lot of quality coaches because of the many concerns addressed. Proposal 3 may allow coaches to be what they intended to be..baseball coaches--not schedule coordinators.
- 3-2 rule won't speed up game. Time limitations between innings with penalties will force all teams to hustle. Speed-up rules in spring are very successful at the collegiate level. (Would help game in any of the proposals.)
- Proposal 3 is a good one; however, pitchers need two weeks prior to regular players to start to condition arms.

SUGGESTED SPEED-UP RULES

By state association adoption any, all, or any part of the suggested speed-up rules may be used.

RUNNERS

1. The team at bat may use courtesy runners for the pitcher and/or the catcher as soon as they reach base. The same runner may not be used for both positions. Neither the pitcher nor the catcher will be required to leave the game under such circumstances.
2. Players who have participated in the game in any other capacity are ineligible to serve as courtesy runners.
3. A player may not run as a courtesy runner for the pitcher or the catcher and then be used as a substitute for another player in that half inning.

PENALTY: For illegal substitution, such substitute shall be ejected.

AFTER PUTOUTS

1. After a putout in the outfield and with no runners on base, the ball shall be thrown to a cutoff man, and if desired, to one additional infielder before being returned to the pitcher for delivery to the next batter.
2. After a putout in the infield and with no runners on base, the ball must be returned directly to the pitcher.
3. Following the final out in any inning, the ball must be given to the nearest umpire. The plate umpire will give the ball to the catcher; the base umpire will place the ball on the pitcher's plate.

COMMENTS ON THE RULE CHANGES

1-1-5 — Player Deliberately Removing Batting Helmet During Playing Action — The Baseball Rules Committee felt that a stronger penalty for deliberately removing the batting helmet was needed in order to emphasize safety. It also felt that a team warning would allow each team the benefit of the doubt for "deliberately" removing the helmet with the full understanding that all subsequent players on that team who violated the rule would be ejected. Previously, if a player deliberately removed his helmet, the ball was dead immediately and he was declared out. The committee felt that the penalty was too strict in situations when a player would remove his helmet and a play was unlikely to be made on that player. Therefore, the rule was revised requiring the umpire to issue a team warning for the first offense, with the next offender(s) on that team being ejected. This is now a delayed dead ball situation. Emphasis still remains on safety, but an out is no longer called.

1-2-2 — Artificial Pitcher's Mound Permitted — Traditionally, the maintenance of pitcher's mounds has been a problem. Pitchers continually dig holes, which make pitching difficult and may present a safety hazard. The use of an artificial pitcher's mound, as specified by rule, is likely to help eliminate these concerns by providing a more consistent surface.

3-3-1-a — Use of Videotape During Game for Coaching Purposes Not Allowed — The rules did not address this situation previously. The rules committee felt that the use of videotape during the game for coaching purposes was inappropriate. If the rule is violated, the umpire shall warn the coach of the offending team and eject him if he or anyone on the team repeats the act. The rule precludes a video camera from being in the dugout area.

10-1-4 — Use of Videotape by Umpires During Game Not Allowed — Using videotape to decide a call or for rendering a decision during the game is considered by the committee to be inappropriate, and is therefore prohibited. Umpires may consult with each other before making a final decision, but reviewing videotape is not allowed.

10-1-6 — Umpires Not Allowed to Use Mobility Aids Which Restrict Movement — Safety has always been the primary concern as rules are formulated for high school baseball. To ensure the safety of players, coaches and umpires, certain items and equipment that could contribute to injury are prohibited. Like players and coaches, umpires have a responsibility to be able to participate without jeopardizing anyone's safety. An umpire whose mobility is restricted by equipment such as crutches, canes, wheel chairs or casts, presents a serious threat to the safety of everyone involved in the game, including themselves. Casts not restricting mobility may be worn, if padded.

Speed-Up Rules — Courtesy Runners for Pitcher or Catcher Must Be Used As Soon As They Reach Base — The intent of the rule is to have a courtesy runner replace the pitcher or catcher as soon as they get on base, not some time later. The effect of speeding up the game can best be accomplished when the pitcher or catcher is replaced immediately by the courtesy runner.

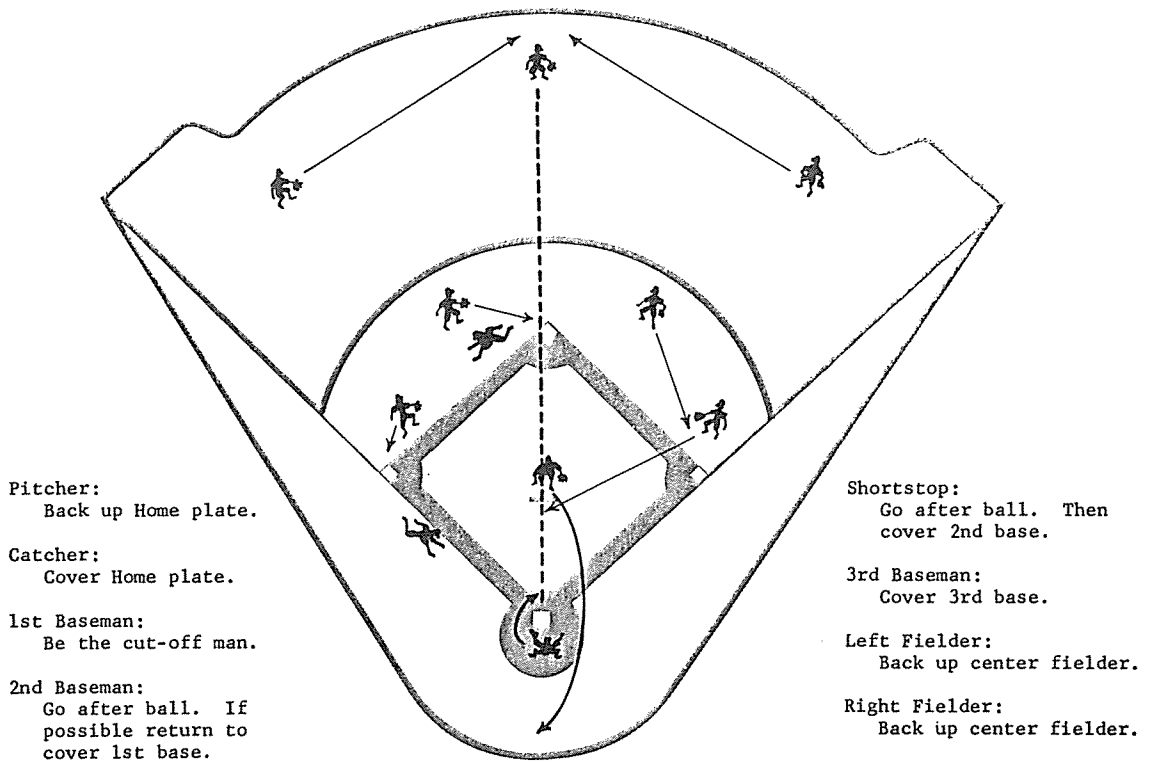

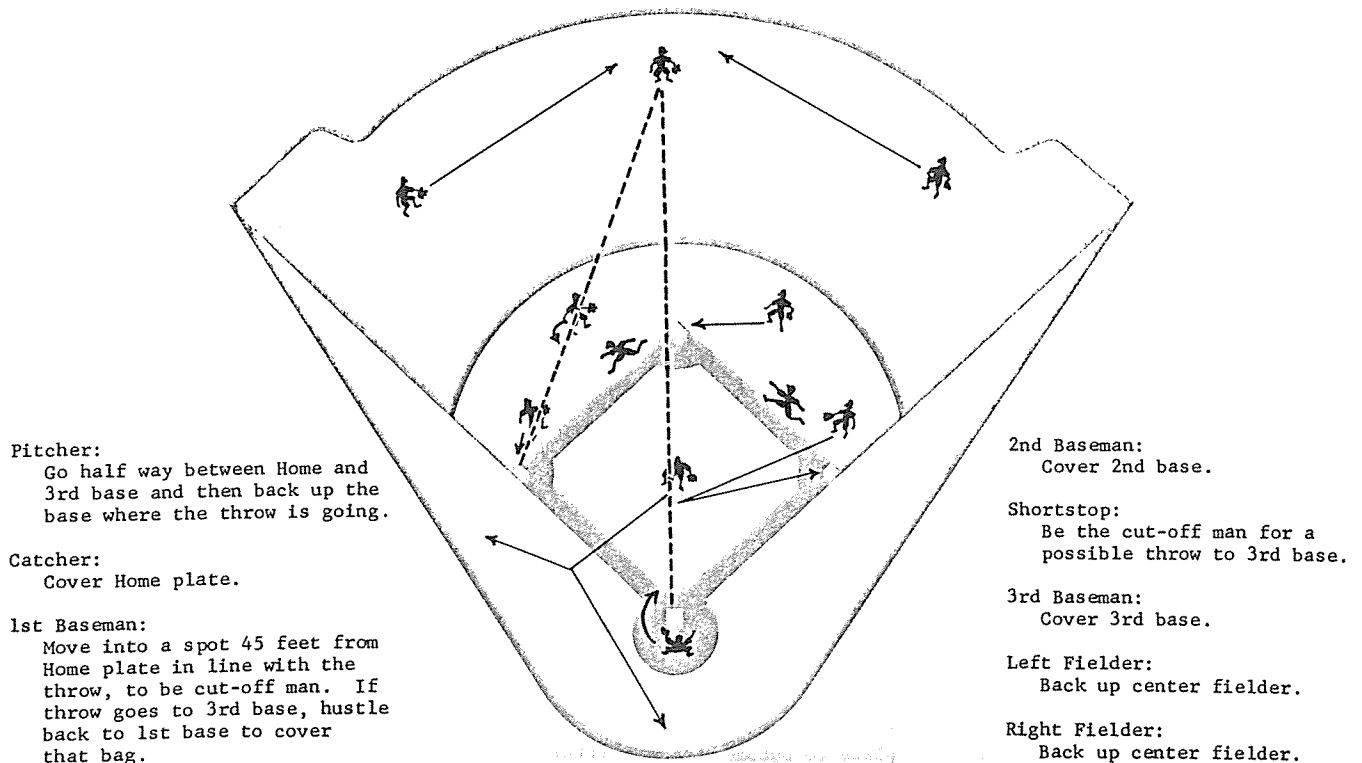

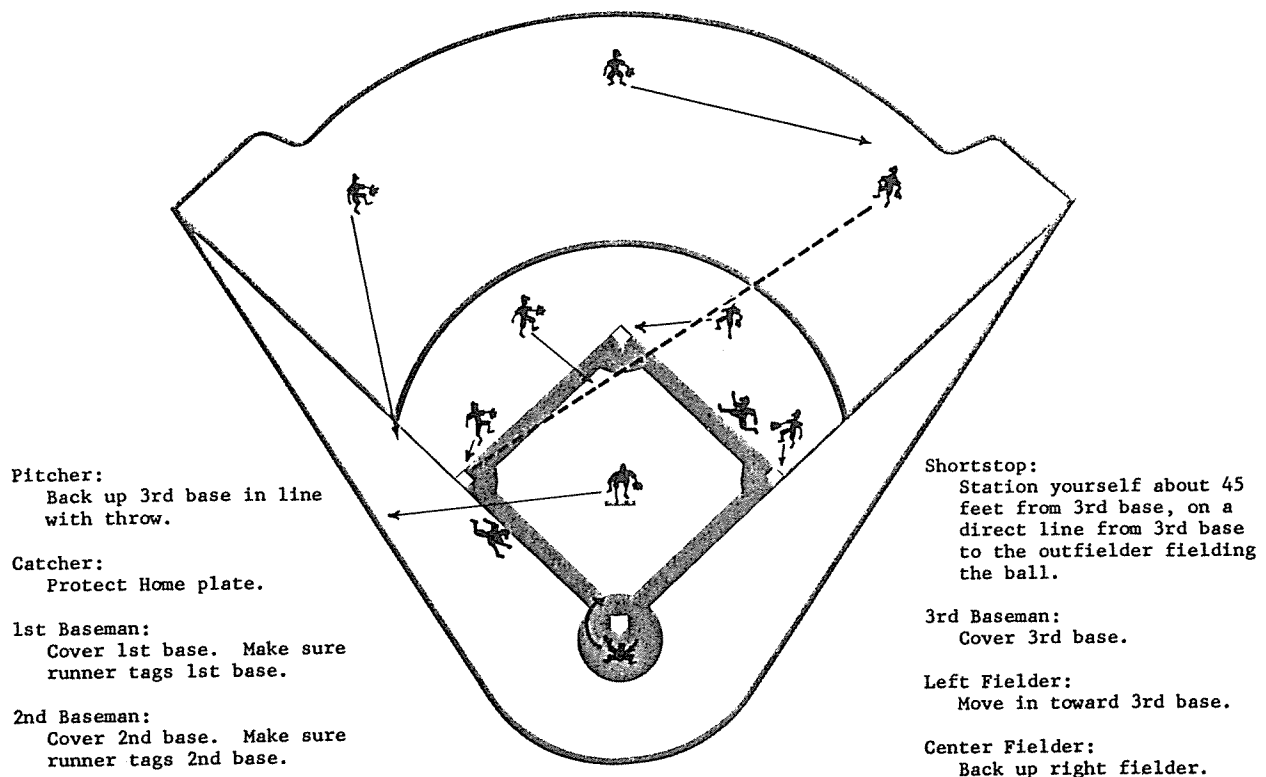

Single to Center Field

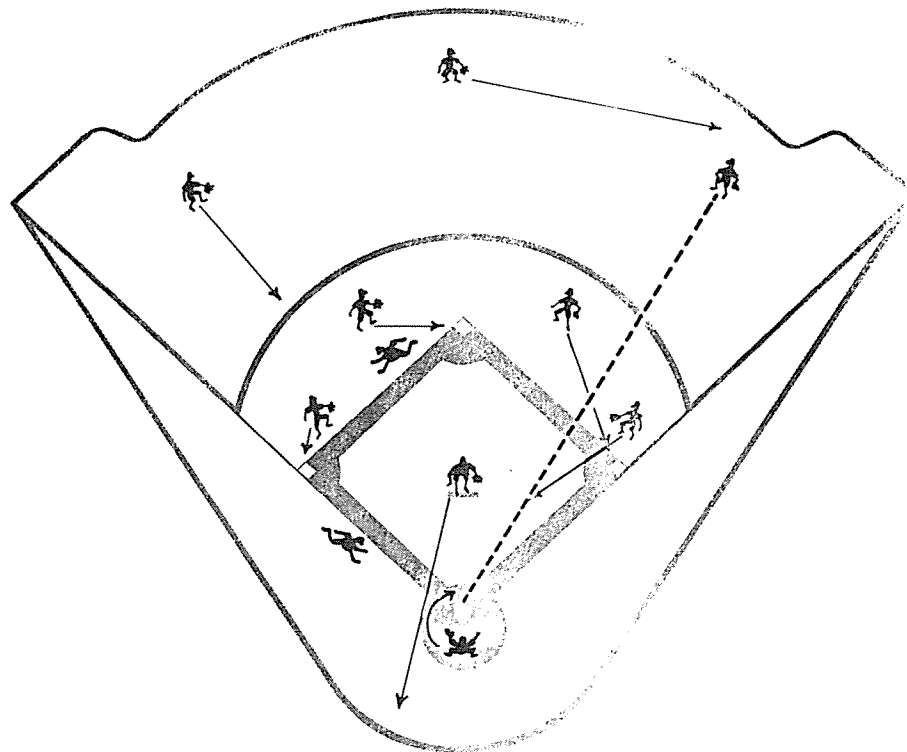
