**1999 31st Annual Clinic:** The Coaches Association announces the 31st Annual Clinic, February 5-6-7, 1999, in Cedar Rapids at Washington High School and University of Iowa on Sunday. The coaching clinics will begin at 1:05 p.m. on Friday, February 5, and will continue to 5:00 p.m. on Saturday. The Awards Banquet will be at the Crowne Plaza Five Seasons Hotel, on Saturday evening, highlighted by the Hall of Fame and Coach and Umpire of the Year Awards. Sunday the Clinic will move to the Iowa Bubble in Iowa City.

The Steering Committee, Board of Directors and several other committees will be meeting prior to the start of the Clinic. They will meet Thursday, February 4. Check the committee meeting schedule for times.

We hope to have 20 exhibitors who will display all the latest in baseball equipment and coaching aids. This Clinic promises to uphold the tradition of the past clinics.

**Six Selected For '99' Hall Of Fame:** Three coaches, one umpire, two players and one contributor have been selected for induction into the I.H.S.B.C.A.'s Hall of Fame.

The six inductees are: Larry Avery, Donnellson, Jack Bruner, Waterloo; Harold Manders, Dallas Center; Andy McGaffin, Spencer; Lowell Thomson, Mason City and Brent Prange, Des Moines.

The six will be inducted at the Awards Banquet, Saturday, February 6, 1999, in Cedar Rapids. They will join 164 other Hall of Fame members.

**LARRY AVERY:** a graduate of Stronghurst High School in Illinois. He went on to Burlington Community Junior College and Western Illinois University, graduating in 1963. Larry has been coaching for 27 years, with a career record of 425-204. He is a member of the 400 win club and the 20-year longevity award club. He was District Coach of Year twice and Conference Coach of year four times and the State Coach of the Year in 1989. His teams have participated in two state tournaments, winning 4 district titles, 10 conference titles.

**JACK BRUNER:** of Waterloo, played his high school baseball at Waterloo East, missing his senior year when he entered the Service in 1942. He graduated in 1945 after service. He pitched a perfect game against Edgewood, IA, in the tournament trails. He went on to the University of Iowa from 1946-49, and then went into Pro baseball in 1949 after becoming an All-American Collegiate baseball player. At the University of Iowa, Jack was the terror of the Big Ten, having a strikeout record of 66 in 61 innings. In the summers he played for the Storm Lake White Caps, batting over .300 and having a 17-1 record. In the Minors he pitched a no-hitter against Wichita. He played with the White Sox and the St. Louis Browns. His first major league win was against the Yankees. He beat Fireman Joe Page. His over-all record in the Majors was 2-4. Jack is now retired, living in Lincoln, Nebraska.

**ANDY McGAFFIN:** of Spencer, has been coaching for 24 years. He graduated from Winterset High and then went on to University of Northern Iowa where he played baseball his freshman year as a catcher. He graduated in 1969, going on to Lake City High School, now called Southern Cal Schools, where he coached for five years. He then moved to Spencer where he has coached for 18 years. He has an overall record of 363-225. He has taken his team to the state tournament twice, winning the championship once. He is a member of the 300-win club, and the 20-year Longevity Award club. He was the District Coach of the Year four times and State Coach of Year in 1997. He has been nominated several times. Andy coached in the 1984 All-star Series and has served on the Board of Directors and gone through the officer chain, serving as President in 1990. He has been a very active member of the Association for 24 years.

**HAROLD MANDERS:** of Dallas Center, graduated from Waukee High School and University of Iowa, where he played baseball as a pitcher. "Hal" started his long baseball playing career at Waukee in 1931, graduating from Waukee in 1935. He entered the University of Iowa in 1936 as a Pitcher. He played semi-pro baseball in Des Moines with the Farmers Union team having a 15-1 record. He signed a pro contract in 1937, with the Detroit Tigers, making the major leagues in 1941. He played in the major leagues with the Tigers and Cubs, have a 3-1 record, used in relief most of his years. While in the minors, he played in every All-Star game until he made it into the majors. Hal had a 89-59 record in the minors. After his time in the majors, he played semi-pro baseball with Audubon in the Iowa State League. Hal has been a great promoter of American Legion Baseball in the State and started the Little League Program in Dallas County. He also started the Babe Ruth League in Dallas County. Hal Manders is a first cousin of Robert "Bob" Feller. He claims he was never defeated in Van Meter! Harold struck out 21 batters in 7 innings in one game.

**BRENT PRANGE:** of Des Moines, has been umpiring for twenty years, and has been a member of the IHSBCA for 15 years. He worked 30 college games and over 40 high school games each year. He has worked the District through the State Tournaments as well as the Iowa Conference, and the State Junior College Tournaments. Brent has served on the Board of Directors of the Coaches Association and was nominated for District Umpire of Year three times and was named Umpire of Year in 1997. Brent is a Counselor at Ankeny High School.

**LOWELL THOMSON:** of Mason City, graduated from Kanawha High School where he played high school baseball as a short stop. He attended Britt Junior College and transferred to Iowa State Teachers College, where he played 2 years of Varsity base-

ball as an outfielder. He coached high school baseball for 20 years in Ledyard, Plymouth and Mason City, retiring at Mason City in 1986. His over-all record was 354-201. He won six District titles, three sub-states and was State Runner-up once. His teams participated in the State Tournament twice. Lowell served as an umpire at Mason City from 1958 until 1972. He coached Little League and umpired in the Little League tournament. He coached in the Second All-Star Series and was named Coach of the Year in 1980. He was District Coach of the Year in 1980. He now is retired and living in Texas in the winter.

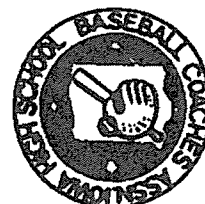

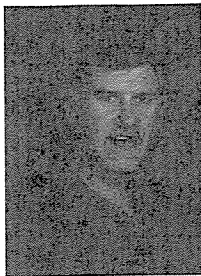

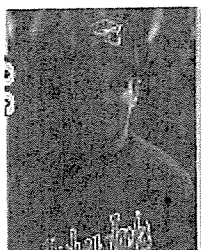


## CLINIC SPEAKERS:

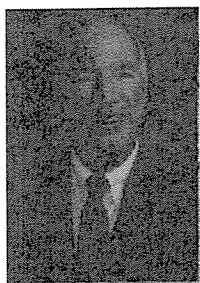
**TERRY AYERS:** Owner and President of American Baseball Academy, a special school for high school pitchers with positive drills and skill work to make them better. Terry was a high school coach for 23 years. He also was an assistant at a Junior College as a pitching coach for two years. Terry was Regional Director for Doyle Baseball School for six years. He was an Assistant Coach in the Pan American Games in Salta, Argentina. His teams won State A.A.U. Championship in 1996. Fifth in the 1998 Nation A.A.U. 17 and under team in Des Moines. Terry has over 400 wins as a coach. Several players are in college and in professional baseball.



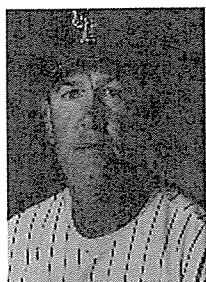
**PETE CALIENDO:** An instructor at the Baseball Schools USA for 2 years with 10 years of experience with the Mickey Owens School. Pete managed a summer college team and was Assistant coach at the University of Illinois/Chicago Circle. He has spoken at 100 plus coaching clinics in the country. Pete played four years of college baseball and played professional baseball in Italy for one summer. Pete coached in the Northern Professional Baseball League last summer and was Head Coach and Director of Baseball Development in the Belgium Baseball Federation from 1995 to the present. Pete is currently the Director of Development of Baseball Operations for the Schaumburg Flyers. He will also coach with the Flyers. Pete has published several articles.



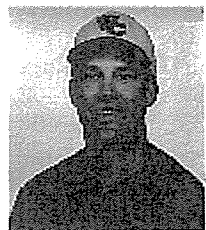
**JIM DIMICK:** Former baseball Coach at St. Olaf College, Northfield, MN. Jim has given many clinics throughout the U.S. He is a past President of the ABCA and a Hall of Fame member. Jim's teams have won over 500 games. He was the recipient of the Dick Siebert Award in 1978 for contributions to baseball in Minnesota. He is one of the most respected speakers in America. Jim has given many clinics in Europe for the USBF.



**RICK MATHEWS:** It's been ten years since Rick has spoken to our coaches. Rick is a former coach at Eddyville, Marshalltown, Iowa Western C.C., K. C. Royals minor league field coordinator and pitching coordinator and presently with the Colorado Rockies as the field coordinator and pitching coordinator for the minor league system. Rick holds many clinics for young pitchers and catchers throughout the state. Rick is a member of the IHSBCA Hall of Fame.

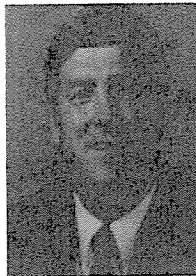


**JOEL HOLST:** is entering his fourth season as Wartburg's head coach. In 1997 and 1998 he guided the Knights to the Iowa Conference championship and into the NCAA Division III Central Division. He has also been named the Iowa Conference Coach of the year the last two seasons. He has posted a career record at Wartburg of 90-46. Coach Holst served as head coach at Loras College for five seasons, where he amassed a 100-80 record and led the Duhawks to national rankings for the first time in school history. After grad-

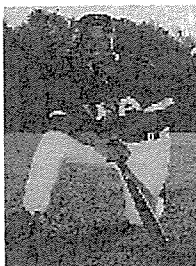


uating from Coe College in 1985, where he earned First Team All-Conference honors three straight years, Coach Holst spent four years as head coach West Delaware. At West Delaware he was nominated District Coach of the Year three times, won a Wamarc Conference and compiled a record of 100-50.

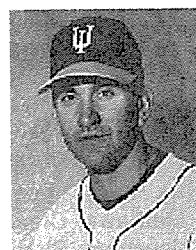
**DUANE BANKS:** Former head coach at the University of Iowa where he coached from 1970 until 1997. Duane's overall record at Iowa was 810-575. Banks was inducted into the ABCA Hall of Fame and also the IHSBCA Hall of Fame. He has served as past president of the ABCA and is one of the leading college coaches in the country. Duane has been named both Big Ten Conference and District Coach-of-the-Year. Many of his former Hawkeyes have earned pro contracts and several have made it to the major leagues.



**BILL KREJCI:** Enters his 21st season as the Head Baseball Coach at Southwestern. Prior to arriving at Southwestern Krejci coached at Thomas Jefferson High School in Council Bluffs. Krejci is a graduate of Northwest Missouri State Univ. where he lettered 3 years in baseball. In 1975-76 he served as Assistant Baseball Coach at Northwest Missouri State where he helped lead the Bearcats to the NCAA Division II World Series. This past summer Bill was an Assistant Coach of the USA Youth Team which won the gold medal in the IBA World Games. Krejci also served as a trials coach in 1996-97 for the USA Junior Team. Bill was recently inducted into the Northwest Missouri State Hall of Fame and St. Lawrence High School Hall of Fame in Chicago.



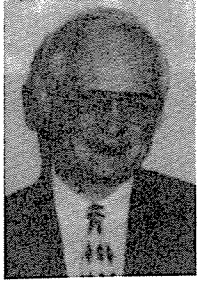
**RICK HELLER:** Enters his 13th season as the Head Baseball Coach at Upper Iowa. Prior to arriving at Upper Iowa Rick played four years of baseball at Upper Iowa. He was an assistant baseball coach at North Fayette High School before taking the head baseball position in Bakersfield, MO. He returned to Upper Iowa as head coach in 1987. In the past 12 years, Rick has won three Conference Championships and has gone on to the NCAA Central region three times. He was named Conference Coach of the Year four times. His 1998 team record was 38-8. He has been a member of the Association for twelve years.



**JIM CALLAHAN:** Enters his fourth season as the Head Baseball Coach at St. Ambrose. He was an Assistant Coach prior to taking over the head coaching position. Jim 1998 team record was 19-19 and he has an over-all record of 88-53. Jim won the Midwest Classic Conference in 1996 plus the Midwest, Regional and came in 2nd in the NAIA finals. Jim played his high school baseball at Dubuque Hempstead for Coach Core. He has been a member of the Association for 4 years.

Of these ejections: Bumping Official 1; Did Not Slide At Home Plate 19; Inappropriate Comments To Officials 5; Intentional Spiking 1; Jewelry Rule 1; Jumped Over Opponent 3; Kicked Dirt at Official 2; Malicious Contact 22; Profanity 32; Threw Dirt At Batter to Distract 1; Throwing Equipment 19; Unsportsmanlike Conduct 13; Verbal Misconduct 6.

### Questions frequently asked:

1. How can I get involved with the Association? All that is necessary is to attend the clinic and all-star series. Volunteer to work or coach at the all-star series and/or at the clinic. Serve on committees!

2. How can I coach in the All-Star Series? Fill out the form in this newsletter and the Steering committee selects the All-Star coaches. They try to get a balance of coaches in each District, hoping to be able to cover the state. Your nomination form stays on file for two years.

3. How can I umpire in the All-Star games? An umpire in the All-Star Series must have been a member of the Association for at least three years. He must be nominated at the District meetings that are held in July. All the nominations from these meetings go to the Umpires committee, which meets at the All-Star site. The nominees are narrowed down to three to each district. The umpire chairman and committee will then select four additional umpires from the area to fill in the other four spots. Sixteen umpires are selected to work each year. If you are interested, you should fill out a nomination form that will be in the next newsletter. This forms will be forwarded to the Umpire committee chairman. All the umpires are selected by the Umpire's committee.

4. How can I get on the Board of Directors? All a coach or umpire must do is get nominated by fellow coaches or umpires. The nomination form is in the Sept.-Oct.-Nov. Newsletter. The nominees who receive the most votes go on the ballot. The one-year representative and alternate stay on the ballot, but must win the votes to go on the Board.

5. Who makes the committee assignments? The Vice-President (President-elect) always makes the committee assignments for the coming year. A coach may request a certain committee. The president-elect will try to spread the committee assignments around so all sections of the state are represented. The chairmen of the committees are usually Board of Directors.

6. How are the district nominees selected? The district nominees are selected in the July meetings. Any coach who takes his team to the State tournament becomes an automatic nominee. The coaches who are nominated in the July All-District meeting and the State tournament are then narrowed down to three for each class at the Fall meeting of the Board of Directors. The District Representatives (Two-Year, One-Year and 2-Year Umpire Reps) select the three nominees that go on the ballot. It is very important that a coach fills out the nomination form that is sent to him.

7. Who selects the officers? The steering committee, who is made up of dues-paying past presidents, selects the officers. The office of President moves around the state by each district. It is in this rotation: Northeast, West, Central, Southeast. The past president is chairman of the steering committee.

8. Who selects the award winners? The award winners are all selected by the Board of Directors. The Hall of Fame is selected by the Hall of Fame committee. All Hall of Fame nominations go to the Hall of Fame committee. This committee is made up of Hall of Fame members of the Board of Directors, Steering Committee and Hall of Famers.

9. Who selects the President's Award? The Board of Directors upon the recommendation of the Executive Secretary.

10. Who selects the Bill & Sheery Freese Award? The Board of Directors upon the recommendation of the Executive Secretary.

11. Who selects the Harold "Pinky" Primrose Award? The Board of Directors upon the recommendation of the Executive Secretary and the Hall of Fame Committee.

12. Who selects the District Media and Contributors Winners? The District chairman of the district with the help of the other representatives select the winners at the Fall meeting.

13. How can a coach or umpire speak at the Annual Clinic? Very easy. Volunteer, give the Clinic chairman your topic, expertise and topic. That committee meets in November and puts the clinic together with the speakers.

14. How can I get my good ball player on the All-Star Team? All you have to do is fill out the profile form in the newsletter and submit to the Executive Secretary. The forms are then forwarded to the Head Coach of each team. The coaching staff then selects the team that they feel can win the Series. They also must have a balance on their team; not everyone can play shortstop. After you submit the form, please let the coaches know that your player has been doing the job for you all year. Make sure you try to get the player exposure. Have other coaches recommend him.

If you have questions that you want answered, please forward them to the Executive Secretary or President of the Association. This is your organization; it needs you and you need it in order to get better and improve. Our business is to help improve high school baseball in the state of Iowa and also honor the coaches and players each year who have done an outstanding job in their district.

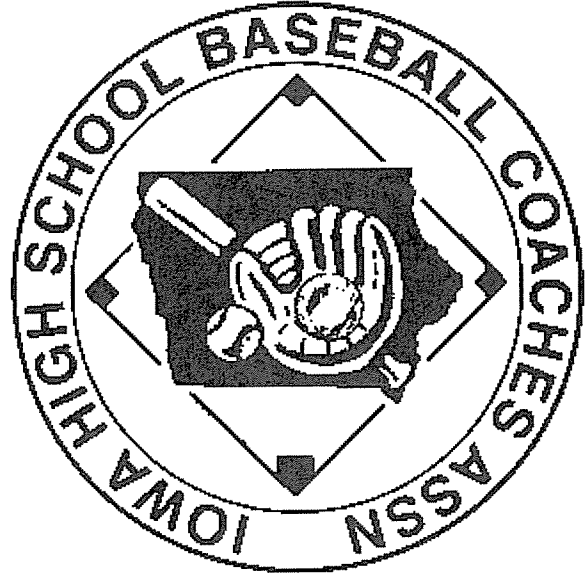
**BASEBALL ITEMS TAKEN FROM THE DECEMBER BULLETIN OF THE I.H.S.A.A.**

Board of Directors Meeting  
November 14, 1998

The fall meeting was called to order at 10:00 a.m. by President Eugene Meister. Gene introduced the directors and thanked Scott Broghamer for hosting the fall meeting.

A/ President's report. President Gene Meister thanked all for being present at the meeting. Thanked Pinky, Bill and the All Star committee for making the 1998 All-Star Series a success.

B/ Executive Secretary's report by Pinky Primrose.

1. Welcome to the meeting and thanks to Scott Broghamer for hosting the fall meeting each year.

2. The Association needs to look at raising the player's All-Star fee from \$125.00 to \$150.00. We need to make enough money at the All-Star Game to pay expenses and with rising hotel and food costs it is not possible unless we raise the player's fees. Last year's All-Star Games lost money, partially due to the bad weather on the first two nights.

3. There are 98 plus coaching changes this year state wide.

4. Pinky emphasized the need to get new members to join the association. Encourage umpires to join as well.

Pinky then went through the different committees and gave a short synopsis of each.

a/ The All-Star Series The All-Star series are slated in the future for: 1999--Sioux City and 2000--Davenport. In 2001--Carroll has expressed an interest as well as Council Bluffs/Omaha.

b/ Nominating forms for All-star coaches are in this newsletter. Be sure to apply if you are interested in coaching in the All-Star series. If you have applied it should be on file. But apply again to confirm your interest for 1999.

c/ Umpiring, encourage umpires to join the association. This year 6 Bob Vrbicek Newcomers have been picked and they will receive a certificate.

d/ Correspondence. Numerous thank you cards were received for the All-star series, only one complaint. Numerous players stated this was the greatest experience of their life.

e/ All-state selection went very well. All districts were represented.

f/ All-Academic team competition is very tough. 80 players were nominated. The list was narrowed to 3 for the Lanny Peterson Award.

g/ All-State rating poll went well this year under the direction of Lee Toole.

h/. New ideas for membership were discussed. Pinky stated that we need more umpires and still need more small school participation.

i/ Thank you letter was received from Mr. Acker.

j/ Dave Harty will again present the Rules Interpretation meeting for all to attend on Saturday morning at the clinic.

k/ Pinky is in the process of completing the staff for the clinic. We have to date: Pete Caliendo, Rick Mathews, Ron Polk, Terry Ayers, Joel Holst, Jim Callahan, Rick Heller, Duane Banks. The umpires have changed their format. The Association umpires will be putting on the clinic. With the savings the association will be

offering scholarships to umpires who have never attended the clinic.

l/ Pinky stated that we have a web page. We will have the clinic on it next month.

m/ The Hall of Fame committee needs to look at expediting the induction of Jack Bruner to the Hall of Fame. Jack was a dominating pitcher at East Waterloo and for the University of Iowa during the 1940s. Jack was signed by the White Sox and later pitched for the St. Louis Browns.

n/ The President's award will go to Rex Bradley, Vice-President of Louisville Sluggers. Rex has contributed the bats to the Coaches of Year Award since we started the Award.

o/ Recommended that Scott Broghamer be the recipient of the Bill and Sherry Frese award.

p/ Recommended Swede Anderson of Carroll is the recipient of the Harold "Pinky" Primrose Award.

q/ The Hilton in Sioux City will be the site for the 1999 All-Star Series. If any one is interested in coaching in the series, please fill out the sheet in the newsletter. We especially need 4A coaches.

r/ Father Collison is the recipient of the state SGMA hero's award. Father received \$100 for himself and \$400.00 for IHSB-CA. Father is now up for the national award that will be announced in USA Today. We are all encouraged to write or E-mail SGMA on Fathers behalf.

Reports:

C/ Hall of Fame Report: Roger Hoel and committee recommended that the following people be inducted into the Hall of Fame. Harold Manders (P); Jim DeBlau (Cont); Andy McGaffin, Larry Aver and Lowell Thomson (C); Brent Prange (U).

D/ Awards Committee by Terry Heald. Committee is looking into changing wins award retroactively. Currently the Association only honors to 500 wins. Look into adding 600-1000.

E/ All Star Committee by Nick Archer. The All-Star Series is on schedule. Jim Scholten is chairing the committee and is getting help from the four Sioux City High school coaches. This year's game will be played at Lewis and Clark Stadium. This year's All-Star Series will also include a baseball Olympics. Players will perform many different baseball skills. Should be a lot of fun for the players.

F/ Umpires Committee by Gary Paulsen. Up to ten umpires who have never attended a Baseball Clinic in the past, will have the potential of receiving a Free Registration. The tuition will come as a result of the savings of our Association umpires putting on the clinic. Ken Bahrke moved to accept this recommendation, Marlow Van Ginkle seconded. Motion passed.

G/ Lanny Peterson Award Report by Rich Stoffers. There were 80 boys up for All-Academic. Coaches are doing a great job of identifying deserving student athletes. Last year's winner was Brian Powers of Mason City Newman.

H/ Academic All-State. No Report.

I/ All-State Rating Poll report by Lee Toole. More coaches than ever were involved this year. Made the job of the committee much easier. Keep up the good work.

J/ Membership Committee by Ken Bahrke. Membership is somewhat better. Still trying hard to reach all the schools.

K/ Constitution Committee Report by Steve Westphal. Steve had nothing new to report.

L/ All-State Coach Committee Report by Charlie Stumpff. No report.

M/ Advisory Committee Report by Jim Mahoney. The climate between coaches and state association is the best it's been in years. There were no real concerns brought up by the state at this time. State would like us all to work on sportsmanship and reducing the number of players and coach ejections. There is a concern among our association about the rotation of coaches on the Advisory Committee. Eugene will call Dave Harty to see if our Association can recommend a pool of coaches that the state will choose from. This will insure our Association has input at the state level.

A Contributor of the year was nominated. He is Scott Broghamer. He contributes hard work at the Clinic and All-Star series year in and year out. Moved by Nick Archer and seconded by Phil Katz to accept the recommendation. Motion carried.

The Presidential award nomination was for Rex Bradley of Louisville. Tim Sauer moved and Ed Feyen seconded. The motion passed.

## COMMITTEE DUTIES:

### ALL STAR COMMITTEE:

Function of Committee: There shall be an All-Star Committee of the Board of Directors composed of 2 members of the Board and other members appointed by the President. The President will appoint the Chairman.

#### DUTIES:

1. Shall serve as evaluators of the All-Star Series along with the Board of Directors.
2. Shall recommend to the Board of Directors any changes, problems and recommend possible solutions to problems.
3. Shall secure advertising for series program.
4. Shall help in running the day to day operation of All-Star Series. 1/ Gate keepers 2/ Foul ball chasers 3/ Program sellers 4/ Field maintenance 5/ PA announcer 6/ Score keeper
5. Shall secure a printer of the All-Star Program.
6. Shall secure a photographer for taking All-Star team pictures.
7. Shall help processing the players upon arrival.
8. Shall help in transportation to ball park.
9. Shall help in securing equipment.
10. Shall help in noon lunches at park.

Executive Secretary's Responsibility at All-Star Series:

1. Shall send out material to All-Star Coaches prior to All-Star series. Time for this should be right after the All-District picks. Material: a/ Medical Form b/ Insurance releases c/ Other information necessary for running series.
2. Shall handle all monies from the a/ program b/ tickets sales c/ banquet d/ sponsors e/ etc.
- 3/ Will be in charge of the Games---Times--Setting up Tournament---Umpires
- 4/ Overseer of Banquet--Picnic--Total operation
- 5/ Shall secure a featured speaker.
- 6/ Shall instruct the coaches about duties of all-star series and rules to live by.
- 7/ Shall secure housing--food & etc.

President's responsibility:

- 1/ Evaluate series 2/ Hand out medals 3/ Help in any area necessary.

### HALL OF FAME COMMITTEE:

Function of Committee: There shall be a Hall of Fame Committee of the Board of Directors composed of present Hall of Fame members and two MEMBERS OF THE BOARD, appointed by the President. The President will appoint the Chairman.

#### DUTIES

1. Shall have the power to select Hall of Fame members each year.
2. Shall set up the selection process for other Hall of Fame members.
3. Shall set up a meeting of the Hall of Fame members at the annual clinic meeting for the selection and discussion of future Hall of Fame members.
4. Shall send out a note to present Hall of Fame members to encourage them to continue to be active in the Association.
5. Shall present to Board of Directors in their October meeting the Hall of Fame members for the up-coming year.
6. Shall recommend after evaluation of the Hall of Fame Award methods to improve the program of the Hall of Fame induction.

Executive Secretary Responsibility:

1. Shall send out ballots of the nominees to the Hall of Fame member (dues paying).

### STEERING COMMITTEE:

Function of Committee: There shall be a Steering Committee of the Board of Directors, composed of the Past Presidents. The past immediate president will serve as chairman.

All recommendations of the Committee shall be reported in full to the Board of Directors. All transactions of the Committee shall be reported to the Board and acted upon the next regular meeting of the Board of Directors.

The Steering committee shall have two meetings annually.

#### DUTIES:

1. Shall have the power to select the All-Star coaching staff.
2. Shall be the nominating committee.
3. Shall study long-range needs of the Association and make recommendations to the Board.
4. Shall serve as a screening committee, arrange interview and make recommendations to the Board of Directors in the selection of the Executive Secretary.
5. Shall serve the President in any capacity deemed necessary by the President
6. Shall evaluate the Executive Secretary's work annually.

### AUDITING COMMITTEE:

Function of Committee: There shall be an Auditing Committee of the Board of Directors. The Committee shall consist of 1 member of the Board and the Treasurer, with other members appointed by the President. The President will appoint the Chairman.

All Recommendations of the Committee shall be in full to the Board of Directors. All transactions of the Committee shall be reported to the Board for action upon.

#### DUTIES

- 1/ They shall serve no more than two terms.
- 2/ They shall complete the audit by the Annual Convention Clinic meeting of the total membership.
- 3/ They shall report their findings to the membership.
- 4/ They shall give a written report of their findings to the Secretary to be recorded in the minutes.
- 5/ They shall visit with the accountant of the organization and recommend changes that are necessary with Board approval.

### MEMBERSHIP COMMITTEE:

Function of Membership Committee: The committee shall consist of the two-year voted members of the Board of Directors from each district. The President will appoint the Chairman.

#### DUTIES

1. Shall develop and execute plans for increasing the membership of the Association.
2. Membership shall be chosen to represent the various geographic sections of the state.
3. It will devise ways and means of cooperation with Umpires in securing members and in methods of organization for making such membership effective.
4. Such action shall be subject to the approval of the Board of Directors.
5. Shall work closely with Conference Representatives in their respective Districts.
6. Shall work to get 100% membership in each conference in the State.
7. Shall make a written annual report to the Board.

### **UMPIRES COMMITTEE:**

Function of Umpires Committee: There shall be an umpire committee of the Board of Directors composed of one 2 year umpire from each District and one alternate from each district. Two at-large umpires appointed by the 5 member committee. This committee selects its chairman. The two highest vote getters will serve as the 2-year representative and 1 alternate to serve on the Board of Directors of I.H.S.B.C.A.

All recommendations of the committee shall be reported in full to the Board of Directors. All transactions of the committee shall be reported to the Board and acted upon at the meeting or next regular meeting of the Board of Directors.

Elected committee members may serve 2 three year terms and then should drop off for 1 term. Appointed members are appointed for a 1-year term and may be reappointed at the wish of the committee chairman.

#### **DUTIES**

- 1/ Shall have the power to select one Hall of Fame member each year.
- 2/ Shall set up the Clinic for umpires. This shall be completed by November 15.
- 3/ Shall set up the process of nomination and selection of District Umpire of the year along with the Board of Directors.
- 4/ Shall serve as evaluators of the District nominees and State Umpire of the year along with the Board of Directors.
- 5/ Shall serve, plan, organize and implement program of information about Umpire of the Year.
- 6/ Obtain names of umpires who will serve on this committee from different districts.
- 7/ Complete reports from district on problems, possible solutions and changes.
- 8/ Shall make a written annual report of committee to the Board of Directors at the annual Clinic/Convention.
- 9/ Each District Representative is responsible for membership for the District.
- 10/ Other duties set out by the President.

#### **DUTIES FOR ALL-STAR GAMES**

- 1/ Umpires nominated for District Umpire of the Year are to be invited to work All-Star games. If not enough umpires from this source are available, the Chairman of Umpires Committee or his designate is to appoint other umpires to work.
2. Chairman of Umpires Committee or his designee makes assignments based upon responses from above.
3. Umpires who work All-Star games receive the following:
  - 1/ 2 tickets for banquet
  - 2/ \$30.00 cash to defray other expenses involved such as transportation and /or lodging.
  - 3/ Other mementos as deemed appropriate by Executive Secretary.
4. Each umpire who works will sign a waiver of injury form before working any games.

#### **LONGEVITY AWARDS FOR UMPIRES**

Awards to be presented:

- 10 Year Certificate of Service
- 15 Years, 20 Years, 25 Years , 30 Years of Service Plaques

Requirements for Above:

- 1/ must be an active umpire
- 2/ must have at least 3 consecutive years of membership of IHSBCA for certificate.

3. Must have a least 5 consecutive years of membership of IHSBCA for a plaque.
4. years as umpire to be certified by IHSAA

Further Stipulations:

1. Awards to be presented at banquet.
2. Umpires eligible for more than one award will be given the award for the longest number of years; however, he may purchase additional awards for earlier years.
3. Announcements of awards to be made in winter newsletter and umpires responses to be received by deadline as stated in newsletter.
4. All awards will be given on 5-year anniversary.

### **RATING POLL COMMITTEE:**

Function of Rating Poll Committee: There shall be a Rating Poll Committee of the Board of Directors. This Committee shall consist of the Directors from each district plus one at large member. All members must be a member of the Association.

#### **DUTIES**

- 1/ Shall set up the rating poll members by district.
- 2/ Shall send out material to committee members, to help evaluate the teams in their district. Such as cards, telephone #, key coaches and etc.
- 3/ Shall try to work through the Conference representatives as much as possible.
- 4/ Shall study needs of this committee and make recommendations to the Board of Directors.
- 5/ All transactions of the committee shall be reported to the board in writing and acted upon at the regular schedule meeting.

### **CLINIC COMMITTEE:**

Functions of Clinic Committee: There shall be a Clinic Committee of the Board of Directors, composed of the Executive Secretary, Umpire Chairman, President and College advisory.

The Executive Secretary will serve as chairman.

Recommendations of the committee shall be reported to the full Board of Directors, and acted upon at the next meeting of the Board of Directors.

#### **DUTIES**

- 1/ Shall set up and run the Annual clinic.
- 2/ Shall secure speakers for Annual clinic.
- 3/ Shall set up program for Annual clinic.
- 4/ Shall mail out press releases for Annual clinic.
- 5/ The site (city & school) will be selected by the Board of Directors after invitation has been tendered.
- 6/ The convention shall be scheduled at such a time, location at such a site and housed in such property which shall maximize convention attendance, administrative efficiency, organization independence, membership convenience and the association image and prestige.

### **CONSTITUTION COMMITTEE:**

Function of Constitution Committee: There shall be a constitution Committee of the Board of Directors, composed of two Board of Directors and other members appointed by the Chairman. The President shall appoint the chairman of this committee. They shall serve no more than two terms.

#### **DUTIES**

- 1/ They shall report any recommendations of the committee to the Board of Directors.

- a/ These recommendations shall then be voted by the Board and then sent out in the newsletter for action at the next regular meeting.
  - b/ They shall study the Constitution and By-Laws of the organization/ Association and continually up-date.
- 2/ If any Constitution changes are recommended they shall be put into proper language before submitting to vote of the Board of Directors.
  - 3/ They shall conduct annual Committee meeting prior to Clinic/ Convention meeting.
  - 4/ They shall make a written annual report of Committee to the Board of Directors.

**ALL DISTRICT COMMITTEE:**

Function of All-District Committee: There shall be an All-District Committee of the Board of Directors composed of two members of the Board of Directors and other members appointed by the Chairman. The chairman shall be appointed by the President.

They may not serve more than two terms on committee.

**DUTIES**

- 1/ Should develop and execute plans to review the All-District selection process.
- 2/ Make recommendations to the Board on problems, possible solutions and purpose changes.
- 3/ Serve as evaluators of All-District meetings and selection process.
- 4/ Make a written annual report of Committee to the Board.

**ALL STATE COACH COMMITTEE:**

Function of All-State Coach Committee: There shall be an All-State Coach Committee of the Board of Directors composed of two members from the Board of Directors and 3 appointed by the Chairman. The President shall appoint the chairman. They may not serve more than two terms.

**DUTIES**

- 1/ Evaluate the Association All-State Coach Awards program and recommend methods of improving the program.
- 2/ Make recommendations to improve the process of electing All-State Coach of the Year and District Coach of Year.
- 3/ Plan, organize, and implement program of information about All-State Coach to be announced in the newsletter.
- 4/ Make a written annual report of Committee to the Board of Directors at the February meeting.
- 5/ Serve as evaluators of District nominees and state coach of the Year along with the Board of Directors.
- 6/ Conduct an annual committee meeting prior to clinic/convention.
- 7/ Obtain names of coaches or who will serve on this committee from different districts.
- 8/ Complete reports from district on problems, possible solution and purpose changes.

**LANNY PETERSON ACADEMIC COMMITTEE:**

FUNCTION OF ACADEMIC COMMITTEE: To review and evaluate the process of choosing academic award winners and report to the Board any of their findings. Members of the committee shall serve at the request of the president until the end of each annual clinic/Convention or until their successor are appointed.

Committee chairman shall be the Vice-President, who shall call the committee together at the clinic/convention. This meeting should be held in the a.m. on Friday. The chairman shall report on their committees direction at the Thursday night meeting and

also at the general session.

They should call as many meetings as necessary in order to get the job done.

**DUTIES**

- 1/ Select the First Team and Honorable Mention All-Academic.
- 2/ Interview the candidates for the Lanny Peterson Award.
- 3/ Evaluate the criteria for selection of candidates.
- 4/ Report to the Board in writing an annual report of the Committee.
- 5/ If any changes shall be necessary, they should be in writing and presented to the Board at the next regular meeting.

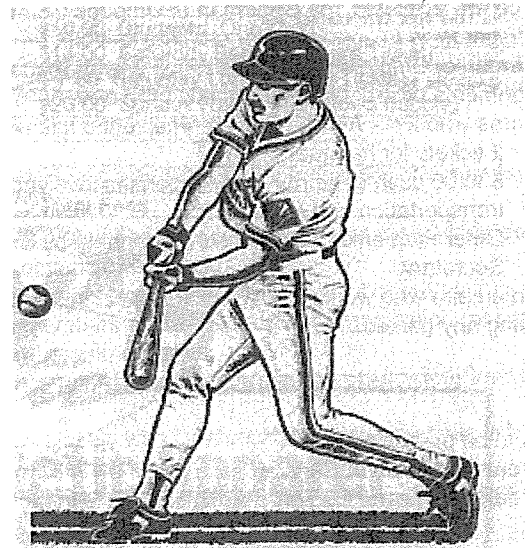
**AWARD COMMITTEE:**
