2000 32nd Annual Clinic: The Coaches Association announces the 32nd Annual Clinic, February 4-5-6, 2000, in Cedar Rapids at Washington High School and the University of Iowa on Sunday. The coaching clinics will begin at 1:05 p.m. on Friday, February 4, and will continue to 5:00 p.m. on Saturday. The Awards Banquet will be at the Crowne Plaza Five Seasons Hotel on Saturday evening, highlighted by the Hall of Fame and Coach and Umpire of the Year Awards. Sunday the Clinic will move to the Iowa Bubble in Iowa City.

The Steering Committee, Board of Directors and several other committees will be meeting prior to the start of the Clinic. They will meet Thursday, February 3. Check the committee meeting schedule for times.

We hope to have 20 exhibitors who will display all the latest in baseball equipment and coaching aids. This Clinic promises to uphold the tradition of the past clinics.

Eight Selected For '2000' Hall Of Fame: Four coaches, one umpire, two players and one contributor have been selected for induction into the I.H.S.B.C.A.'s Hall of Fame.

The eight inductees are: Jack Collum, Grinnell; Rick Davis, Boone; Robert Dougherty, Dunlap; Jim DeBlauw, Maple Valley; James Gebhart, Saydel; Tom Jenk, Jr., Dyersville; Dick McVay, Norway; Ev Petersen, Cedar Rapids.

The eight will be inducted at the Awards Banquet, Saturday, February 5, 2000, in Cedar Rapids. They will join 171 other Hall of Fame members.

JACK COLLUM graduated from Newburg High School in 1944. Beginning in 1947 he played pro-baseball for 17 years, nine years in the major leagues with the Cardinals, Reds, Cubs, Dodgers and Twins. He played with the Cards in 51-52 and 56. He played 3 years with the Cincinnati Reds before returning to the Cardinals. He had a 32-28 major league record as a pitcher. He played on the 1954 All-Star National League All Star team. He presently resides in Grinnell.

RICK DAVIS attended Boone High School graduating in 1966. He was a catcher for Hall of Fame Coach Bill Sapp. He attended Iowa State University, playing two years for the Cyclones. After a stint in Viet Nam, he played for several semi-pro teams. He began his coaching career as an Asst. Varsity Coach at Freeport, IL. He coached at Boone for 21 years. His teams record is 368 - 258, winning one sub-state title, two district titles and seven Conference titles. Rick conducts many youth baseball clinics in Boone and started the 1st Freshman baseball team at Boone. He has published baseball articles for the ABCA. He has been a District Representative for 5 years and Conference Rep for the past 5 years and has served on many committees. He has been inducted into two Hall of Fames in Boone. He has received the 25-year longevity award from IHSBCA and is a member of the 300 Win Club.

JAMES DeBLAUW coached for 25 years--23 years in Maple Valley and 2 years as Legion Coach in Crofton, NE. He coached American Legion ball for 13 years and was head coach at Maple Valley High School. His composite Legion-High School record is 676-200. In addition Jim coached volleyball for 11 years and golf for 8 years. Jim's Legion teams went to 8 state tournaments and earned State Youth Championships 3 times. In his work to organize baseball in Northwest Iowa, he was commissioner of the Northwest Baseball league for 9 years. Jim organized a Fellowship of Christian Athletes chapter at Maple Valley and in 1976 received the Governor's Award for his work in youth baseball. Jim is currently principal at Schuyler Grade School.

ROBERT DOUGHERTY graduated from Bedford High. He coached baseball for 33 years, most of them at Dunlap High, and has an overall record of 338-250. He had several players named to the All-State teams and played in the All-Star Series. A number of his players went on to play college baseball. He stressed being the "good guys" and absolutely to display class in all that they did. He has been an active member in the Association. He is a member of the 300 win club and has the 30-Year Longevity Award. Bob is retired, enjoying life, and doing some traveling.

JAMES GEBHART graduated from Xavier High School in Dyersville in 1963, lettering 4 years in baseball. He did his undergraduate work was at UNI where he played two years at 2B and graduated in 1968. His MS degree is from ISU in 1981. Jim has been the baseball coach at Saydel High School for 24 years winning one sub-state title, five district titles and six conference titles. Jim has been named Conference Coach of the Year five times and District Coach of the year three times. He is a 25-year member of the Coaches Association. Jim coached in the 1987, '94 and '98 All-Star Series, he has been a member of the Board of Directors and served on many committees. His field is used for many different baseball contest, since it is one of the better fields in central Iowa. Jim is the Athletic Director and Baseball Coach at Saydel High School in Des Moines.

TOM JENK JR. graduated from Beckman High School in Dyersville in 1971. At Beckman he played three years of baseball as an outfielder and catcher. Tom's undergraduate work was at Drake University. He has been the baseball coach at Beckman for 24 years with an over-all record of 543-266 record. His teams have won one State Championship, four Sub-State Titles and eleven District Titles, and have been Conference champs 13 of the last 20 years. Tom has hosted many tournaments at Beckman which include Legion, Babe Ruth, District and Sub-State games. Tom played semi-pro baseball and coached semi-pro baseball in Dyersville for many years. He has been a member of the Association for 24 years, belonging to the 500 Win Club, has received the 20-year longevity award and has coached in

three All-Star Series. He has served on many committees and has spoken at the clinic.

DICK McVAY graduated from Norway High School in 1968. At Norway, Dick had a career record of 69-3. Dick won 49 games in a row during one stretch. He won six state tournaments, had a 16-strikeout per 7 inning (average) and hit 3 homeruns in the state finals. He was All-Conference in '67 and '68 and All-State in 1968. He also played for the Cedar Rapids Legion Teams, Norway Town team and signed with the St. Louis Cardinals after his high school career. Honors include winning the State Legion batting average trophy in 1968. In the Minor Leagues, Dick had 5 shutouts and had a 3.2 ERA and his record was 24-8. His highest level of pro baseball was Triple A. Dick is working on his coaching endorsement and is helping with the Norway Pony League teams and plans to coach at an area high school.

EV PETERSEN graduated from Scranton High School in 1959, lettering in baseball, football and basketball. His undergraduate work was at Dana College, Blair, NE, lettering in football and baseball. Ev majored in Elementary and Phys Ed. He taught and coached at Jefferson Co. CO. and then moved to Kennedy High School. He got his Masters in Counseling and Guidance at the Univ. of Arizona in 1974. Ev started Umpiring baseball (25 yrs), basketball (25 yrs) and football (26 yrs) in 1974. He has umpired in many state tournaments as well as Sub-states and Districts. He has worked several All-Star Series since 1989 and has been named District Umpire and State Umpire of the Year. He has worked in many different leagues in eastern Iowa. Ev presently is a counselor at McKinley Middle School in Cedar Rapids.

CLINIC SPEAKERS:

HOWIE BEDELL has been involved in professional baseball for 45 years as a player, coach, manager, and member of front office management, and as a baseball consultant. He has three World Series rings from the Phillies, Royals and Reds. Bedell played professional baseball for 13 seasons as a member of the Milwaukee Braves, St. Louis Cardinals, Washington Senators, and Philadelphia Phillies organizations. He is known for ending Drysdale's scoreless inning streak, and also for being part of the Pottstown High School team that won 48 consecutive games from 1952-55. Howie has managed several Minor league teams and has worked as Director of Minor Leagues for the Philadelphia Phillies. Bedell is president of Chris', Inc., a company that represents sports-related industries and products development. He was Topps Minor League Player of the Month in 1961 and was nominated for National League Rookie of the year in 1962.

RICK HELLER is the UNI head baseball coach, and enters his 14th season as a Head Baseball Coach. Rick has spent the past 13 years as the Head Coach at Upper Iowa where he played his baseball and was an assistant coach at North Fayette High School before taking the head baseball position in Bakersfield, MO. In the past 13 years, Rick has won four Conference Championships and has gone on to the NCAA Central region three times. He was named Conference Coach of the Year four times. His 1999 team record was 30-15, with an over-all record of 291-193. He has been a member of the Association for thirteen years.



JOEL HOLST is entering his fifth season as Wartburg's head coach. In last three years he guided the Knights to the Iowa Conference championship and into the NCAA Division III Central Division. He has also been named the Iowa Conference Coach of the year the last three seasons. He has posted a career record at Wartburg of 123-59. Coach Holst served as head coach at Loras College for five seasons, where he amassed a 100-80 record and led the Duhawks to national rankings for the first time in school history. After graduating from Coe College in 1985 where he earned First Team All-Conference honors three straight years, Coach Holst spent four years as head coach at West Delaware. At West Delaware he was nominated District Coach of the Year three times, won a Wamac Conference and compiled a record of 100-50.



RON POLK is one of the winningest college baseball coaches in the country. Ron's over-all record at Mississippi State was 888-422. He is in the American Baseball Coaches Association Hall of Fame. He has taken many teams to the College World Series. Some current major league players who played for Ron are: Will Clark, Jeff Brantley, Rafael Palmeiro, Bobby Thigpen and Jay Powell. Ron has written one of the best practice books for new coaches, called the The Baseball Playbook. Ron has served as President of the ABCA and just finished the Head Coach position for the USA Baseball National Team. He currently serves as head baseball coach at the University of Georgia.



PAUL SUSCE comes to us with a strong baseball background. His father, George, was in the Major Leagues for 39 years. Brother, George, Jr., played with Boston and Detroit. Paul graduated from high school in Sarasota, FL, where he had an outstanding career. He pitched in high school and once struck out 27 men in one of these high school games. He attended Auburn Univ. on a baseball scholarship. He pitched varsity baseball for four years and made all-SEC pitcher in 1954-55-56 and MVP Player in 1956. He coached high school baseball in Sarasota, FL, Richmond, VA and Winter Park, FL. He was nominated for the NHSCA Coach of the Year by the AABC in 1974. In seventeen years of high school baseball coaching, Paul has sent 72 players to college on a baseball scholarship. Presently he heads Worth Sports Company National Promotion.



BOB SYMONDS is a former Cumberland High School star who has become a very successful baseball coach at Triton College, IL. He now ranks second on the all-time victories list among junior college coaches, having compiled a 1,178-360 mark in 29 seasons. Bob has never had a losing season at Triton. The Trojans have averaged over 40 wins during his coaching tenure and have topped 50 wins seven times. He has been named ABCA Coach of the Year and Region IV Coach of the Year 16 times. In 1990 and 1993, he was voted the Diamond/ABCA NJCAA Coach of the Year. In 1998 he was inducted into the Region IV Hall of Fame. He was also inducted in the JNCAA Baseball Hall of Fame. Bob had nineteen All-Americans who have played at Triton, including Lance Johnson, Jeff Reboulet and Kirby Puckett, while 100 Trojans have signed contracts with professional teams.



RICH SYMONDS, Bob's younger brother, also graduated from Cumberland High School and is in his 27th year as Head Baseball Coach at Oakton Community College. Prior to arriving at Oakton, Symonds coached one year at Western Illinois University. Symonds is a graduate of Wayne State College where he was named All-American. In 1987, he served at the U.S. Olympic Trials. Symonds also served as a trials coach in 1994 for the U.S. Olympic team. He is the past President of the NJCAA Baseball Coaches Association.



TRAVIS WYCKOFF is a new addition to the Iowa coaching staff. Travis will work with the Hawkeye hurlers. Wyckoff played baseball at Wichita State from 1993-96 as both pitcher and outfielder. He was named MVP in 1996 and was a first team All-America selection by Collegiate Baseball as a utility player. He was drafted by the Florida Marlins in 1996 and competed in their organization until 1998. Wyckoff received his bachelor's degree in General Studies from Wichita State in 1996.



LOU YACINICH is currently a professor, Athletic Director and head baseball coach at Grand View College in Des Moines. He attended Grand View and graduated from Drake University. He has been coaching for 36 years, eight at the high school level. During this time he has compiled a 786-573 record. His 1999 team record was 39-17, winning the Conference for the third year in a row. Lou is a charter member of the IHSBCA and a Hall of Fame member. Lou has been active in the NAIA in many levels. He hosted the NAIA World Series in 1992-93-94. He served on the rules committee and tournament procedures and Hall of Fame Committee. Lou has been District 15 Coach of Year 8 times and Area Coach of Year 4 times. Mid-West Classic Conference 3 years. He participated in three World Series. Lou has been named Midwest Region Coach of Year for 1999 and is up for the National Coach for 1999. The base of his program is the Iowa talent. his teams have a 97% graduation rate.



UMPIRE SPEAKERS:

DAVE HARTY is assistant Executive Secretary of the I.H.S.A.A. Dave has served the baseball program of Iowa for 30 years. He is a former high school coach and administrator. He is in charge of the baseball program in the state of Iowa and also in charge of the umpires. Dave has received the President's Award from the Association. He has served on the National Rules Body for 8 years.

1999 Baseball Player and Coach Ejection Report:

There were 112 player ejections in grades 7-12 during the 1999 baseball season. This is 15 less than in 1998. 7th grade-0; 8th grade-2; 9th grade-13; 10th grade-11; 9/10th grade-0; JV-16; and Varsity 70. Of these ejections: Throwing Equipment 22; Profanity 36; Unsportsmanlike Behavior 5; Malicious Contact 33; Talking Back to Umpire/Disputing Calls 13; Removing Helmet 2; Taunting 2; Roll Block Slide 1; On Deck W/Live Ball 1.

There were 18 coach ejections during the 1999 baseball season. 8th grade-0; 9th grade-4; 10th grade-0; JV-2; Varsity-12; Varsity Assistant-0. Reasons for ejections: Questioning/Arguing Calls 10; Verbal Misconduct 4; Lack of Control of Players in Dugout 1; Profanity 1; On Field Disputing Calls 3; Threw Ball Down by Umpire 1.

Questions frequently asked: (Repeat from 1999 letter)

1. How can I get involved with the Association? All that is necessary is to attend the clinic and all-star series. Volunteer to work or coach at the all-star series and/or at the clinic. Serve on committees!

2. How can I coach in the All-Star Series? Fill out the form in this newsletter and the Steering committee selects the All-Star coaches. They try to get a balance of coaches in each District, hoping to be able to cover the state. Your nomination form stays on file for two years.

3. How can I umpire in the All-Star games? An umpire in the All-Star Series must have been a member of the Association for at least three years. He must be nominated at the District meetings that are held in July. All the nominations from these meetings go to the Umpires committee, which meets at the All-Star site. The nominees are narrowed down to three to each district. The umpire chairman and committee will then select four additional umpires from the area to fill in the other four spots. Sixteen umpires are selected to work each year. If you are interested, you should fill out a nomination form that will be in the next newsletter. This forms will be forwarded to the Umpire committee chairman. All the umpires are selected by the Umpire's committee.

4. How can I get on the Board of Directors? All a coach or umpire must do is get nominated by fellow coaches or umpires. The nomination form is in the Sept.-Oct.-Nov. Newsletter. The nominees who receive the most votes go on the ballot. The one-year representative and alternate stay on the ballot, but must win the votes to go on the Board.

5. Who makes the committee assignments? The Vice-President (President-elect) always makes the committee assignments for the coming year. A coach may request a certain committee. The president-elect will try to spread the committee assignments around so all sections of the state are represented. The chairmen of the committees are usually Board of Directors.

6. How are the district nominees selected? The district nominees are selected in the July meetings. Any coach who takes his team to the State tournament becomes an automatic nominee. The coaches who are nominated in the July All-District meeting and the State tournament are then narrowed down to three for each class at the Fall meeting of the Board of Directors. The District Representatives (Two-Year, One-Year and 2-Year Umpire Reps) select the three nominees that go on the ballot. It is very important that a coach fills out the nomination form that is sent to him.

7. Who selects the officers? The steering committee, which is made up of dues-paying past presidents, selects the officers. The office of President moves around the state by each district. It is in this rotation: Northeast, West, Central, Southeast. The past president is chairman of the steering committee.

8. Who selects the award winners? The award winners are all selected by the Board of Directors. The Hall of Fame is selected by the Hall of Fame committee. All Hall of Fame nominations go to the Hall of Fame committee. This committee is made up of Hall of Fame members of the Board of Directors, Steering Committee and Hall of Famers.

9. Who selects the President's Award? The Board of Directors upon the recommendation of the Executive Secretary.

10. Who selects the Bill & Sheery Freese Award? The Board of Directors upon the recommendation of the Executive Secretary.

11. Who selects the Harold "Pinky" Primrose Award? The Board of Directors upon the recommendation of the Executive Secretary.

12. Who selects the District Media and Contributors Winners? The District chairman of the district with the help of the other representatives select the winners at the Fall meeting.

13. How can a coach or umpire speak at the Annual Clinic? Very easy. Volunteer, give the Clinic chairman your topic, expertise and topic. That committee meets in November and puts the clinic together with the speakers.

14. How can I get my good ball player on the All-Star Team? All you have to do is fill out the profile form in the newsletter and submit to the Executive Secretary. The forms are then forwarded to the Head Coach of each team. The coaching staff then selects the team that they feel can win the Series. They also must have a balance on their team; not everyone can play shortstop. After you submit the form, please let the coaches know that your player has been doing the job for you all year. Make sure you try to get the player exposure. Have other coaches recommend him.

If you have questions that you want answered, please forward them to the Executive Secretary or President of the Association. This is your organization; it needs you and you need it in order to get better and improve. Our business is to help improve high school baseball in the state of Iowa and also honor the coaches and players each year who have done an outstanding job in their district.







Rick Davis of Boone tells us that Nate Hilton of Boone signed with the Oakland A's. Rick's won-lost record is 382-295.



COMMITTEE DUTIES:

ALL STAR COMMITTEE:

Function of Committee: There shall be an All-Star Committee of the Board of Directors composed of 2 members of the Board and other members appointed by the President. The President will appoint the Chairman.

DUTIES:

1. Shall serve as evaluators of the All-Star Series along with the Board of Directors.
2. Shall recommend to the Board of Directors any changes, and possible solutions to problems.
3. Shall secure advertising for series program.
4. Shall help in running the day to day operation of All-Star Series. 1/ Gate keepers 2/ Foul ball chasers 3/ Program sellers 4/ Field maintenance 5/ PA announcer 6/ Score keeper
5. Shall secure a printer of the All-Star Program.
6. Shall secure a photographer for taking All-Star team pictures.
7. Shall help processing the players upon arrival.
8. Shall help in transportation to ball park.
9. Shall help in securing equipment.
10. Shall help in noon lunches at park.

Executive Secretary's Responsibility at All-Star Series:

1. Shall send out material to All-Star Coaches prior to All-Star series. Time for this should be right after the All-District picks. Material: a/ Medical Form b/ Insurance releases c/ Other information necessary for running series.
2. Shall handle all monies from the a/ program b/ tickets sales c/ banquet d/ sponsors e/ etc.
3. Will be in charge of the Games---Times--Setting up Tournament---Umpires
4. Overseer of Banquet, Picnic, Total operation
5. Shall instruct the coaches about duties of all-star series and rules to live by.
7. Shall secure housing--food & etc.

President's responsibility:

1. Evaluate series 2/ Hand out medals 3/ Help in any area necessary.

HALL OF FAME COMMITTEE:

Function of Committee: There shall be a Hall of Fame Committee of the Board of Directors composed of present Hall of Fame members and two MEMBERS OF THE BOARD, appointed by the President. The President will appoint the Chairman.

DUTIES

1. Shall have the power to select Hall of Fame members each year.
2. Shall set up the selection process for other Hall of Fame members.
3. Shall set up a meeting of the Hall of Fame members at the annual clinic meeting for the selection and discussion of future Hall of Fame members.
4. Shall send out a note to present Hall of Fame members to encourage them to continue to be active in the Association.
5. Shall present to Board of Directors in their October meeting the Hall of Fame members for the up-coming year.
6. Shall recommend after evaluation of the Hall of Fame Award methods to improve the program of the Hall of Fame induction.

Executive Secretary Responsibility:

1. Shall send out ballots of the nominees to the Hall of Fame member (dues paying).

STEERING COMMITTEE:

Function of Committee: There shall be a Steering Committee of the Board of Directors, composed of the Past Presidents. The past immediate president will serve as chairman.

All recommendations of the Committee shall be reported in full to the Board of Directors. All transactions of the Committee shall be reported to the Board and acted upon the next regular meeting of the Board of Directors.

The Steering committee shall have two meetings annually.

DUTIES:

1. Shall have the power to select the All-Star coaching staff.
2. Shall be the nominating committee.
3. Shall study long-range needs of the Association and make recommendations to the Board.
4. Shall serve as a screening committee, arrange interview and make recommendations to the Board of Directors in the selection of the Executive Secretary.
5. Shall serve the President in any capacity deemed necessary by the President
6. Shall evaluate the Executive Secretary's work annually.

AUDITING COMMITTEE:

Function of Committee: There shall be an Auditing Committee of the Board of Directors. The Committee shall consist of 1 member of the Board and the Treasurer, with other members appointed by the President. The President will appoint the Chairman.

All Recommendations of the Committee shall be in full to the Board of Directors. All transactions of the Committee shall be reported to the Board for action upon.

DUTIES

1. They shall serve no more than two terms.
2. They shall complete the audit by the Annual Convention Clinic meeting of the total membership.
3. They shall report their findings to the membership.
4. They shall give a written report of their findings to the Secretary to be recorded in the minutes.
5. They shall visit with the accountant of the organization and recommend changes that are necessary with Board approval.

MEMBERSHIP COMMITTEE:

Function of Membership Committee: The committee shall consist of the two-year voted members of the Board of Directors from each district. The President will appoint the Chairman.

DUTIES

1. Shall develop and execute plans for increasing the membership of the Association.
2. Membership shall be chosen to represent the various geographic sections of the state.
3. It will devise ways and means of cooperation with Umpires in securing members and in methods of organization for making such membership effective.
4. Such action shall be subject to the approval of the Board of Directors.
5. Shall work closely with Conference Representatives in their respective Districts.
6. Shall work to get 100% membership in each conference in the State.
7. Shall make a written annual report to the Board.

UMPIRES COMMITTEE:

Function of Umpires Committee: There shall be an umpire committee of the Board of Directors composed of one 2 year umpire from each District and one alternate from each district. Two at-large umpires appointed by the 5 member committee. This committee selects its chairman. The two highest vote getters will serve as the 2-year representative and 1 alternate to serve on the Board of Directors of I.H.S.B.C.A.

All recommendations of the committee shall be reported in full to the Board of Directors. All transactions of the committee shall be reported to the Board and acted upon at the meeting or next regular meeting of the Board of Directors.

Elected committee members may serve 2 three year terms and then should drop off for 1 term. Appointed members are appointed for a 1-year term and may be reappointed at the wish of the committee chairman.

DUTIES

1. Shall have the power to select one Hall of Fame member each year.
2. Shall set up the Clinic for umpires. This shall be completed by November 15.
3. Shall set up the process of nomination and selection of District Umpire of the year along with the Board of Directors.
4. Shall serve as evaluators of the District nominees and State Umpire of the year along with the Board of Directors.
5. Shall serve, plan, organize and implement program of information about Umpire of the Year.
6. Obtain names of umpires who will serve on this committee from different districts.
7. Complete reports from district on problems, possible solutions and changes.
8. Shall make a written annual report of committee to the Board of Directors at the annual Clinic/Convention.
9. Each District Representative is responsible for membership for the District.
10. Other duties set out by the President.

DUTIES FOR ALL-STAR GAMES

1. Umpires nominated for District Umpire of the Year are to be invited to work All-Star games. If not enough umpires from this source are available, the Chairman of Umpires Committee or his designate is to appoint other umpires to work.
2. Chairman of Umpires Committee or his designee makes assignments based upon responses from above.
3. Umpires who work All-Star games receive the following:
 1. 2 tickets for banquet
 2. \$30.00 cash to defray other expenses involved such as transportation and /or lodging.
 3. Other momentos as deemed appropriate by Executive Secretary.
4. Each umpire who works will sign a waiver of injury form before working any games.

LONGEVITY AWARDS FOR UMPIRES

Awards to be presented:

- 10 Year Certificate of Service
- 15 Years, 20 Years, 25 Years , 30 Years of Service Plaques

Requirements for Above:

1. must be an active umpire
2. must have at least 3 consecutive years of membership of IHSBCA for certificate.

3. Must have a least 5 consecutive years of membership of IHSBCA for a plaque.
4. years as umpire to be certified by IHSAA

Further Stipulations:

1. Awards to be presented at banquet.
2. Umpires eligible for more than one award will be given the award for the longest number of years; however, he may purchase additional awards for earlier years.
3. Announcements of awards to be made in winter newsletter and umpires responses to be received by deadline as stated in newsletter.
4. All awards will be given on 5-year anniversary.

RATING POLL COMMITTEE:

Function of Rating Poll Committee: There shall be a Rating Poll Committee of the Board of Directors. This Committee shall consist of the Directors from each district plus one at large member. All members must be a member of the Association.

DUTIES

1. Shall set up the rating poll members by district.
2. Shall send out material to committee members, to help evaluate the teams in their district. Such as cards, telephone #, key coaches and etc.
3. Shall try to work through the Conference representatives as much as possible.
4. Shall study needs of this committee and make recommendations to the Board of Directors.
5. All transactions of the committee shall be reported to the board in writing and acted upon at the regular schedule meeting.

CLINIC COMMITTEE:

Functions of Clinic Committee: There shall be a Clinic Committee of the Board of Directors, composed of the Executive Secretary, Umpire Chairman, President and College advisory.

The Executive Secretary will serve as chairman.

Recommendations of the committee shall be reported to the full Board of Directors, and acted upon at the next meeting of the Board of Directors.

DUTIES

1. Shall set up and run the Annual clinic.
2. Shall secure speakers for Annual clinic.
3. Shall set up program for Annual clinic.
4. Shall mail out press releases for Annual clinic.
5. The site (city & school) will be selected by the Board of Directors after invitation has been tendered.
6. The convention shall be scheduled at such a time, location at such a site and housed in such property which shall maximize convention attendance, administrative efficiency, organization independence, membership convenience and the association image and prestige.

CONSTITUTION COMMITTEE:

Function of Constitution Committee: There shall be a constitution Committee of the Board of Directors, composed of two Board of Directors and other members appointed by the Chairman. The President shall appoint the chairman of this committee. They shall serve no more than two terms.

DUTIES

1. They shall report any recommendations of the committee to the Board of Directors.

- a/ These recommendations shall then be voted by the Board and then sent out in the newsletter for action at the next regular meeting.
 - b/ They shall study the Constitution and By-Laws of the organization/ Association and continually up-date.
- 2/ If any Constitution changes are recommended they shall be put into proper language before submitting to vote of the Board of Directors.
 - 3/ They shall conduct annual Committee meeting prior to Clinic/ Convention meeting.
 - 4/ They shall make a written annual report of Committee to the Board of Directors.

ALL DISTRICT COMMITTEE:

Function of All-District Committee: There shall be an All-District Committee of the Board of Directors composed of two members of the Board of Directors and other members appointed by the Chairman. The chairman shall be appointed by the President.

They may not serve more than two terms on committee.

DUTIES

- 1/ Should develop and execute plans to review the All-District selection process.
- 2/ Make recommendations to the Board on problems, possible solutions and purpose changes.
- 3/ Serve as evaluators of All-District meetings and selection process.
- 4/ Make a written annual report of Committee to the Board.

ALL STATE COACH COMMITTEE:

Function of All-State Coach Committee: There shall be an All-State Coach Committee of the Board of Directors composed of two members from the Board of Directors and 3 appointed by the Chairman. The President shall appoint the chairman. They may not serve more than two terms.

DUTIES

- 1/ Evaluate the Association All-State Coach Awards program and recommend methods of improving the program.
- 2/ Make recommendations to improve the process of electing All-State Coach of the Year and District Coach of Year.
- 3/ Plan, organize, and implement program of information about All-State Coach to be announced in the newsletter.
- 4/ Make a written annual report of Committee to the Board of Directors at the February meeting.
- 5/ Serve as evaluators of District nominees and state coach of the Year along with the Board of Directors.
- 6/ Conduct an annual committee meeting prior to clinic/convention.
- 7/ Obtain names of coaches or who will serve on this committee from different districts.
- 8/ Complete reports from district on problems, possible solution and purpose changes.

LANNY PETERSON ACADEMIC COMMITTEE:

FUNCTION OF ACADEMIC COMMITTEE: To review and evaluate the process of choosing academic award winners and report to the Board any of their findings. Members of the committee shall serve at the request of the president until the end of each annual clinic/Convention or until their successor are appointed.

Committee chairman shall be the Vice-President, who shall call the committee together at the clinic/convention. This meeting should be held in the a.m. on Friday. The chairman shall report on their committees direction at the Thursday night meeting and

also at the general session.

They should call as many meetings as necessary in order to get the job done.

DUTIES

- 1/ Select the First Team and Honorable Mention All-Academic.
- 2/ Interview the candidates for the Lanny Peterson Award.
- 3/ Evaluate the criteria for selection of candidates.
- 4/ Report to the Board in writing an annual report of the Committee.
- 5/ If any changes shall be necessary, they should be in writing and presented to the Board at the next regular meeting.

AWARD COMMITTEE:

Function of the Awards Committee: There shall be an Awards Committee of the Board of Directors, composed of two members of the Board of Directors and other members appointed by the Chairman. The Chairman shall be appointed by the President.

DUTIES

- 1/ To evaluate all awards presented by Association.
- 2/ To evaluate a named award after 5 years, and recommend to the Board to continue the name or change the name of the award.
- 3/ Shall make a written annual report of the Committee to the Board of Directors.
- 4/ These recommendations shall then be voted upon by the Board of Directors.

The Association needs good committee workers. If you are interested in serving on a committee, please contact the Vice-President of the Association, who makes all committee assignments.

CRITERIA: Winner of District Coach of the Year
Selected by ballot of All State Committee, District Board of Directors and Steering Committee members.

DISTRICT UMPIRE OF THE YEAR: (Four districts)

CRITERIA: Four association member umpires are selected at each district meeting by association coaches. Umpires' All District Committee selects three umpires for the final ballot. Ballots are sent to all association members with the top vote getter in each district the winner.

STATE UMPIRE OF THE YEAR:

CRITERIA: Winner of District Umpire of the Year
Selected by ballot of All State Umpire Committee, District Board of Directors and Steering Committee members.

IOWA COLLEGE COACH OF THE YEAR:

CRITERIA: Nominated by association coaches at district meetings.

Selected by vote of District Board of Directors and Steering Committee members.

100-200-300-400-500 CAREER VICTORIES:

CRITERIA: Any association member who has the required number of varsity coaching victories may submit his name for recognition. 100 through 400 are certificates—500 and above receive a plaque.

MEDIA AWARD: (Two awards are given—print & electronic))

CRITERIA: Nominated by association coaches at district meetings.

Have helped promote high school baseball in their area. Selected by vote of District Board of Directors and Steering Committee members.
