**Six Selected For '2004' Hall Of Fame:** Three coaches, one umpire and two players have been selected for induction into the I.H.S.B.C.A.'s Hall of Fame.

The six inductees are: Denny Barton, Urbandale; Randy Bruns, Waverly; Brad Clement, Marshalltown; Dean Corson, Rockwell City; Glen Drahn, Belle Plaine; Steve Westphal, Lenox.

The six will be inducted at the Awards Banquet, Saturday, February 7, 2004, in Cedar Rapids. They will join 190 other Hall of Fame members.

**DENNY BARTON** has been coaching for 20 years at Urbandale High School. He has an overall record of 508-255. Denny went to North Polk High School where he played baseball for four years. He entered Simpson College in 1971 and transferred to Drake University in 1972. He played two years at Drake as an outfielder and catcher. He played 21 years of semi-pro baseball after graduating from high school. Denny has been a very successful baseball coach at Urbandale, being the State Coach of Year in 2000 and District Coach of Year twice. He is a member of the 500-Win

Club and has the 20-Year Longevity Award. His teams won one State Championship and came in second twice. He has coached in two All-Star Series. He has served on the Board of Directors of the Association and on many committies. 53 of his players have played in Division I baseball, 18 in Professional and 5 in the Major Leagues.

RANDY BRUNS has been umpiring at all levels. Prior to his high school and college umpiring, Randy worked in the professional leagues for 12 years. He has averaged between 60 and 65 games a year for 25 years. He has worked two All-Star Series. Randy has been a member of the Association for 20 years. He has worked in many state tournaments. He has been a presenter at the Clinic several times. He is regarded as one of the best umpires in eastern lowa. Prior to umpiring, Randy coached baseball at Waverly High School, where he graduated in 1965.

BRAD CLEMENT played high school baseball at Newton High, graduating in 1971. He was a 4-year letterwinner as a catcher. He went to Mesa Community College and played from 1971-73. He was a head high school coach at Marshalltown for 14 years (1980-93). At Marshalltown his teams won three State Championship titles, Five Districts. His over-all record was 319-191. Brad has been active in community baseball for many years, conducting clinics and has spoken at the State Clinic. He was very active in the Coaches Association, chairing and serving on various committees, and has also served on the Board of Directors. He was the IHSBCA Coach of Year twice (1985 & 86). He also coached the Marshaltown team in the 1996 Little League World Series. Presently he is a school administrator at Marshalltown School System.

**DEAN CORSON** played high school baseball at Rockwell City, graduating in 1942. After graduating he went into the service until 1945 serving in the North Africa and European theaters. He went on to Upper Iowa University and played for the late Doc Dorman. He pitched and played outfield and was a .300 plus hitter and a 24-4 record in pitching. Dean played semi-pro for several town teams in Iowa. He worked for Garst and Thomas Seed Company in Coon Rapids where he was very active in the community. He presently resides in Bella Vista, AR.

GLENN DRAHN was an outstanding player at Elkader High and the University of Iowa. He played many years in semi-pro baseball in Eastern Iowa. At the University, Glenn was a pitcher and outfielder. He played on the championship team in 1949. Glenn held the record for scoreless innings pitched of 29 2/3 until Mike Boddicker broke the record. After college, Glenn played for numerous semi-pro teams, Marengo, Elkader Vets, Estherville Pride, Williamsburg, Belle Plaine, Urbana, and the M & J League in Cedar Rapids. He coached 3 years at Belle Plaine and 3 years at Coe College before he became the AD of Coe. In high school, he played on two championship teams. He has been very much involved in baseball outside his coaching, he ran the Little League, Pee Wee League, Legion teams in Belle Plaine. He set up Little League and Pee Wee tournaments. Presently, Glenn lives in Belle Plaine and runs Drahn Insurance Company.

STEVE WESTPHAL graduated from Midland High School in 1973 and played varsity baseball as a pitcher and catcher for three years. He went to Buena Vista College and caught for three years. Steve then went into coaching where he has spent twenty-three years in Lenox. As a coach his teams won 515 and lost 399. He won the Sub-State Championships four times and eight District titles. Steve is an active member of the Coaches Association in his 20 plus years of coaching. He is a Board Member, chaired many committee meetings and spoke at the many clinics in and out of lowa. He coached in three All-Star

Series. He was named State Coach of Year in 1989 and Distirct Coach of Year three times. Steve is still an active coach at Lenox.

# 2003 Baseball Player and Coach Ejection Report:


There were 86 player ejections in grades 7-12 during the 2003 baseball season. This is 18 less than in 2002. 7th grade-1; 8th grade-1; 9th grade-7; 10th grade-10; JV-13; and Varsity-54. Of these ejections: Throwing Equipment 7; Profanity 23; Unsportsman-like Behavior 24; Malicious Contact 32; Talking Back to Umpire/Disputing Calls 15.

There were 23 coach ejections during the 2003 baseball season. 7th grade-0; 8th grade-1; 9th grade-0; 10th grade-4; JV-1; Varsity-17; Varsity Assistant-0. Reasons for ejections: Questioning/Arguing Calls 15; Profanity/Arguing 8.

JACK DAHM, former Head Coach at Creighton and now the



University of Iowa new Head Coach. He coached at Creighton from 1989 until 2003. At Creighton he became the Head Coach in 1993. He has been very active on many Committees of the ABCA, NCAA and the College World Series, Inc. Jack is the winningest coach in Creighton Baseball history. Missouri Valley Conference Coach of Year twice and won NCAA Regionals in 1999 and 2000.

Jack has presented my clinics in western lowa.

# STEVE EDDIE is beginning his fourth season as the Head



Baseball Coach at Buena Vista University. In his three completed seasons as a coach, Eddie has already garnered the Iowa Conference Coach of the Year award (2002) after his team finished with a 24-14 record and tied for second place. Eddie graduated from Albert City-Truesdale. He received First Team All-Conference awards four times and

was named First Team All-State. He attended the University of lowa, playing shortstop. He signed with the White Sox and reached Triple A with both the Sox and Cincinnati Reds. He appeared in more than 700 minor league games.

RICK HELLER enters his 17th season as the Head Baseball Coach at



the college level, presently his fourth year at University of Northern Iowa. A graudate of Upper Iowa University in 1986, Heller is the only Upper Iowa athlete to letter in three sports in the same year since 1961. Prior to arriving at UNI he spent 14 years at Upper Iowa. Rick's over-all record is 407-304. Six players have been drafted by Major League Baseball. He was an assistant baseball coach at North Fayette before taking the head

baseball position in Bakersfield, MO. He returned to Upper Iowa as head coach in 1987. In the past 16 years, Rick has won four Conference Championships and has gone on to the NCAA Central region three times, and the College World Series two years ago. He has been a member of the Association for 18 years.

### RICK MATHEWS was a former high school coach at Eddyville and



Marshalltown and then moved on to lowa Western C.C. From there he became the K.C. Royals minor league field coordinator and pitching coordinator. He is presently with the Colorado Rockies as the bull-pen coach. Rick holds many clinics for young pitchers and catchers throughout the state. Rick is a member of the IHSBCA Hall of Fame. He spoke in the 1999 and 2001 clinics. He returns by popular request.

ED SERVAIS head baseball coach at Creighton, succeeded Jack



Dahm. Ed will be entering his seventh season at Creighton. His previous head coaching experience was at Rib Lake, WI high school, St. Mary's University (Winona, MN) as an assistant, before coming the head coach at St. Mary's. He moved or to Viterbo College in LaCrosse, WI where he compiled a record of 23-6 in his one year before returning to St. Mary's as head. coach. From St. Mary's he became the Assistant Coach at Iowa State University for two years. He moved on to Creighton

University in 1997, where he was an Assistant Coach to Jack Dahm. Ed's over-all record as head coach was 182-82 and was named the Minnesota Intercollegiate Athletic Conference "Coach of Year". Many of his student-athletes went on to play pro ball.

# NICK ZUMSANDE comes to the Univ. of Iowa as pitching coach.



Nick has been a coach for the past 18 years. He spent 15 seasons at Muscatine Community College, 12 as head coach. Nick moved from Muscatine to Iowa State Univ. and then to Indiana State for two years. Nick pitched at Norway and Iowa State. As a head coach, Nick compiled an over-all record of 431-196. While at Muscatine, many of his players went on to Division I baseball and many signed a pro contract.

DAVE HARTY is a native of Iowa Falls and a graduate of Iowa State



University. Dave coached baseball, football and wrestling at Postville and Eagle Grove. He became a school administrator at Eagle Grove and formely served as the Assistant Executive Director of the I.H.S.A.A. He was in charge of the lowa High School Baseball Program for 32 years. He has given many State baseball rules meetings and is an interpreter of the rules for the state of lowa. He has served on the Clinic staff for many years. Dave is in

the Hall of Fame. The "Umpire Newcomer of the Year" is named after Dave. Dave has served on the National rules committee three different times for a total of 12 years.

KIRK LEVINE comes to us with many years of umpiring. He went to Al



Somers Umpiring School and then into professional baseball. He spent six years in the minor leagues, working the Pacific Coast League and the Championship Series. Kirk works many college games throughout Iowa and the Big Twelve, Missouri Valley. Kirk has worked six Division I Regional tournaments. He has umpired for 25 years. The minutes from the February 2003 meeting that were published in the newsletter were approved. Gary Paulsen made the motion to approve the minutes, while Steve Westphal seconded the motion. All were in favor.

Pinky gave the financial report. Handouts were given to all in attendance. Motion was made to approve the financial report by Charlie Stumpff. Seconded by Dick Core. All were in favor.

Pinky introduced the new lowa Baseball Coach, Jack Dahm. A special "Thanks" to Jack and the University of lowa for allowing us to continue to hold the meeting in lowa City and attend the football game. Pinky reviewed the policy and procedure used towards issuing tickets for the lowa football game. Pinky made mention of the progress being made towards scheduling speakers/clinicians for the February clinic in Cedar Rapids. He reminded all of the importance to complete the all-district coaches and umpire selections right after the regular meeting ends in a timely manner. Pinky commented on the success of the All-Star Series in Council Bluffs last August. Many positive letters were received from parents, players, and fans in appreciation of the event. Jim reported on a workshop being offered by the lowa Athletic Council and Drake University promoting sportsmanship and character education building for our high school athletes. It was decided to see if Dave Harty would be willing to meet in February at the clinic with a small group of 4A coaches to discuss this issue and see if any options could be explored. The issue of seeding teams in 4A tournaments is still a concern.

Charlie Stumpff gave the Select Committee report. The select junior team that had previously participated in a Chicago Tournament after the regular baseball season for two years has faded away. Due to a lack of support, this topic will be discontinued.

Pinky followed with the communications portion of the agenda. Pinky made mention of the letters received from many players, parents, and fans towards their positive experiences with the all-star series. One negative letter from a parent was received in regards to the Academic All-State Team Award. Pinky would like to see the academic players get their bios read at the all-star series banquet, as we do the individual players when they are introduced with their teams.

Pinky apologized to the association for his letter to Boone in regards to a proposal asking that Cedar Rapids be considered towards hosting future state tournaments. Pinky stated he has been in communication with Bernie Saggau at the IHSAA about the situation. Pinky commented that his letter should have been a personal letter to Boone rather than an association letter in support of a state tournament site change. This issue is now behind us, we need to move forward – Jim Gebhart.

There was no new business submitted. Meeting was adjourned to District Meetings.
