**Six Selected For '2005' Hall Of Fame:** Three coaches, one umpire and two players have been selected for induction into the I.H.S.B.C.A.'s Hall of Fame.

The six inductees are: Ray Antisdel, Wilton; Gary Christiansen, Mason City; Phil Lebo, Grundy Center; Robert "Pinky" Primrose (D), Norway; Steven Stumpff, Norway; Lee Toole, Council Bluffs.

The six will be inducted at the Awards Banquet, Saturday, February 5, 2005, in Cedar Rapids. They will join 196 other Hall of Fame members.

RAY ANTISDEL coached for 25 years at Wilton High School. He has an overall record of 407-302. Ray went to Cromwell and Creston High Schools where he played baseball as a catcher for four years. He entered University of Iowa in 1964. Ray has been a very successful baseball coach at Wilton, was the State Coach of Year in 1993 and District Coach of Year three times. He is a member of the 400-Win Club and has the 25-Year Longevity Award. His teams won one State Championship in 1993. His teams were in four State Tournaments and won five Conference

Championships. He has coached in two All-Star Series. He has served on the Board of Directors of the Association and on many committees. Ray retired from coaching in 1998. Ray has two adult daughters and lives with his wife, Shari, in Wilton.

GARY CHRISTIANSEN has been umpiring for 35 years at the high school and college level. He worked in North Iowa, CIML, Northeast Iowa, Corn Bowl and North Central Leagues. He has averaged between 60 and 65 games a year for 35 years. He has worked three All-Star Series. Gary has been a member of the Association for 20 years. He has worked in many state tournaments. He has been a presenter of the rules throughout the state for the past 13 years. He is regarded as one of the best umpires in eastern Iowa. He has won several awards, including induction into the IHSAA Officials Hall of Fame and the Girls High School Coaches Hall of Fame, Girls Basketball Official of the Year, Boys Basketball Official of the Year and Football Official of the Year and Baseball Umpire of the Year. Gary teaches at NIACC Community College. He is married to Colleen and has two adult children.

PHIL LEBO graduated from United Community High School in 1967 and played varsity baseball as a catcher for three years. He went to Morningside College and caught for three years. Phil then went into coaching where he has spent twenty-five years coaching—the last 21 in Grundy Center. His teams won 264 and lost 261. He won the Sub-State Championships and 2 District titles. Phil has been an active member of the Coaches Association in his 26 plus years of coaching. He is a Board Member, chaired many committee meetings and has gone through the Chairs of the Association. He presently is serving on the Steering Committee. He coached in three All-Star Series. He is a member of the 200-Win Club and has the 25-Longevity Award. Phil is still an active coach at Grundy Center. Phil is married to Nancy and has two adult children.

ROBERT "PINKY" PRIMROSE played his high school baseball at Norway High, graduating in 1946. He was a 4-year letterwinner as an infielder, pitcher and catcher. He went to University of Iowa on a baseball scholarship and played from 1948-50. He was an All-Big Ten player in 1950. The 1949 Hawkeyes won the Big Ten Baseball title. He played semi-pro baseball in eastern Iowa for Amana Freezers, Iowa Manufacturing Co., Norway town team and Lake View-Wall Lake in the Iowa State League. He had a Boston Red Sox offer but chose to enter the United States Air Force as a commissioned officer. He flew 105 ground support missions in Korea and ended his flying career flying the U-2 spy plane. He died in a U-2 plane accident in 1964 leaving four children and wife, Skip. They presently live in Pennsylvania.

STEVEN STUMPFF played his high school baseball at Norway High School, graduating in 1972. As a player for Norway High he hit for an average .386, with 63 doubles, 13 triples and homeruns. He played on the Cedar Rapids Legion teams in 1971 and 1972, finishing 2nd in the nation in 1971. He was the MVP in the State Legion Tournament in 1972. After graduating he went to the University of Iowa, playing for four years as a first baseman and pitcher. At the University Steve was All-Big Ten twice as a first baseman. He signed a minor league contract with the San Francisco Giants and played in Great Falls, MT for one year. Steven played semi-pro for Norway and Walford town teams. He presently is a counselor at Prairie High School and coaches in the Girls Varsity Basketball program. He is married to Kim and has 4 adult children.

**LEE TOOLE** graduated from Mason City High School in 1977 where he played varsity baseball his junior and senior years as an Outfielder. He attended NIACC and then transferred to Northern

lowa University graduating in 1985. He started his coaching career at New Hartford High and then moved to Thomas Jefferson High in Council Bluffs where his team was the Class 4A State Champion in 1993. He presently coaches at Lewis Central High. His over-all record is 519-266. His teams have participated in five State Tournments, also winning 4 District and five Conference Championships. He has been a member of the IHS-BCA for 24 years. He has coached in three All-Star Series and has served as Chairman of the Rating Poll committee for many years. He is presently 2nd Vice-President of the Association going throught the Chairs. He is a member of the 20-Year Longevity Award and 500-Win Club. He was District Coach of Year seven times and State Coach of the Year in 1993. He was named NHSBCA District 5 Coach of the year in '93. He has hosted three All-Star Series in Council Bluffs area. He is married to Jeanine and has three children.

### 2004 Baseball Player and Coach Ejection Report:


There were 80 player ejections in grades 7-12 during the 2004 baseball season. This is 6 less than in 2003. 9th grade-9; 10th grade-12; JV-11; and Varsity--45. Of these ejections: Throwing Equipment 2; Unsportsmanlike Behavior 38; Malicious Contact 40; Threw Equipment (Bat) 2.

There were 19 coach ejections during the 2004 baseball season. 7th grade-0; 8th grade-0; 9th grade-2; 10th grade-2; JV-2; Varsity-13; Varsity Assistant-0.

#### CLINIC SPEAKERS:



**HOWIE BEDELL** has been involved in professional baseball for 48 years as a player, coach, manager and member of front office management, and as a baseball consultant. He has three World Series rings from the Phillies, Royals and Reds. Bedell played professional baseball for 13 seasons as a member of the Braves, Cardinals, Senators, Phillies organizations. He is known for ending Drysdale's scoreless inning streak and being part of the Pottstown High School team that won 48 consecutive games from 1952-55. Howie has managed several Minor

league teams and has worked as Director of Minor Leagues for the Phillies. Bedell is president of Chris', Inc. a company that represents sports-related industries and products development. He was Topps Minor League Player of the Month in 1961 and nominated for national League Rookie of the year in 1962.



BOB BENNETT has coached 45 years with 34 at Fresno State having recorded 1299 wins and 756 losses. He is the 8th winningest coach in NCAA Division I history and ranks 4th of all Division I active coaches in wins. During his tenure, Fresno State won 17 championships, 211 regional appearances, and 2 College World Series appearances. Bennett was named Sporting News Coach of the Year in 1988.

He was a 1992 ABCA Hall of Fame honoree and the recipient of the coveted ABCA Lefty Gomez award in 2000. He was the 1987 President of the ABCA and currently serves on the Board of Directors as well as the Standing Committee.

JACK DAHM, former Head Coach at Creighton, is now the University



of Iowa Head Coach. He coached at Creighton from 1989 until 2003. At Creighton he became the Head Coach in 1993. He has been very active on many committees of the ABCA, NCAA and the College World Series. Jack is the winningest coach in Creighton Baseball history--Missouri Valley Conference Coach of Year twice and won NCAA Regionals in 1999 and 2000. His 2004 lowa

record was 20-35. Jack has presented many clinics in western lowa.

CHARLIE GREENE is one of the best known college coaches in the



USA. He is a veteran of the clinic circuit not only in America, but also around the world. After coaching high school baseball in Portsmouth, N.H., leading his school to the state champiohnship in 1964, Greene moved on to the college ranks serving three years as a graduate assistant at the Univ. of Alabama. His next move would prove to be his last. In 1967, he took over as head coach at Miami-Dade C.C. and held that post for the next 30 years

leading the school to three Florida State Championships and winning it all in 1981 -- the National Junior College World Series. He spent eleven summers as a pitching coach for several minor league teams. He also served as head coach for Team USA in 1988 and 1989. He became the first junior college coach to serve as President of the ABCA and currently serves on that group's Board of Directors. He has spoken at many ABCA Clinics and others throughout the world. He has published several books on pitching and is a regular contributor to Collegiate Baseball magazine. His pitching chapter is in the ABCA book, The Coaching Bible.

RICK HELLER enters his 19th season as the Head Baseball Coach



at the college level, presently his fifth year at University of Northern Iowa. A graduate of Upper Iowa University in 1986, Heller is the only Upper lowa athlete to letter in three sports in the same year since 1961. Prior to arriving at UNI he spent 14 years at Upper Iowa. Rick's over-all record is 379-280. Six players have been drafted by Major League Baseball. He was an assistant baseball coach at North Fayette before taking the head baseball position in Bakersfield, MO. He returned to Upper lowa as head coach in 1987. In the past 16

years, Rick has won four Conference Championships and has gone on to the NCAA Central region three times and the College World Series three years ago. He has been a member of the Association for 19 years.

JOHN SIRIANNI is in his 21st year as the director of athletics at



Simpson and also the baseball coach for 20 seasons. He has posted a 462-280 record leading Simpson to six NCAA Division III regional tournaments, three Conference titles, two ILAC Tournament championshhips, and one College World Series (1991). A five-time IIAC Coach of the Year, 68 of Sirianni's players have earned All-Conference honors with five Storm players going on to sign professional baseball contracts. John earned both his bachelors (1972) and master's (1982)

degrees from Iowa State University.

#### SCOTT SERVAIS is roving minor league catching instructor for the



Chicago Cubs. Scott was a three-year starter for Creighton University. Prior to pro ball he won a gold medal in Seoul as a member of the U.S. Olympic Team. He was drafted by the Houston Astros in the third round of the 1988 free-agent draft, playing in Astros minor league system. In 1991 he joined the Astros making his debut July 12. In 1995 he was traded to the Cubs. His best year was in 1996 playing in 129 games. He has been the roving catching instructor since 2002. He

completed 14-year professional career in 2002. He was the Cubs' starting catcher in 1998 when they went to the National League Division Series. He spent eleven years in the majors with Houston, Cubs, San Francisco and Colorado, appearing in 820 games batting .245 with 63 homers and 319 R.B.I.

**DAVE HARTY** is a native of lowa Falls and a graduate of lowa State



University. Dave coached baseball, football and wrestling at Postville and Eagle Grove. He became a school administrator at Eagle Grove and served as the Assistant Executive Director of the I.H.S.A.A. He was in charge of the lowa High School Baseball program for 32 years. He has given many State baseball rules meetings and is an interpreter of the rules for the state of lowa. He has served on the Clinic staff for many years.

Dave was inducted into the Hall of Fame 2003. The "Umpire Newcomer of the Year" is named after Dave. Dave has served on the National rules committee three different times for a total of 12 years.

## **LANNY PETERSON AWARD:** (Captain of Academic All State Team)

CRITERIA: Selected to All State Academic team.

Ranks at or near the top in requirements for Academic All State. Selected by panel of coaches and chairman of Lanny Peterson Committee.

#### HAROLD "PINKY" PRIMROSE AWARD:

**CRITERIA:** Anyone who played high school baseball in the State of lowa who went on in his career to distinguish himself in his community, district, state or nation. Did not have to be an outstanding baseball player.

**ALL DISTRICT TEAMS:** (5 Districts, 4 Classes, 1 st and 2nd Team)

**CRITERIA**: Nominated on ballot by association members. Selected by vote of association head coaches at district meetings.

**ALL STATE TEAMS:** (A Super Class, 4 classes, 1st and 2nd Team each class)

**CRITERIA**: Selected on All District Team and nominated by his coach

Nominated and selected by vote of association nomination committee at the All-Star Series.





#### MINUTES OF IHSBCA FALL MEETING NOVEMBER 20, 2004

The meeting was called to order by President Paul Keitel at 10:30 A.M.

A motion was made by Gary Paulson to approve the last meeting's minutes that were printed in newsletter, seconded by Jack Lynch and approved.

A motion was made to approve the Financial report by Jim Gebhart, seconded by John Bartolo and approved.

The President's report was made by Paul Keitel elaborating on the success of the All-Star series and clinic.

Pinky Primrose gave a detailed executive secretary's report. He announced the clinic speakers for the 2005 clinic. They are Scott Servais, Bob Bennett, Charlie Greene, Howie Bedell, Jack Dahm, Rick Heller, John Sirianni, Roger Barr and Dave Hardy plus the University of Iowa Staff on Sunday.

He reviewed the duties of the District Directors at the Clinic and the Steering Committee duties.

He feels the budget is on course, with it costing us money to get the web site upgrades. Nearly 56,000 have hit the web site, more than 20,000 since the beginning of year.

He complimented Charlie Stumpff and staff for the excellent All-Star series in Iowa City. He announed that Phil Katz will be the chairman of the 2005 All-Star Series in Cedar Rapids.

He recommended that Dan Pomeroy receive the President's Award, Adm. Dick Naughton of San Diego the Harold "Pinky" Primrose award and Charlie Harris of Pro-Line Hats the Bill and Sherry Freese Award.

He mentioned that we spent over \$5,100 on plaques, certificates and awards.

He complimented the work of the Academic All-State Committee and their selection--Kyle Rehnstrom. He also mentioned the Pro-Line Player of Year selection--Tyler Howe.

Roger Hoel announced the 2005 Hall of Fame inductees. They were: Ray Antisdel, Wilton; Phil Lebo, Grundy Center; Dan Pomeroy, Coon Rapids; Robert "Pinky" Primrose, Norway; Steve Stumpff, Norway; Lee Toole, Council Bluffs. The above was approved by the board.

Lee Toole gave the advisory committee report. Most importantly please note the new starting dates for the 2005 district and substate tournaments. 2005 Tournament Play dates:



- Shall help in running the day-to-day operation of All-Star Series. a/ Gate keepers b/ Foul ball chasers c/ Program sellers d/ Field maintenance e/ PA announcer f/ Score keeper
- 5. Shall secure a printer of the All-Star Program.
- 6. Shall secure a photographer for taking All-Star team pictures.
- 7. Shall help process the players upon arrivial.
- 8. Shall help in transportation to ball park.
- 9. Shall help in securing equipment.
- 10. Shall help in providing and serving meals.

Executive Secretary's Responsibility at All-Star Series:

- Shall send out material to All-Star Coaches in late June.
   Material: a/ Medical Form b/ Insurance releases c/ Other information necessary for running series.
- Shall handle all monies from the: a/ program b/ ticket sales c/ banquet d/ sponsors e/ etc.
- 3. Will be in charge of the Games: a/ Times b/ Setting up Series c/ Umpires
- 4. Overseer of Banquet, Meals, Total operation
- 5 Shall instruct the coaches about duties of All-Star Series and rules to live by.
- 7. Shall secure housing--food, etc.

President's Responsibility:

1/ Evaluate series 2/ Hand out medals 3/ Help in any area necessary.

#### HALL OF FAME COMMITTEE:

Function of Committee: There shall be a Hall of Fame Committee of the Board of Directors composed of present Hall of Fame members and two members of the board, appointed by the President. The President will appoint the Chairman.

#### **DUTIES:**

- Shall have the power to select Hall of Fame members each year.
- 2. Shall set up the selection process for other Hall of Fame members
- Shall set up a meeting of the Hall of Fame members at the annual clinic meeting for the selection and discussion of future Hall of Fame members.
- 4. Shall send out a note to present Hall of Fame members to encourage them to continue to be active in the Association.
- 5. Shall present to Board of Directors at their Fall meeting the Hall of Fame members for the up-coming year.
- Shall recommend after evaluation of the Hall of Fame Award methods to improve the program of the Hall of Fame induction.

#### **Executive Secretary's Responsibility:**

1. Shall send out letters to the nominees of the Hall of Fame.

#### STEERING COMMITTEE:

Function of Committee: There shall be a Steering committee of the Board of Directors composed of the dues-paying Past Presidents. The past immediate president will serve as chairman.



All recommendations of the Committee shall be reported in full to the Board of Directors. All transactions of the Committee shall be reported to the Board and acted upon the next regular meeting of the Board of Directors.

The Steering committee shall have two meetings annually.

#### **DUTIES:**

- 1. Shall have the power to select the All-Star coaching staff.
- 2. Shall be the nominating committee.
- 3. Shall study long-range needs of the Association and make recommendations to the Board.
- Shall serve as a screening committee, arrange interviews and make recommendations to the Board of Directors in the selection of the Executive Secretary.
- Shall serve the President in any capacity deemed necessary by the President
- 6. Shall evaluate the Executive Secretary's work annually.

#### **AUDITING COMMITTEE:**

Function of Committee: There shall be an Auditing Committee of the Board of Directors. The Committee shall consist of 1 member of the Board and other members appointed by the President. The President will appoint the Chairman.

All recommendations of the Committee shall be in full to the Board of Directors. All transactions of the Committee shall be reported to the Board for action upon.

#### DUTIES:

- 1. Shall serve no more than two terms.
- 2. Shall complete the audit by the Annual Convention Clinic meeting of the total membership.
- 3. Shall report their findings to the membership.
- Shall give a written report of their findings to the Third Vice-President to be recorded in the minutes.
- Shall visit with the accountant of the organization and recommend changes that are necessary with Board approval.

#### MEMBERSHIP COMMITTEE:

Function of Membership Committee: The committee shall consist of the two-year voted members of the Board of Directors from each district. The President will appoint the Chairman.

#### **DUTIES:**

- 1. Shall develop and execute plans for increasing the membership of the Association.
- Membership shall be chosen to represent the various geographic sections of the state.
- 3. Shall devise ways and means of cooperation with Umpires in securing members and in methods of organization for making such membership effective.
- 4. Such action shall be subject to the approval of the Board of Directors.
- Shall work closely with Conference Representatives in their respective Districts.
- 6. Shall work to get 100% membership in each conference in the State.
- Shall make a written annual report to the Board.



#### **UMPIRE COMMITTEE:**

Function of Umpires Committee: There shall be an umpire committee of the Board of Directors composed of one 2-year umpire from each District and one alternate from each district. Two atlarge umpires appointed by the 5-member committee. This committee selects its chairman. The two highest vote-getters will serve as the 2-year representative and alternate on the Board of Directors of I.H.S.B.C.A.

All recommendations of the committee shall be reported in full to the Board of Directors. All transactions of the committee shall be reported to the Board and acted upon at the meeting or next regular meeting of the Board of Directors.

Elected committee members may serve 2 three-year terms and then should drop off for 1 term. Appointed members are appointed for a 1-year term and may be reappointed at the wish of the committee chairman.

#### **DUTIES:**

- Shall have the power to select one Hall of Fame member each year.
- Shall set up the Clinic for umpires. This shall be completed by November 15.
- 3. Shall set up the process of nomination and selection of District Umpire of the Year along with the Board of Directors.
- 4. Shall serve as evaluators of the District nominees and State Umpire of the Year along with the Board of Directors.
- Shall serve, plan, organize and implement program of information about Umpire of the Year.
- Obtain names of umpires who will serve on this committee from different districts.
- Complete reports from district on problems, possible solutions and changes.
- Shall make a written annual report of committee to the Board of Directors at the annual Clinic/Convention.
- Each District Representative is responsible for membership for the District.
- 10. Other duties set out by the President.

#### **DUTIES FOR ALL-STAR GAMES**

- Umpires nominated for District Umpire of the Year are to be invited to work All-Star games. If not enough umpires from this source are available, the Chairman of the Umpires Committee or his designee is to appoint other umpires to work.
- 2. Chairman of Umpires Committee <u>or his designee</u> makes assignments based upon responses from above.
- 3. Umpires who work All-Star games receive the following:
  - a/ 2 tickets for banquet
  - b/ No less than \$40.00 cash to defray other expenses involved such as transportation and /or lodging.
  - c/ Other momentos as deemed appropriate by Executive Secretary.
- Each umpire who works will sign a waiver of injury form before working any games.

#### LONGEVITY AWARDS FOR UMPIRES

Awards to be presented:

5 and 10-Year Certificate of Service

15 Years, 20 Years, 25 Years , 30 Years of Service Plaques

Requirements for Above:

- 1. Must be an active umpire
- 2. Must have at least 3 consecutive years of membership in IHSBCA for certificate.
- 3. Must have a least 5 consecutive years of membership in IHSBCA for a plague.
- 4. Years as umpire certified by IHSAA

Further Stipulations:

- 1. Awards to be presented at banquet.
- Umpires eligible for more than one award will be given the award for the longest number of years; however, he may purchase additional awards for earlier years.
- Announcements of awards to be made in winter newsletter and umpire responses to be received by deadline as stated in newsletter.
- 4. All awards will be given on 5-year anniversary.

#### **RATING POLL COMMITTEE:**

Function of Rating Poll Committee: There shall be a Rating Poll Committee of the Board of Directors. This Committee shall consist of the Directors from each district plus one at-large member. All members must be a member of the Association.

#### **DUTIES:**

- 1. Shall set up the rating poll members by district.
- Shall send out material to committee members to help evaluate the teams in their district, such as cards, telephone #, key coaches, etc.
- 3. Shall try to work through the Conference representatives as much as possible.
- Shall study needs of this committee and make recommendations to the Board of Directors.
- All transactions of the committee shall be reported to the board in writing and acted upon at the regular scheduled meeting.

#### **CLINIC COMMITTEE:**

Functions of Clinic Committee: There shall be a Clinic Committee of the Board of Directors composed of the Executive Secretary, Umpire Chairman, President and College advisory.

The Executive Secretary will serve as chairman.

Recommendations of the committee shall be reported to the full Board of Directors and acted upon at the next meeting of the Board of Directors.

#### **DUTIES:**

- 1. Shall set up and run the Annual clinic.
- 2. Shall secure speakers for Annual clinic.
- 3. Shall set up program for Annual clinic.
- 4. Shall mail out press releases for Annual clinic.
- The site (city & school) will be selected by the Board of Directors after invitation has been tendered.
- The convention shall be scheduled at such a time, location at such a site and housed in such property which shall maximize convention attendance, administrative efficiency, organization independence, membership convenience and the association image and prestige.

#### CONSTITUTION COMMITTEE:

Function of Constitution Committee: There shall be a constitution Committee of the Board of Directors composed of two Board of Directors and other members appointed by the Chairman. The President shall appoint the chairman of this committee. They shall serve no more than two terms.

#### **DUTIES:**

- Shall report any recommendations of the committee to the Board of Directors.
  - a/ These recommendations shall then be voted by the Board and then sent out in the newsletter for action at the next regular meeting.
  - b/ They shall study the Constitution and By-Laws of the organnization/ association and continually up-date.

- If any Constitution changes are recommended they shall be put into proper language before submitting to vote of the Board of Directors.
- Shall conduct annual Committee meeting prior to Clinic/ Convention meeting.
- 4. Shall make a written annual report of Committee to the Board of Directors.

## ALL DISTRICT COMMITTEE:

Function of All-District Committee: There shall be an All-District Committee of the Board of Directors composed of two members of the Board of Directors and other members appointed by the Chairman. The chairman shall be appointed by the President.

They may not serve more than two terms on committee.

#### **DUTIES:**

- Should develop and execute plans to review the All-District selection process.
- Make recommendations to the Board on problems, possible solutions and purpose changes.
- 3. Serve as evaluators of All-District meetings and selection process.
- 4. Make a written annual report of Committee to the Board.

## ALL STATE COACH COMMITTEE:

Function of All-State Coach Committee: There shall be an All-State Coach Committee of the Board of Directors composed of two members from the Board of Directors and 3 appointed by the Chairman. The President shall appoint the chairman. They may not serve more than two terms.

#### **DUTIES:**

- Evaluate the Association All-State Coach Awards program and recommend methods of improving the program.
- Make recommendations to improve the process of electing All-State Coach of the Year and District Coach of Year.
- Plan, organize, and implement program of information about All-State Coach to be announced in the newsletter.
- Make a written annual report of Committee to the Board of Directors at the February meeting.
- Serve as evaluators of District nominees and State Coach of the Year along with the Board of Directors.
- 6. Conduct an annual committee meeting prior to clinic/convention.

- 7. Obtain names of coaches who will serve on this committee from different districts.
- 8. Complete reports from district on problems, possible solution and purpose changes.

#### LANNY PETERSON ACADEMIC COMMITTEE:

FUNCTION OF ACADEMIC COMMITTEE: To review and evaluate the process of choosing academic award winners and report to the Board any of their findings. Members of the committee shall serve at the request of the president until the end of each annual clinic/Convention or until their successor are appointed.

Committee chairman shall be the Vice-President, who shall call the committee together at the clinic/convention. This meeting should be held in the a.m. on Friday. The chairman shall report on their committee's direction at the Thursday night meeting and also at the general session. They should call as many meetings as necessary in order to get the job done.

#### **DUTIES:**


- 1. Select the First Team and Honorable Mention All-Academic.
- 2. Interview the candidates for the Lanny Peterson Award.
- 3. Evaluate the criteria for selection of candidates.
- 4. Report to the Board in writing an annual report of the Committee.
- If any changes shall be necessary, they should be in writing and presented to the Board at the next regular meeting.

#### AWARDS COMMITTEE:

Function of the Awards Committee: There shall be an Awards Committee of the Board of Directors composed of two members of the Board of Directors and other members appointed by the Chairman. The Chairman shall be appointed by the President.

#### **DUTIES:**

- 1. To evaluate all awards presented by Association.
- To evaluate a named award after 5 years, and recommend to the Board to continue the name or change the name of the award.
- Shall make a written annual report of the Committee to the Board of Directors.
- 4. These recommendations shall then be voted upon by the Board of Directors.




## Questions frequently asked: (Repeat from 1999 letter)

- 1. How can I get involved with the Association? All that is necessary is to attend the clinic and All-Star series. Volunteer to work or coach at the All-Star series and/or at the clinic. Serve on committees!
- 2. How can I coach in the All-Star Series? Fill out the form in this newsletter. The Steering Committee selects the All-Star coaches. They try to get a balance of coaches in each District, hoping to be able to cover the state. Your nomination form stays on file for two years.
- 3. How can I umpire in the All-Star games? An umpire in the All-Star Series must have been a member of the Association for at least three years. He must be nominated at the District meetings held in July. All the nominations from these meetings go to the Umpires Committee, which meets at the All-Star site. The nominees are narrowed down to three per district. The umpire chairman and committee will then select four additional umpires from the area to fill in the other four spots. Sixteen umpires are selected to work each year. If you are interested, fill out a nomination form that will be in the next newsletter. This form will be forwarded to the Umpire Committee chairman. All the umpires are selected by the Umpire committee.
- 4. How can I get on the Board of Directors? All a coach or umpire must do is get nominated by fellow coaches or umpires. The nomination form is in the Sept.-Oct.-Nov. Newsletter. The nominees who receive the most votes go on the ballot. The one-year representative and alternate stay on the ballot, but must win the votes to go on the Board.
- 5. Who makes the committee assignments? The Vice-President (President-elect) always makes the committee assignments for the coming year. A coach may request a certain committee. The president-elect will try to spread the committee assignments around so all sections of the state are represented. The chairmen of the committees are usually Board of Directors.
- 6. How are the district nominees selected? The district nominees are selected in the July meetings. Any coach who takes his team to the State tournament becomes an automatic nominee. The coaches who are nominated in the July All-District meeting and the State tournament are then narrowed down to three for each class at the fall meeting of the Board of Directors. The District Representatives (Two-Year, One-Year and 2-Year Umpire Reps) select the three nominees who go on the ballot. It is very important that a coach fill out the nomination form that is sent to him.
- 7. Who selects the officers? The steering committee, which is made up of dues-paying past presidents, selects the officers. The office of President moves around the state by each district. It is in this rotation: Northeast, West, Central, Southeast. The past president is chairman of the steering committee.
- 8. Who selects the award winners? The award winners are all selected by the Board of Directors. The Hall of Fame is selected by the Hall of Fame committee. All Hall of Fame nominations go to the Hall of Fame committee. This committee is made up of Hall of Fame members of the Board of Directors, Steering Committee and Hall of Famers.
- 9. Who selects the President's Award? The Board of Directors upon the recommendation of the Executive Secretary.

- 10. Who selects the Bill & Sherry Freese Award? The Board of Directors upon the recommendation of the Executive Secretary.
- 11. Who selects the Harold "Pinky" Primrose Award? The Board of Directors upon the recommendation of the Executive Secretary.
- 12. Who selects the District Media and Contributors Winners? The District chairman of each district with the help of the other representatives selects the winners at the fall meeting.
- 13. How can a coach or umpire speak at the Annual Clinic? Very easy. Volunteer, give the Clinic chairman your topic, expertise and topic. That committee meets in November and puts the clinic together with the speakers.
- 14. How can I get my good ball player on the All-Star Team? Fill out the profile form in the newsletter or on the web site and submit to the Executive Secretary. The forms are then forwarded to the Head Coach of each team. Each coaching staff then selects the team that they feel can win the Series. They also must have a balance on their team; not everyone can play short-stop. After you submit the form, please let the coaches know that your player has been doing the job for you all year. Make sure you try to get the player exposure. Have other coaches recommend him.

If you have questions that you want answered, please forward them to the Executive Secretary or President of the Association. This is your organization; it needs you and you need it in order to get better and improve. Our business is to help improve high school baseball in the state of lowa and also honor the coaches and players each year who have done an outstanding job in their district.
