I.H.S.B.C.A. announces the 2008 All-Star Series in Des Moines August 1-2-3-4, 2008:

The Thirty-Second Annual All-Star Games will be held in Des Moines at Dowling High and I-Cubs Principal Park, Aug.1-2-3-4, 2008. Any coach who feels he has a player or two who should be playing in the All-Star Games should fill out the Player Recommendation sheet that can be found on the Web Site. Please enclose a photo of your player (if available) with the recommendation sheet. The guidelines for the All-Star selection can be found on that sheet. All of the advance information we can get on the best ball players will help in the selection of the All-Stars.

The Board of Directors passed a policy that any player or coach selected to participate in the All-Star Series must have a minimum of **\$200.00** of sponsors' fees. More would help to defray the cost of the All-Star Series. **It will be the high school coach's responsibility to get sponsors for the player if he wishes him to play in the All-Star games.** This policy is necessary in order to offset the high cost of putting on the All Star series. If you have any questions about this policy, contact any officer or director in your area; they will explain it to you. Sponsor names and fees must be paid to Executive Secretary no later than Saturday, July 28, if your player is selected.

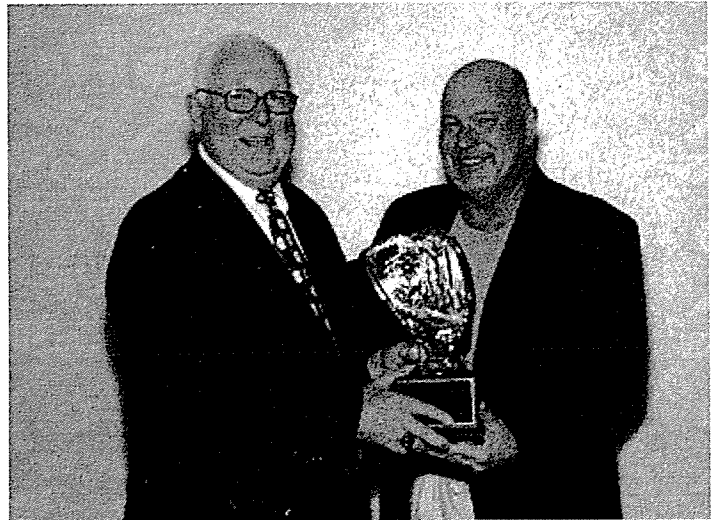

All-Star Games Schedule: The players, coaches, umpires and staff will be staying at the Valley West Inn in West Des Moines. The Honors Dinner will be held at the Botanical Garden, Saturday night at 6:00 p.m. All games will be played at Dowling High and I-Cubs Principal Park.

1/ Players will arrive Thursday, August 1st. Individual pictures for inclusion in the program will be taken after check in.

2/ Players from Small Schools West will report by 10:30 a.m. Large Schools West players will report at 10:45 a.m.

3/ Players from Small Schools East will report at 11:00 a.m. and players from Large Schools East will report at 11:15 a.m.

4/ Practice for East teams will be 12:15 p.m.--2:45 p.m. Practice for the West teams will be from 2:45 p.m.--4:15 p.m. Small West and Small East-Valley West Des Moines High School Diamond and Large West and Large East at Urbandale High School Diamond.

5/ First Round 7-inning games will be at 5:30 p.m., Thursday, Aug. 1, at **Dowling High School**: Small Schools East vs. Large Schools East, followed by Small Schools West vs. Large Schools West.

6/ Second Round 7-inning games will be at 10:30 a.m. Friday, Aug. 2, at **Principal Park**, Small Schools East vs. Large Schools West followed by Small Schools West vs. Large Schools East.

7/ Saturday, Aug. 3, at **Principal Park**, games will begin at 10:30 a.m., Small Schools West vs. Small Schools East followed by Large Schools West vs. Large Schools East.

8/ At 6:00 p.m. Saturday, the Honors Dinner will be held at the Botanical Gardens off I-235.

9/ Sunday, Aug. 4, at 10:30 a.m., at **Dowling High School**, the two teams with the poorest records will play for 3rd and 4th place. The two teams with best records will play for 1st and 2nd place following the first game.

11/ M.V.P. players will be announced after each game on Sunday.

All Star Squad Regulations:

1. Each squad will consist of 16 players (2 catchers, 4 pitchers, 5 infielders, 4 outfielders and 1 utility).

PLAYER SELECTION:

First priority: Coach's recommendation form

Second priority: All District Team

Third priority: Coach a member of the association.

Rules:

1/ All players chosen must play.

2/ The pitchers can pitch a full game.

3/ All games will be 7 innings in length unless extra innings are necessary.

4/ Tie breaker system will be announced in advance for who will play for 1st and 2nd place. Example: Head to Head competition, most runs scored, least runs given up, most hits, least hits given up.

All of the examples can be given points. The two teams with the most points will play for 1st place. This system will give more boys an opportunity to play and show what they can do. We will not restrict a pitcher on amount of innings he can pitch in one day.

******Players who do not make the All District Team will still be eligible to play in the All-Star Series. ******

If a coach fills out a player profile form that is found on the Web Site and sends it in, this player will have the same opportunity as a player on the All District Team. This system is necessary because a number of good ball players have been left off the All Star Squads because a coach could not get enough votes for his player at the All District Selection meetings. A reminder that each player must have \$200.00 worth of sponsor fees in order to play in the All Star Series.

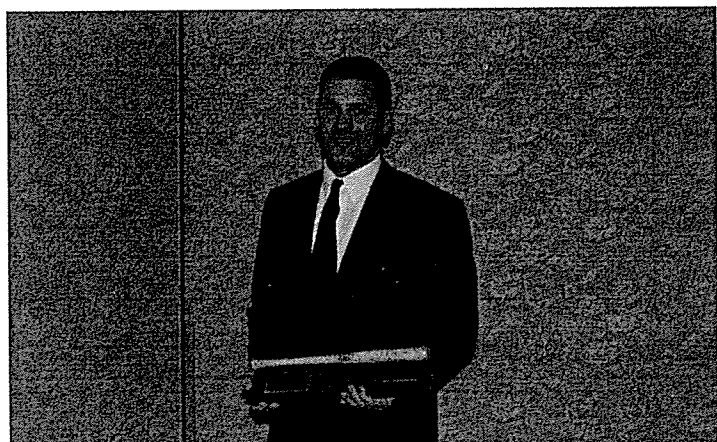

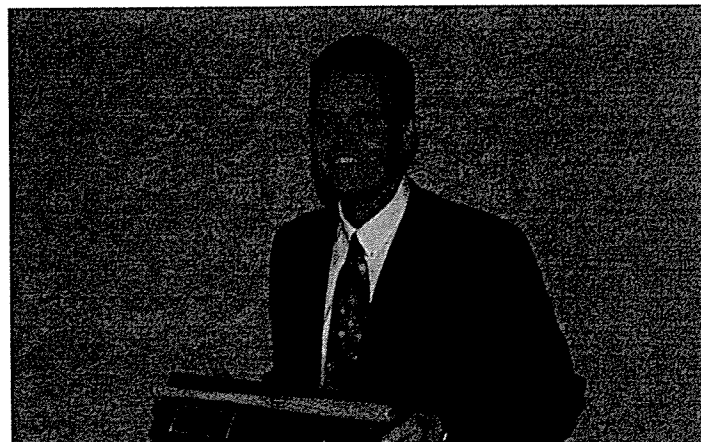

Board of Directors Meeting: Thursday, January
31, 2008
Monarch Room, Crowne Plaza Hotel, Cedar
Rapids, IA

President Denny Barton called the meeting to order at 7:46 p.m.

Motion by Lee Toole and 2nd by Dan Pomeroy to accept the fall board minutes. Motion carried. Members are reminded that the minutes from previous board meetings are published in the newsletters.

Bret Hoyer presented the Audit report. He noted that some line items need to be cleaned up on the itemized budget report, but everything had been cross-checked and approved by the CPA. Jeff Westendorf inquired about interest income. Pinky said much of this income is not paid until year-end, however it could be reflected in the projected budget. Motion by Mike Morrison and 2nd by Randy Wee to accept report. Motion carried.

Lee Toole presented the Steering Committee report. Gary Paulsen of Ogden was recommended to go through the chairs. Motion by Ryan Woods and 2nd by Steve Hanson to accept. Motion carried.

Pinky presented the Financial report. He indicated the Linn Area Credit Union would be a financial replacement for Wells Fargo. They appear to be a more user friendly organization. Pinky reminded members that the CPA checks the books for accuracy and that some of the line items on the budget report need to be placed in different categories. He also stated the association had a very good year financially. Pinky indicated the annual IHSAA donation and the income received from the exhibitor display tables are used as the primary sources to pay for the actual clinic portion of the weekend. Motion by Jack Lynch and 2nd by Gary Nyhus to accept the report. Motion carried.

Pinky presented the Executive Secretary's report. He discussed necessary changes to the speaker line-up and schedule for the clinic. In particular, two of the featured clinicians Brian Cain (snowed in) and Chris Hatcher (employment commitment) would not be able to present on Friday and Saturday. Cain was expected to be at the bubble in Iowa City on Sunday. Randy "Wayne" White will be the featured speaker at the banquet. Pinky reminded coaches of their assigned clinic duties to help things run smoothly. He also reviewed expected numbers for the clinic which included 30 umpires, over 300 coaches, 25 exhibitors and 340 banquet attendees. Special award recipients for the banquet were reviewed and Gary Nyhus was thanked for sponsoring the post-banquet hospitality room. The web site continues to receive numerous hits. The association membership for the past year was 765. Pinky reviewed the All-Star format for the 2008 series that will be held in Des Moines. Tentative sites for future All Star Series are as follows: 2009 – Cedar Rapids; 2010 – Council Bluffs; 2011 – Davenport. Pinky also noted an error was made on the 2A Central District coaches ballot. A new vote was taken from members using e-mail addresses on record. Motion by Dave Middleton and 2nd by Ken Schreiber to accept the report. Motion carried.

Roger Hoel presented the Hall of Fame report. He stated the committee was looking forward to the induction of the 2008 members. They include: Cal Eldred, Urbana/University of Iowa, player; Stan Bahnsen, Davenport Central, player; Don Lyons, Denison, coach; Rick Heller, UNI, coach; Phil Katz, Linn-Mar, coach; Marlow Van Ginkel, Rock Valley, umpire. Roger encouraged members to continue nominating deserving individuals for future consideration. Motion by Steve Westphal and 2nd by Gary Paulsen to accept the report. Motion carried.

John Waddle gave the All-District report. He reminded members of the importance of filling out the All State nomination form and the expanded All District statistics form. These two forms are very helpful guides for selecting the All State teams. Motion by Gary Paulsen and 2nd by Jack Lynch to accept the report. Motion carried.

Phil Katz gave the Awards Committee report. He stated that there are approximately 60 awards categories with a budget of over \$5000. Phil also stated the committee has been asked to consider dropping the 15-year service award and to review the length of the banquet. Motion by Jack Lynch and 2nd by Randy Wee to accept the report. Motion carried.

Randy Wee presented the All Star Series report. He said current preparations are going well for the event scheduled for Des Moines this summer. He did note a format change, stating that games played on Friday and Saturday would be begin at

10:00 am and noon at Principal Park. This will also change the All State voting times. The Super Team voting will start at 7:00 a.m., while the other selections will be chosen at approximately 2:30 p.m. Randy listed the Hall of Pride and Bob Feller Museum as possible sites for players to visit during the series. He also noted Oakley sunglasses have been donated for each participating coach. Motion by Dave Middleton and 2nd by Lee Toole to accept the report. Motion carried.

Gary Paulsen presented the Umpires report. He stated that a great umpires clinic has been planned. It was suggested that the IHSAA use three man umpiring crews for all district final and sub-state games. Gary also noted that district umpire nominees will be given first priority for the All Star Series. Jeff Westendorf presented a very comprehensive booklet containing the results of a recently conducted umpire survey. Due to the extensive data contained in the report, a joint coach/umpire committee will be formed to review the results. Chairmen for this committee will be Westendorf and Denny Barton. Jeff also volunteered to publish an in-season newsletter for umpires, covering a variety of topics. A preliminary copy of the newsletter will be sent to the IHSAA for review. Once Boone has approved the content, it will be forwarded to umpire members via e-mail. Motion by Mike Pauly and 2nd by Steve Westphal to accept the report. Motion carried.

Dave Rock presented the Lanny Peterson Award report. Brian Inloes of Mount Ayr emerged as the academic winner from the 78 nominations that were submitted. Motion by Randy Wee and 2nd by Jerry Roling to accept report. Motion carried.

Lee Toole presented the Rating Poll committee report. He said interest continues to increase and the process seems to be getting better each year. The IHSAA will be used to help with classifications. Motion by Mike Morrison and 2nd by Paul Keitel to accept report. Motion carried.

Dave Middleton presented the Membership report. The committee sent out 90 letters to "non-clinic" coaches encouraging them to become involved. At the end of the 2008 season, the committee will focus on any coach who is not a member at that time. It was also noted that it may be a good idea to work with college curriculums to increase membership awareness for graduates entering the coaching profession. Motion by Roger Hoel and 2nd by Paul Keitel to accept the report. Motion carried.

Steve Hanson presented the All State Coach report. His committee requested that one of their members be present at the November board meeting in Iowa City. Their role would be to collect the names and biographical sheets for all of the Coach of the Year nominees that are to be placed on the ballot. Once a complete list is generated, the final product would be copied and presented as one document to the Executive Secretary. Steve also noted that the committee would like to see more consistency concerning the information presented between and among the biographies. His committee will also discuss a system to ensure that all Coach of the Year information sheets are returned prior to the November board meeting. Motion by Randy Wee and 2nd by Dave Middleton to accept the report. Motion carried.

Denny Barton presented the President's report. He stated that he has a new appreciation for the association after proceeding through the chairs the past four years. He thanked Pinky for his help throughout this time. Motion by Jim Donohue and 2nd by Don Taylor to accept the report. Motion carried.

Prior to the Executive Secretary job review, Pinky submitted his resignation to President Barton, effective April 1, 2008. The board did not accept the resignation at this time. The board will meet at a future date to determine the direction of the association.

In new business, Bret Hoyer, presented a proposal from the Cedar Rapids Marriott to host the annual clinic in 2009 and 2010. He also noted that the Better Business Bureau of Cedar Rapids would provide a financial stipend to the IHSBCA during these two years. Motion by Steve Westphal and 2nd by Steve Hanson to try the new venue on a two year trial basis. Motion carried.

Motion by Mike Pauly and 2nd by Mike Morrison to adjourn at 10:38 p.m.

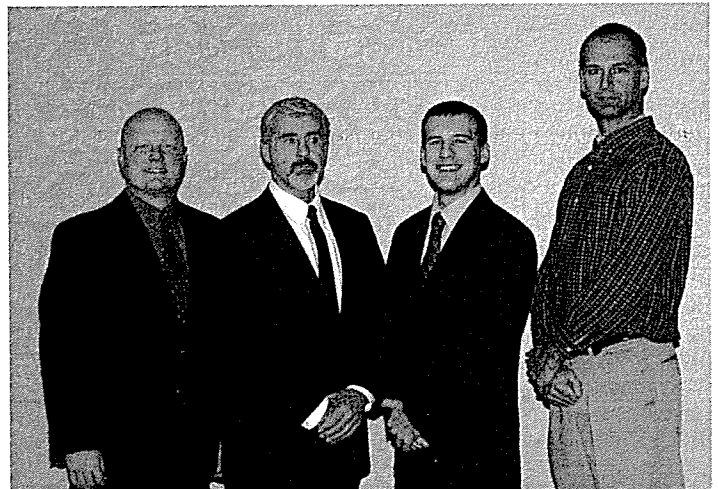

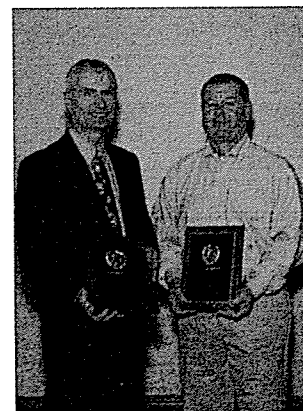

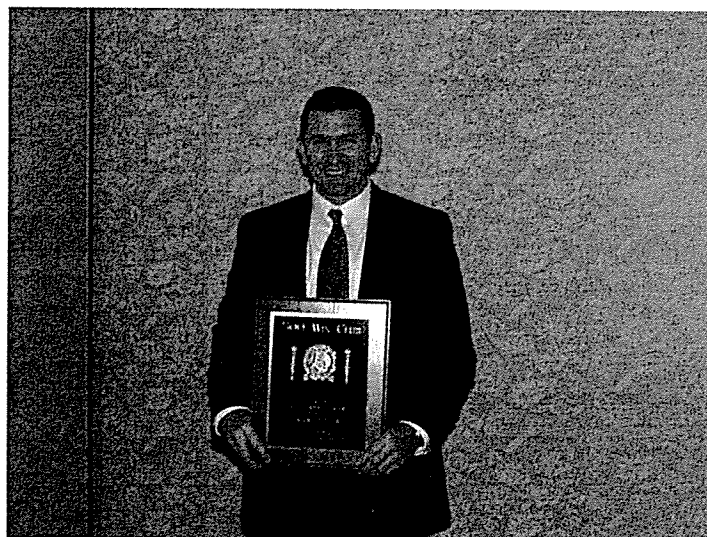
