HALL OF FAME: The coaches association inducted into its Hall of Fame five more outstanding baseball men. They were: Dick Davis, Council Bluffs T. J.; Ray Manship, Van Horne; Chick Sutherland, Iowa State; Estel Thomson, Clear Lake; George Thomson, C. R. Roosevelt. Each was introduced and a brief history was given. You will be able to nominate a man you feel is qualified for the honor in your ballot for All District in July. Look around for those deserving coaches who may have been forgotten who are deserving of such honor.

DISTRICT COACHES OF THE YEAR: Five District Coaches were honored again. They were Vic Belger, Fonda O.L.G.C., Northwest District; Bill Lehr, Clinton, Southeast District; Dennis Olejniczak, Decorah, Northeast District; Bill Sapp, Boone, Central District; Tom Vincent, Council Bluffs T. J., Southwest District. Each coach was nominated last July on the All District Ballot. A candidate must be a member of the Coaches Association. He must have coached for at least two years in his present school. He must take a team to the District or State Tournament. He must promote baseball in his District. These are the qualifications to become the District coach of the year. Each coach received a certificate, plus being a guest at the clinic.

COACH OF YEAR TO DENNIS OLEJNICZAK: Dennis Olejniczak was elected the coach of the year 1970. Coach Olejniczak had an outstanding record the past two years, winning the State tournament last summer and runner up in the Spring of 1968 and 1970. He was selected by the District Representatives and officers at the Board Meeting prior to the Third Annual Clinic. The rating ranged from 5 for top to 1 for low. The candidate with the highest point total was the Coach of the Year. This is a great honor that we all can work for. He must meet all the requirements set out in the District Coach of Year Guidelines.

1972 FOURTH ANNUAL CLINIC: The dates for the Fourth Annual Clinic are set. They are March 10-11. It will be held in Cedar Rapids Washington high school once again. If you have any ideas for speakers and topics for next year's clinic drop us a line. We need some new ideas. The clinic committee is already looking toward next year's clinic.

CALLING IN YOUR GAMES: We would like to remind you coaches to send in to your local newspaper or the nearest newspaper plus the Des Moines Register the results of your baseball games. Call in your scores to the radio and television stations in your local area. Make sure you send a schedule to your newspaper, radio and television people. SUGGESTIONS FOR IMPROVEMENT OF YOUR PROGRAM:

1. Have a program for the fans to have with a score card on it with player's numbers. This program will have your schedule, roster, and score card.

2. Make sure you have a score board. These can easily be made in your shop or given to you by

Coke or Pepsi people. This should be a rule: All diamonds have a score board.

3. Outfield fence. Try to get a fence put up for the boys to hit a ball over. This would give them something to shoot for. This also should be a rule: All diamonds have an outfield fence.

4. Bleachers for people to sit on.

5. Rest rooms for the people to use. They have them for all other sports. Why not baseball?

6. Warm up pitcher's mound. This is a must for a pitcher to warm up on. It's difficult to warm up on the flat and then come into a game and throw off a hill. All it takes is a couple loads of dirt! One for each team.

7. Charge at the gate. This would attract people. Make your team worth paying to see.

# MINUTES OF THE GENERAL MEETING March 12, 1971

The meeting was called to order by President Harold Primrose at Cedar Rapids Washington High School at 8:55 p.m.

The minutes of the afternoon Board meeting were approved as read.

Bernie Hutchison gave the treasurer's report. He stated that the balance on hand, not including the clinic, as \$510.80. The report was accepted as read.

Mr. Primrose gave the President's report and stated that the membership has increased in the past year and a complete membership breakdown will be presented in the April newsletter. He also made it clear that the organization and college coaches should review the present situation that exists with the Iowa college coaches.

Bob Locker read the proposed Constitutional changes which are as follows: Article V, Sec. 1, Article VI, Sec. 2, Article VI, Sec. 2C, Article VII Sec. 5.

It was moved by Emil Klumpar and seconded by Elmer Starr to accept the recommended changes. Motion carried.

Dick Wagner of the All-District Committee read the list of priorities that the committee felt was important in selecting All-District teams. The list is as follows:

1. 1st Team All State any previous year

- 2. 2nd Team All State any previous year
- 3. 3rd Team All State any previous year
- 4. 4th Team All State any previous year
- 5. 1st Team All District any previous year
- 6. 2nd Team All District any previous year
- 7. 3rd Team All District any previous year
- 8. Nomination of player by his own coach
- 9. Number of votes for nominating player
- 10. Degree of difficulty of schedule
- 11. Nomination from the floor of committee
- 12. Year in school by player
- 13. Coach as a member of the baseball association.

It was moved by Ed McNeil, Fort Dodge, and seconded by Bill Freeze to accept this list of priorities in selecting the teams. The motion passed.

Bernie Hutchison reported that nominations for Hall-of-Famers would be accepted on the ballots of the All-District Selection ballots or may be accepted if a letter was sent to him. He mentioned the idea of nominating someone while the new Hall-of-Famers were still fresh in your mind.

The membership committee chairman, Jim Jagim, listed ten ways the committee felt the organization could help promote itself. The list is as follows:

- 2. Local publicity
- 3. Contact umpire association
- 4. Tell of the success of the clinic
- 5. Try to become baseball coach first do not rob players
- 6. Day off to go to clinic

- 7. Free major league tickets
- 8. Newsletters more interesting coaches must send in news
- 9. Work on some area meetings sponsored by area colleges
- 10. One year complimentary membership.

The audit committee, headed by Byron Rhodes, had reviewed the books and reported that everything was in order.

Mr. Primrose stated in his program committee report that all State Champion coaches for the past year would be invited to be speakers at the next clinic. He also made mention of the fact that the names of any possible new speakers should be presented to the committee.

Under new business, Bernie Hutchison moved that a plaque be presented to each retiring President of the organization recognizing their service. The motion was seconded by Elmer Starr and passed.

Harold Schmickley stated that he would like to present to the Board of Control, from our organization, the playing of a consolation game in the afternoon of the State Finals. If the game could not be played for one reason or another, the winner would be decided by a flip of a coin. Mr. Primrose moved that Mr. Schmickley also present to the Board the following new rules: 1) All diamonds have an outfield fence, 2) All diamonds must have a scoreboard. The motion was seconded by Buck Cheadle and after discussion was passed. It was then moved by Dick Wagner and seconded by Buck Cheadle to recommend to the Board of Control that all tournament sites have an outfield fence. The motion passed.

Dennis Olejniczek presented the following state officers for the year of 1971:

Secretary — Dave Hoyt

Vice-President — Vern Bredeson

Treasurer — Bill Freese

There were no new nominations from the floor. Jagim moved to accept the state of officers as presented. It was seconded by Gay Bowden and the motion passed.

Mr. Starr then announced that new committees would be appointed on Saturday.

Meeting was adjourned at 10:07 p.m.

# MINUTES OF BOARD OF DIRECTORS March 12, 1971

The meeting was called to order by President Harold 'Pinky' Primrose at 12:10 p.m. The meeting was held at Cedar Rapids Washington High School. The board members present were: Nick Archer, Viv Belger, Vern Bredeson, Bill Freese, Bernie Hutchison, Dave Hoyt, Jim Jagim, Bob Locker, Vince Meyer, Dennis Olejniczak, 'Pinky' Primrose, Jim Schulz, Elmer Starr, Tom Vincent, and Chuck Wolever.

The minutes of the October 27th board meeting were approved as read.

Bernie Hutchison reported that the treasury had a balance of \$510.80 not including bills from the clinic. It was moved by Elmer Starr and seconded by Vince Meyer to accept the report. The motion passed.

Elmer Starr started the committee reports by reviewing the selection procedures of the Coach of the Year. There were three coaches selected from each of the five districts. The coaches were selected at the last board meeting and each district coach of the year was then to be selected by a ballot in the winter newsletter.

Bernie Hutchison reported that at future clinics a member of the Hall of Fame will present each new Hall of Famer. He also stated that if anyone knows of a deserving person for the Hall of Fame they should let him know as soon as possible. Mr. Primrose added that it may be desirable to have a member of the Hall of Fame as an advisory person to the Board. He also stated that the committee should think about considering umpires for the Hall of Fame.

Bob Locker presented new Constitutional changes. The changes are in the following places in the Constitution: Art. V, Sec. 1, Art. VI, Sec. 2 and 2C, and Art. VII, Sec. 5. A possible change that will be looked into is Art. III, Sec. 2, a definition of active member.

Jim Jagim reported that the membership committee was concerned about the membership in the Western part of the State.

Bob Locker suggested that the Association back the new man that will be hired in place of Harold Schmickley. Mr. Primrose then read the letter that he wrote to Bernie Saggau. He also wrote a letter to all of the major league teams concerning our coaches passes. The list of teams that will honor the passes will be in a future newsletter.

Clair Rierson reviewed a study conducted by a student at Iowa State concerning baseball in Iowa. The study pointed out many problems currently facing high school baseball, one of which is the great turnover of coaches.

Mr. Primrose started his President's Report by quoting statistics of membership. These statistics will be in the next newsletter. He then passed out the proposed budget for 1971-72. Elmer Starr moved to amend the budget by increasing the executive secretary's salary to \$240.00 per year. The motion was seconded by Vince Meyers and passed. It was then moved by Vern Bredeson and seconded by Jim Jagim to accept the budget as amended. The motion carried.

Bob Locker moved to accept the Constitutional changes presented earlier. The motion was seconded by Jim Schulz. It was then passed and will go to the General Meeting for final approval.

Duane Banks, Coach of the Year committee, reported that he was concerned about the lack of interest on the part of many of the college coaches in Iowa. He stated that he will investigate this situation more fully and report to the Board at the next meeting.

Mr. Primrose presented the meeting places and dates for the coming year and they are as follows: Board Meeting May 25 at Mason City, Board Meeting Oct. 16 at the University of Iowa, and the 1972 Clinic at Cedar Rapids Washington on March 10 and 11. It was moved by Bernie Hutchison and seconded by Bob Locker to accept the dates. The motion carried.

It was suggested from the floor that a baseball newspaper be started in the state. Mr. Primrose said that he will look into the possibility of having one started and will report back to the next board meeting.

Vince Meyer moved to hire Mr. Primrose as the executive secretary. The motion was seconded by Bernie Hutchison and passed.

Mr. Primrose then passed out the ballots for the selection of the Coach of the Year. Each board member voted unless his name was on the ballot in which case his alternate voted in his place. The results will be presented at the general meeting.

Vern Bredeson moved that each past President of the association receive a plaque from the association recognizing his service and leadership. The motion was seconded by Bob Locker. The motion passed.

The meeting was adjourned at 2:00 p.m.

# CONSTITUTION OF THE IOWA HIGH SCHOOL BASEBALL COACHES ASSOCIATION

### Article I-Name

The name of this organization shall be the Iowa High School Baseball Coaches Association, organized as a non-profit voluntary organization.

## Article II-Purpose

1. To promote cooperation and understanding between the administration, teachers, coaches and the community concerning the place of baseball in the total education program.

2. To promote pure, wholesome, amateur inter-scholastic baseball in the secondary schools of

Iowa.

3. To help maintain the highest possible standards in inter-scholastic baseball and the baseball coaching profession.

4. To secure a better understanding of high school baseball by sharing mutual problems and

practices.

- 5. To have a representative group of coaches interested in fostering a close working relationship with the Iowa High School Athletic Association, secondary schools, colleges, and professional organizations.
  - 6. To develop and promote greater unity, uniformity, and fellowship among all members.

### Article III—Membership

**Section 1.** There shall be three classes of membership in this association; active, associate and honorary.

**Section 2.** Active membership shall include all actively engaged baseball coaches of secondary schools, and they shall be the only voting body.

**Section 3.** Associate membership shall include all interested supporters of secondary school baseball programs and not actively engaged in coaching secondary inter-scholastic baseball.

Section 4. Honorary membership shall be elected to the membership at the pleasure of the Executive Committee upon two-thirds vote.

Section 5. Membership shall extend from September 1 to September 1 of the following year.

### Article IV—Dues

**Section 1.** The annual active membership fee shall be \$5.00 for head coaches and \$3.00 for assistant coaches.

Section 2. The annual associate membership fee shall be \$3.00.

Section 3. No fee for honorary membership.

## Article V—Officers and Board of Directors

**Section 1. Officers.** The officers shall be a President, Vice-President, Secretary and Treasurer. Only active members of the Association shall hold office.

Section 2. Board of Directors. The Board of Directors shall consist of ten members, two (2) representatives from each of the five Iowa High School Athletic Association Districts. (3) The third highest vote winner will be the alternate from his district. He will have no vote, unless a representative is absent from his district.

# Article VI-Elections and Terms of Office

**Section 1. Officers.** (A) Candidates for each of the four offices shall be nominated by a nomination committee of the Board of Directors at the late-winter annual clinic meeting. An election shall then be held at the clinic meeting by the members present.

(B) Elected officers shall take office upon duly being elected. Term of office shall be one year.

Officers shall be eligible for re-election.

Section 2. Board of Directors. (A) The representatives to the Board of Directors shall be elected by the members within their district. By October 15 of each year, the association members will receive an official blank nomination ballot. Upon voting, the nomination ballot to be returned (within ten days from mailing) to the executive secretary. In the presence of two other association members, there shall be a canvass of the ballots. The 4 receiving the highest number of votes shall be considered the nominees. In case of a tie of more than 4, all those in the ties shall be considered nominees. In case the number of nomination ballots for any one of the nominees is a majority of the number of members in the respective district, he shall be declared elected. The executive secretary shall prepare and mail official election ballots to the members of the district. Upon voting, the election ballot to be returned (within ten days from mailing) to the executive secretary. The procedure in canvassing shall be the same as in canvassing nomination ballots and the person receiving the highest number of votes shall be declared elected. In case of a tie, the election shall be decided by lot by the candidates in the presence of the canvassing committee. The third highest vote getter shall be considered the alternate and in event of inability of elected Director to serve, alternate will be appointed to the Board of Directors.

(B) Elected Board of Directors shall take office at the late-winter annual clinic meeting. A Board of Directors member shall be eligible to succeed himself but once.

# Article VII—Duties of the Officers

**Section 1. President.** The President shall preside at all meetings of the Association and Executive Committee. He shall have the power to appoint all committees and officers not otherwise provided for in the Constitution. He shall keep on file and transmit to the next president his records, and shall be an ex-officio member of all committees.

Section 2. Vice-President. The Vice-President shall assume the duties of the President in his

inability to act. He shall assist all standing committee chairmen.

**Section 3. Secretary.** The Secretary shall be the chief officer responsible for all such records and proceedings of the association meetings. He shall read all minutes of the previous meetings. He shall keep up-to-date records of the meetings and keep on file and transmit to the next secretary his records. He shall conduct meetings in case of absence of the President and Vice-President.

Section 4. Treasurer. The Treasurer shall be the chief financial officer responsible for receipt and disbursement of funds as authorized by the Executive Committee. Accurate records are to be kept subject to annual audit by the Auditing Committee. A financial report shall be given as routine order of business at all regular meetings. He shall conduct meetings in the absence of the President, Vice-President, and Secretary.

# Article VIII—Executive Committee

Section 1. Membership. The Executive Committee shall be composed of all duly elected and appointed officers and board members specified in Article VI, each having one vote on all legislative matters.

Section 2. Legislative Action. The Executive Committee shall be responsible for proper management of the affairs of the Association and shall act on all matters pertaining to membership and legislation in accordance with the Constitution.

Section 3. Quorum. A quorum shall consist of the membership of the Executive Committee

present and any action taken shall be based on simple majority vote.

# Article IX—Meetings

Section 1. Regular. To be decided by the Executive Committee.

Section 2. Quorum. A quorum shall consist of the active members present, due notice having been given of the meeting.

#### Article X—Committees

Section 1. Standing Committees. The standing committees shall consist of: Membership, Program, Auditing, and Public Relations.

Section 2. The functions, organization, and methods of procedure of the various committees are

to be set forth in their respective operating codes.

Section 3. The President shall appoint a chairman for each of the standing committees and they shall terminate with his administration in office.

# Recommended Amendments and Changes

### Article 5 Section 1

The officers shall be a President, Vice-President, Secretary and Treasurer. Only active members of the Association shall hold office.

### Article 6 Section 2 (C)

The Board of Directors shall appoint an Executive Secretary. The Executive Secretary shall be paid a fee of \$120 annually (\$10 per month). Only active members of the association shall be eligible to be appointed as Executive Secretary. He shall be appointed for a term of two (2) years and shall be eligible for re-appointment by the Board of Directors..

# Article 7 Section 5

**Executive Secretary.** The Executive Secretary shall be responsible for the publication and distribution of nomination ballots and the election ballots, the publication and the distribution of the NEWSLETTER and other materials that may be authorized by the Executive Committee. He shall attend all Board meetings and Executive meetings and make reports to the same when asked to do so. He shall carry on the day to day operation of the Association.
