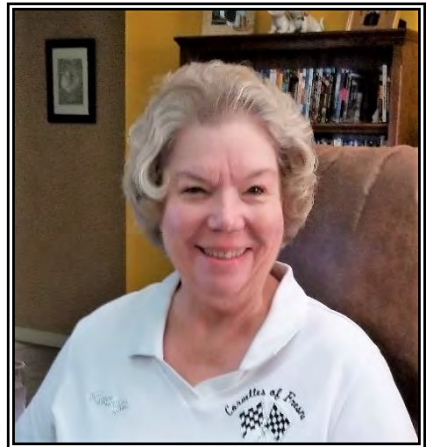

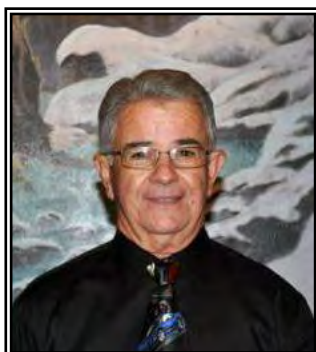

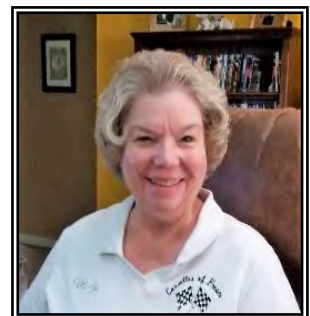

***I was happy to build the site and service it for the club, but at this time I feel it would be better served by having a club member or someone else in charge.***

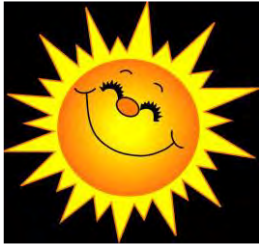

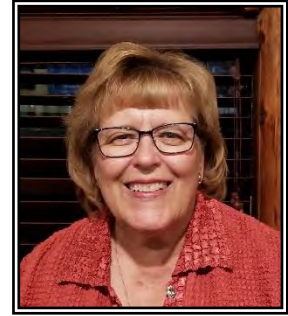
A day or so later, Chris made the requested changes to the website.

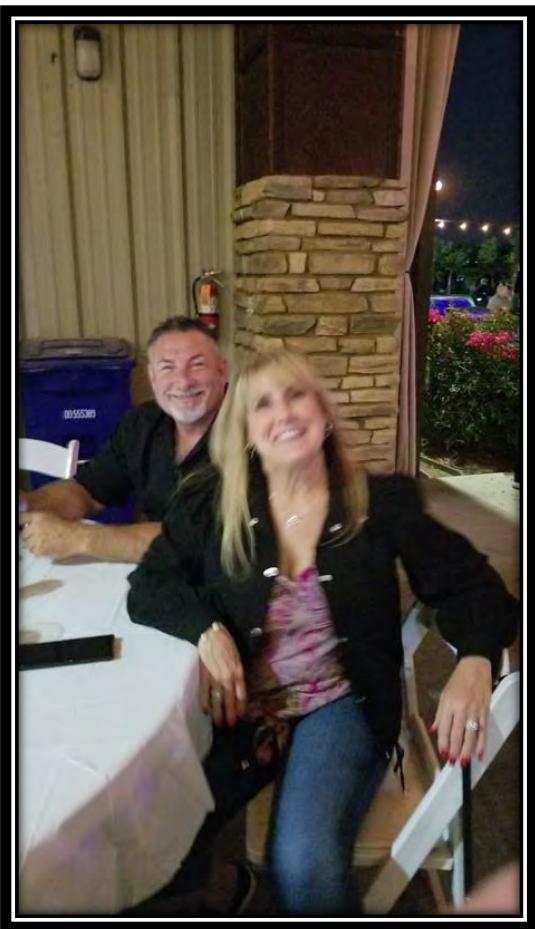
