November 10,2020

Call to Order: President Dave Trauger called the meeting to order at 7:00PM. This General meeting was a virtual meeting via Zoom. Board members present were: Dave Trauger, Lee Blackstone, Ron Lindegren, Betsy Lindegren, Socorro Biglieri, Allen Teixeira, Gerri Ware, and Chuck Ware. Board member absent was Mokey Cowger. Again, thank you to Betsy and Ron for inviting us to this Zoom meeting. The Pledge of Allegiance was shared by all.

Secretary's Report: Minutes of the last General Meeting on October 20, 2020 were published on the October Communications Report on October 30, 2020. A motion to waive the reading of the minutes was made by Terry Johnson and seconded by Ron Lindegren. Motion approved. A motion to accept the minutes as printed was made by Louis Biglieri and seconded by Allen Teixeira. Motion approved.

Treasurer's Report: Mokey Cowger was absent, so Cheryl Blackstone presented the Treasurer's Report. Cheryl presented the report for both the General and Tahoe Accounts as of October 31, 2020. On the General account the total deposits were \$706.00 for Membership dues; a check was written for \$34.95 to Chris Campbell for Internet/Software service. There was no activity on the Tahoe account. There are three members that have not paid their dues. Communications Report: Betsy did not have a report, other than in regards to the Christmas party updates which will be discussed on the Activities Report.

Webmaster Report: No Report.

Activities Report: Please refer to the Calendar of Events in the Club's Communication Report or on the website www.corvettesoffresno.com for more details and up to date information. Lee reported that he was in contact with Lee Delap in regards to the Sanger Christmas Parade. "Reverse" parade where the crowd is mobile and the entrants are stationery, Lee Delap was not able to attend the meeting, but the parade is scheduled (maybe) for December 5th. And as soon as there is more information, we will get something organized. Christmas Party: Betsy has been working on this matter, but unfortunately due to present circumstances the Christmas Party for this year has been cancelled. The deposit that was made for the 2020 Christmas party, will be applied to next year's Christmas party. Betsy has received verbal approval on this and she is still waiting on written communication.
