Skilled Care, Inc. participates in the Medicare Program. To be eligible for Medicare coverage you must be 65 or older, or be medically disabled.

For Home Health services under Medicare, you must:

- Be under the care of a physician who orders service and establishes a plan of care. We must receive an order from your physician before services are initiated.
- Be considered home bound.
- Require one skilled service such as nursing, physical therapy or occupational therapy.

Benefits may also be covered by your insurance provider.
