## Our Curriculum

- ▶ Our curriculum seeks to assist children to meet and/or exceed the Illinois Early Learning Standards. The Creative Curriculum and the Teaching Strategies Gold Assessment System provide a foundation for individualized and group programming. Daily classroom activities focus on all areas of each child’s growth and development. Every class works in large and small groups with hands on materials. Social skill, language, and literacy development are emphasized in all areas of instruction. Faith based activities are also integrated into our curriculum. Trinity Day Care embraces the following principles about how children learn best as we carry out educational programming.
- ▶ Active Learning – Young children construct knowledge that helps them make sense of their world through direct and immediate experiences, deriving meaning from them through reflection.
- ▶ Adult-Child Interaction – Learning is dependent on consistent and positive adult-child interaction.

- ▶ Learning Environment – The layout and tone of the environment has a strong impact on how children behave and requires thoughtful planning and must include a diversity of developmentally appropriate materials. Play space is organized into special areas of interest to support curiosity.
- ▶ Daily Routine – A consistent daily routine that supports active learning is essential.
- ▶ Assessment & Teamwork – Teachers work together to gather and assess information to ensure that observing, interacting with and planning for children is developmentally appropriate, stimulating and effective. Parents and teachers exchange information about strengths, challenges and progress of children.

## Our Employees

All of the employees at Trinity Day Care meet or exceed the educational requirements set forth by the Department of Children and Family Services (DCFS) for childcare center staff. Employees are required to pass a background check and participate in at least 20 hours of professional development every year. On-going training enables our staff to stay current on information that pertains to Early Childhood Education, supporting the high quality care and educational environment that we are committed to providing.
