PAYMENT OPTIONS

_____ Option 1) **PAYMENT IN FULL** —Cash or Check by mail or in the church office. Credit or debit cards will be accepted online only.

_____ Option 2) **INSTALLMENT PLAN**—Only credit or debit cards will be accepted. **A \$20 registration fee is due with the first monthly payment.** Four monthly payments are due on the first of each month, **Jan. 1, Feb. 1, Mar. 1, and April. 1.** Again, this will be the only option for using the installment plan. POLICIES AND PROCEDURES FOR FALL 2024 SEMESTER

PAYMENT OPTIONS:

- A. PAYMENT IN FULL - Cash, check, credit/debit cards (online only) will be accepted at the time of registration.
- B. INSTALLMENT PLAN - Only credit or debit cards will be accepted through online payment which you set up online. Payments are due Jan. 1, Feb. 1, Mar.1, and April 1. To pay online, you must register and pay monthly on our website at www.fbcmhc.org.
 - Scroll down on the Music & Arts Academy page and carefully select your payment options.
 - Refer to the payment amounts as listed above for your student’s fees.

Again, this will be the only option for using the installment plan.

INCLEMENT WEATHER POLICY: Please read carefully.

- The FBC Music and Arts Academy will observe the following closing program:
 - A. If the Carteret County Schools are **closed**, our program **will not meet**.
 - B. If the Carteret County Schools are on a **delayed schedule**, our program **will** operate on normal schedule.
 - C. **Early release:** If Carteret County Schools release students early due to inclement weather, please check with teacher prior to coming to lesson. Each teacher will decide whether lessons will be conducted based on the current weather conditions and any lessons missed due to that decision will be made up at a time set by the individual teacher. **Note: Our program will meet every week, except as noted above, regardless of school holidays or teacher workdays.**

POLICIES CONCERNING ABSENCES OF STUDENTS FROM LESSONS: PLEASE READ CAREFULLY

- A. There will be no makeup offered when missing a group class unless it is convenient for the teacher to have the child join another class for makeup purposes.
- B. Private Lessons:
 - 1. If a student misses a lesson without prior notification to the teacher, no makeup will be offered.
 - 2. An attempt will be made to makeup a lesson in the case of illness or family emergency if the teacher is notified at least six hours or more prior to the lesson. It is the student’s responsibility to notify the teacher if a lesson is to be missed for any reason. If the teacher cannot be reached the student should notify the Music and Arts Academy office at 726-4142. It is best to notify the teacher directly since most are here only in the afternoon or early evening. Each teacher should give his or her students a home or cell phone number.
 - 3. If a teacher misses a class, he or she will see that the lesson is made up before the end of the semester.
- C. Please make every effort to be on time for your lessons or classes. All of the teachers are on a very tight schedule and can only give the time allotted for each student. Please do not expect them to go beyond your lesson time if you are late getting to a lesson.
