Council Members,

These are copies of my **Article One Petition** citing the immediate danger we are in with Donald Trump in office, and my Complaint to the Federal Trade Commission citing antitrust violations by Wal-Mart, Colgate-Palmolive, Johnson & Johnson, and Proctor & Gamble.

Per the Petition, Andrew McCabe's new book, The Threat, states Donald Trump is an agent of President Putin. My Petition not only shows he is committing treason against the United States, but that he is planning to impose martial law with the help of Russia and China. Like many of you, I could not understand why he abandoned the North Korea nuclear talks to start a trade war with China. This question was answered with the aluminum manufacturing deal with Russia in Appalachia Kentucky. Trump's solicitation of the Russians directly contradicts his declaration that steel and aluminum are national security industries, resulting in tariffs, for example, forcing GM to close 5 plants with the loss of \$1 billion. His agency for Russia is further confirmed with approval of the Russian company Rusal to own 40% of Braidy Industries in Appalachia while only putting-up 11.7% (\$200 mil.) of the \$1.7 billion needed. So he imposed the tariffs only as an excuse to bring-in the Russians and give-away a major portion of this national security industry. The trade wars are for 1) weakening the U.S. while 2) isolating us from our allies. Please note the continuing military provocations from Russia and Trump taunting Iran. Since he knows he's not getting re-elected, his only way to stay in power is to create constant chaos for imposing martial law. Thus, his meeting with Putin and China later this month is to set the final plans to create a manufactured skirmish for war. But we must not allow that meeting.

Per the Federal Trade Commission Complaint, these are iconic products sold by Wal-Mart: *Old Spice Deodorant*, *Equate Mouthrinse*, & *Colgate Toothpaste*. But they are trash today. They are diluted and price-fixing is occurring (see entire Complaint at Prose-litigants.org). The Complaint makes the case that our largest corporations, including Wal-Mart, must be broken-up for protecting the public by creating healthy competition between companies.
