Feb. 8, 2020. The day after the Feb. 4 Iowa caucus voter reporting blackout, **CBS This Morning's** Dean Reynolds asked the Walker family how they feel about their dysfunctional voting experience. Husband [Will Walker](#) said, " . . I'm so frustrated, I probably won't even do the next one . . ." [won't vote again].

Reynolds then asked, "Cause you're disillusioned by this?" Walker replied, "Yeah."

1) Walker's comments were the "national public optics" the *Establishment* was looking for to dissuade voters from voting this year, to lose faith in America's voting process. It's the classic "subliminal suggestion" to the nation. **The perpetrators needed** this initial Iowa debacle to put the Democrat primaries on bad footing because they know the next presidential election is going to be, by far, a record turnout to remove Trump from office. Whoever is the Democrat nominee will win the election. (Oh God, please let them vote Bloomberg as the Democrat nominee.) [But Trump's criminal behavior requires his removal from office now.](#)

2) Early on, as information from the caucus trickled out, you could see that the voting blackout was a set-up, inclusive of acquiring Walker's comments. NPR's (*National Public Radio*) Miles Parks reported that precinct leaders were not given any training on the voter-reporting software app that was distributed only Monday, Feb. 3, the day before the election. When the app did not work, their phone calls were blacked-out for several hours. **It's illegal, as only an executive order from government can direct phone company black-outs of designated phone systems.** And the software company, called Shadow, was only paid \$60,000 for providing the app, though they could've racked-up \$\$\$\$thousands more to train the 1,600 precinct leaders, but \$\$\$training was ignored. Why? The other huge question mark (?) is Parks reported his team tried for several weeks to get the app to test it, but Shadow and Democrat caucus organizers denied access for testing. Why?

3) Please excuse my obsession over Donald Trump, but the Iowa blackout has the feel of a Soviet-style crackdown on voting; so per these circumstances, my suspicions are wholly justified. It has the feel of Trump's involvement, and there is material evidence to prove it. To wit, only the high-level democrats could have set this up, for example, their denying software testing. Here, only Trump has the motive to do the blackout to further disrupt the Democrats, **though only the Democrat leadership could have arranged this disruption.** For the Democrat Party is supposed to be pushing for maximum voter turnout to beat Trump. Yet they evidently sabotaged their own caucus (w/ help from CBS). Thus we can only conclude that the Dems leadership is conspiring with Trump, consistent with other evidence that Nancy Pelosi is secretly backing Trump. – **4)** The other curious matter is why Pete Buttigieg and Bernie Sanders were so eager to leave Iowa without calling for an investigation into Shadow, for example, why no app training was conducted (**Buttigieg is receiving large donor money, and Shadow has previously worked for him**). They must know that this interference can occur in later elections in other States. So their quick disappearance from Iowa is suspicious, at best. **Why are they not pushing to protect future election cycles?**

5) As you already know, the invalid and very weak Articles of Impeachment that could have been much stronger is what bothers me, too. Then Pelosi withheld the Articles only until a week after Trump committed the unlawful Jan. 3, 2020 drone strike killing Iran's General Qasem Soleimani. **As I have pointed out many times**, the most telling evidence is Trump, Pelosi, and McConnell routinely "meeting heads" to pass off the \$trillion debt bills that do not address any of America's pressing problems, as acts of willfully damaging our nation.

6) Pelosi's Articles of Impeachment are invalid because she opened-up the investigation in the Intelligence Committee though the rules require a House vote for initiating the investigation in the Judiciary Committee. Thus, Chairman Adam Schiff of the Intelligence Committee denied due process when issuing subpoenas to the White House that should've originated from the Judiciary Committee after a House vote giving authorization. This conspiracy between Trump and Democrat leadership became apparent when the Trump Administration identified these due process violations, but while Pelosi and Rep. Schiff refused to correct them, including not challenging John Bolton when taking his subpoena into court. Schiff could not legally challenge them because they were improperly issued. – By understanding the impeachment screw-ups, you can further see how the Iowa blackout is suspect.

7) In this vein, the State-of-the-Union public optics of Trump refusing to shake hands with Pelosi, and Pelosi tearing-up Trump's written speech were necessary for their attempts to silence the growing suspicions that they are conspiring together. – What scare's the dickens out of me are grass root Americans on both sides want so badly to believe Trump and Pelosi are truthful to them. And yet the record is clear, **with everything that has happened**, that neither of these politicians is being truthful (as well as Mitch McConnell's cover-up of Trump's

crimes). We are being lead down another rabbit hole, as only our demanding enforcement of the Constitution will protect us. We must demand their resignations from office.

Why isn't Democrat Leadership fighting back against Trump?

8) The other vexing situation is how Washington Democrats are not fighting Trump's hideous insults and un-presidential rants (that are sadly accepted by the Republican base). The Dems have the powerful truth to rail against Trump that will likely shut him up and force him to act more presidential. Trump is claiming victory where he has no victory; he prevailed against removal from office only by McConnell acting to cover-up the evidence. **For example**, we know that Trump conspired with Lev Parnas and White House officials to remove Ambassador Marie Yovanovitch from Ukraine to get to Ukraine President Zelensky. They actually ignored the overwhelming people's call for witnesses and documents.

Here, the Democrats can callout simple, truthful sound bites: **"We have a criminal President in Office."** **"McConnell has directed the Senate to cover up the crimes of this President."** **"The Republican Senate is infested with immoral behavior that's harming our nation."** Leveraging the President's behavior with these 30-second truth-bites will very likely shut him up and even help to calm down the nation.

Their silence helps to confirm Democrat leadership wants Trump re-elected. Why? Because as also proven, Trump is a leftist agent of Russia disguised as an American republican. Thus it makes perfect sense that Pelosi supports him. And again, they keep passing \$trillion spending bills that are not applied to the nation's problems (Trump keeps lying that the national debt is \$16 trillion, but in fact it's been growing from \$22+ trillion since he took office). They are keeping the transfer-of-wealth to Wall Street that's destroying the lives of countless Americans.

As introduced, the solution to this crisis is for the nation to understand these events and then demand Trump, Pelosi, and McConnell to resign from office. Dear Sergeants-at-Arms & Elected Official(s),

Pursuant to the **above instructions** and the stated evidence sent to the FBI Director on Feb. 8, 2020 (by Certified mail **7019 1120 0001 9056 0251**), I am concerned that our elections are in danger of being further disrupted by President Trump and Democrat Party Leadership, and that these criminal activities of Trump, etc., are supported by Sen.
