# PETITION FOR WRIT OF MANDAMUS FOR RATIFYING UNCONTESTED LIENS

### **Jurisdiction**

The Court has jurisdiction that concern three liens as UCC Financing
Statements issued by the Kentucky Secretary of State, a state agency.
Where the Jefferson County Circuit Court has original jurisdiction but refused to ratify and dispose of these liens, the Court has jurisdiction herein.

# CIRCUIT COURT PLAYING "MUSCIAL JUDGES" TO AVOID RATIFYING UNCONTESTED LIENS FOR REMOVAL FROM COMMERCIAL REGISTRY

Now comes Secured Party Daniel Cobble to Petition the Court for a Writ of Mandamus ordering the Jefferson County Circuit Court (hereafter Circuit Court) to administratively process Liens #2008-2298237-43.01, #2011-2516531-27.01 and #2011-2516533-49.01 for payment for disposal & removal from the Secretary of State's Commercial Registry (hereafter as Registry). Filing fees totaling \$306.00 was paid to the Circuit Court for processing these undisputed, longstanding liens

as respective *UCC Financing Statements*. But the Circuit Court has refused to dispose of the liens for removal from the *Registry*.

Debtors for the liens have not challenged their validity for jury trials, and thus the liens must be honored and processed as administrative functions for the Circuit Court (or any other court). There are no judicial issues to be considered by the Circuit Court.

Lien #2008-2298237-43.01 has been on the *Registry* for over four years. In addition, please see, attached hereto, the Jan. 4, 2012 concession letter as the latest concession from Debtor's Agency U.S. Tort Branch passing the matter over to Debtor U.S. Treasury (Treasury) for payment of the lien. As shown, U.S. Tort Branch is not contesting Cobble's Tort Claim #1571637103, of which Lien #2008-2298237-43.01 is expressly based. U.S. Tort Branch and Treasury have refused the opportunity to appear in Court, and thus the Lien is cleared for ratification / payment.

Lien #2008-2298237-43.01 was filed with a \$153.00 filing fee in Circuit Court on Dec. 14, 2010 for ratification and disposition, presided by Chief Judge Audra Eckerle. Though Debtor Treasury and U.S. Tort Branch <a href="https://doi.org/10.2016/jws.11">have not appeared</a> before Circuit Court to challenge the lien, Judge Eckerle has since given Cobble the "runaround" in refusing to process / ratify the lien and transferring it to Judge Brian Edwards (Div. 11).

To wit, please see Judge Edwards' Mar. 28, 2012 recusal order, attached hereto, his refusal, too, to process Lien #2008-2298237-43.01. Then, see Judge Eckerle's Mar. 29, 2012 "RE-ALLOTMENT ORDER" assigning the lien to yet another judge, Judge Stengel of **Div. 4**.

Since there are no judicial issues / challenges for the Circuit Court, Lien #2008-2298237-43.01 is required to be promptly ratified as only an administrative function. There is no cause to transfer the lien to another judge, **that has lingered in the Circuit Court for 16 months**. Whereby, Cobble requests the Court to require the Circuit Court to ratify the lien for payment, so it may be removed from the *Registry*. Or, the Court, itself, may so ratify the lien.

2. Liens #2011-2516531-27.01 and #2011-2516533-49.01 were filed in Circuit Court on Aug. 29, 2011 with Cobble's \$153.00 paid processing / filing fee. These liens were also filed in Judge Eckerle's court, and too, she transferred them to Judge Edwards.

To wit, please see Cobble's Mar. 27, 2012 notarized Affidavit specifying his appearance in Judge Edwards' court on Mar. 26, 2012 for ratification of the liens. Yet even though Debtor Metro Louisville Office of Risk Management did not appear in Edwards' court, Judge Edwards still refused to ratify the liens. Debtor has not challenged Liens #2011-2516531-27.01 and #2011-2516533-49.01 for jury trial, and thus the valid liens must be ratified by the Circuit Court. Or, the Court, itself, may ratify the liens.

**CONCLUSION:** The liens <u>have not</u> been challenged in civil jury trials as offered by Secured Party Cobble. Wherefore, the Court has <u>no legal recourse</u> but to require the Circuit Court to ratify Liens #2008-2298237-43.01, #2011-2516531-27.01 and #2011-2516533-49.01 for payment, so they may be removed from the Registry. Or the Court, itself, may ratify the liens for payment and such removal.
