The leaked confidential cable communications with disparaging comments on Trump reeks with Trump's Iran motive.

Dear Attorney General William Barr, House Speaker Nancy Pelosi,
Senate Leader Mitch McConnell, **& White House Chief of Staff,**

Pursuant to Article 1, Section 3, Clauses 6 & 7 of the U.S. Constitution, I hereby charge that our nation is in danger of the listed conspiracies and motives perpetrated by President Trump that require his immediate removal from office. The herein 2nd Article-1 Petition with additional evidence is a follow-up to the June 13, 2019 Article-1 Petition (hereafter called the ***First Petition***).

To wit:

• **Introduction** to the Public:
Why the U.S. Status Quo Wants Martial Law (People Voted for Change in 2018)

The primary purpose of this 2nd Article-1 Petition is to help ensure the removal of President Donald J. Trump from office (hereafter as Trump). The language must be clear for a U.S. Congress that is curiously reluctant to remove him despite the material evidence in the *First Petition*. —



The secondary purpose here is to provide people with an organized list of his crimes being committed. Most people are having a difficult time keeping track with so many offenses that began as he entered office on Jan. 20, 2017. The herein document identifies some of his “high crimes and misdemeanors” though you will likely add to this list. — This Petition also shows how he **is not** acting alone but has the help of members of Congress and the mainstream media. The Establishment (status quo) forbids these leaders from mentioning the material evidence identified in the *First Petition* because it requires Trump's impeachment. Thus, the third purpose of the herein 2nd Petition is to alarm Americans of the immediate danger we're in **that requires our louder demands to remove Trump from office.**

If you studied the *First Petition*, then you understand the strategy of President Trump is to weaken America in every way he can prior to imposing martial law upon the United States. With the apparent cooperation of House Speaker Nancy Pelosi and Senate Leader Mitch McConnell, Trump believes he has a chance of suc-

cessfully imposing martial law as he moves closer to starting a war with Iran (and erasing all the gains and \$trillions of U.S. tax dollars spent in Afghanistan over the last 18 years by negotiating a surrender to the Taliban who is funded by Iran).

As the martial law scheme is unfolding before our eyes, we can begin to understand the unexplained & dishonest conduct of both the Republican and Democratic parties since Trump took office. For example, besides attempting to erase the PIP program discussed in the next section, there is no movement towards resolving the nation's problems (healthcare, drug prices, infrastructure, teachers' pay, clean air & water, etc., etc.) And why Mitch McConnell, at age 77, is insistent upon running again for the U.S. Senate, to help keep the status quo that's intentionally destroying America. And why, at all costs, Nancy Pelosi needed to win the House speakership again. And why **no Democrat** has brought material evidence against Trump. And why the Democrats have not invoked the War Powers Act to stop Trump from starting a war with Iran. And why the Robert Mueller investigation cleared Trump of wrongdoing while throwing grass root Democrats the "false bone" of *obstruction of justice* (i.e., Trump interfering with that investigation); while every credible lawyer & trial judge knows an obstruction charge cannot exist if there's no crime committed. But the Establishment requires media pundits to accept this falsehood. In fact, there was never a legal basis for the Mueller investigation since

there was **no probable cause** to affirm a crime was committed. (Though we now know Trump is an agent of Russia, he hid his tracks well during the 2016 campaign.)

And in fact, the Mueller investigation is a "double scam" upon the American people by the FBI planting two undercover agents inside the Trump campaign in 2016 and **found no probable cause** of any crime committed. So there was never a legal basis for the Mueller investigation.

All the "smoke-and-mirrors" (including today's inundation of sports & entertainment) are necessary to



keep the American consciousness filled with bullshit while the plan for martial law proceeds. The Establishment deems martial law is needed due to success of the 2018 elections that brought-in new Congressional blood to replace the old guard. The younger new blood knows little or nothing of the complex schemes in-place designed to keep Americans on their knees (student debt, growing poverty, high rent, high drug costs etc., etc.). These schemes include (but not limited to-) the three unlawful policies that are transferring wealth to Wall Street from the commercial sector and the healthcare scam. And whereby, the new leadership is putting these schemes at-risk for the old guard. The new leadership includes Rep. Alexandria Ocasio-Cortez (D-NY) and Rep.

Ayanna Pressley (D-MA). And Rep. Justin Amash of Michigan recently converted to Independent from the Republican Party. He's known as a workhorse and pushes for gov't accountability. He may challenge Trump in 2020. ¹ — The old guard cannot afford the elected new blood to move-in to take the prized control of the American republic with a: \$17 trillion economy, \$4.5 trillion annual budget, and management of the global U.S. dollar. Hence, the old guard can stop the push for eventual change by imposing martial law in attempts to hold power. They don't realize (thru their two-dimensional thinking) that "unbalanced governance" makes them irrelevant (of which is why they lost the 2018 elections). I.e., they cannot hold power without meeting the needs of Americans.

And finally, but not the least, the status quo, lead by Robert Mueller, himself, is instructing media pundits to misinform the public that, "Trump cannot be charged with a crime while in office." To the contrary, the President can be convicted in office. **The U.S. Constitution, Article 2, Section 4, so states:** "The President, Vice President and all civil Officers of the United States, shall be removed from Office on Impeachment for, and Conviction of, Treason, Bribery, or other high Crimes and Misdemeanors." And see *Media*, pg.14.

¹ The three unlawful policies are identified in my May 30, 2019 letter to U.S. Rep. John Yarmuth supporting the ***Economic Normalization Act*** bill (bill is not drafted yet) at www.prose-litigants.org. They are causing the high rent and food insecurity crisis, shortages in social security, the Kentucky pension crisis, and more.

1. "Parole-in-Place" (PIP) Program Revoked to Hurt Service Members (As Soon as Trump Took Office)

OFFENSES: a. Conspiracy to sabotage the U.S. military; b. Weaken national security; c. Abuse of gov't resources; d. Wanton harassment of service members; e. Treason.

If you are not yet convinced that Donald Trump is an agent of Russia, then consider his



almost immediate Jan. 24, 2017 Executive Order that revoked the parole-in-place (**PIP**) program for U.S. service members. Finalized in 2013 by the Dept. of Homeland Security, PIP allows the undocumented immigrant family members of service members to remain in the U.S. while their "green cards" are processed. It was tailored to the U.S. military so service members would not worry that their immigrant family members would be deported. The Pentagon understood that the worry of deportation would deter military readiness with this stress on the minds of service members, most especially when they are deployed.

Yet can you believe that soon after Trump took office, he signed his Executive Order to end PIP? He actually seeks to break-up the families of service members. According to the July 5, 2018 press article from the *Military Times*, "As many as 11,800 service members face deportation

issues . . .” Many of the children are therefore adopted by American service members. This is a dire need for reducing adolescent violence, including gang violence from angry boys who grow-up without their fathers.

So Trump began compromising military readiness as he took office by disrupting morale and sowing mistrust within the military ranks and by making the recruitment targets more difficult to reach. Here from the beginning he started weakening America with acts of treason. For there is no other rational reason to revoke the PIP program that has become a critical component of military readiness. **Wherefore, Mitch McConnell and Nancy Pelosi must lead Congress to reinstating the PIP program.**

Trump’s early-on 1-24-2017 revocation Order (*supra*) proves his “plans to disrupt America,” planned well prior to his entering the White House. He was a traitor when entering the White House. (The broadcast media did not report removing PIP as a treasonous act to disrupt military readiness. The mainstream media’s silence on Trump is suspicious at-best.)

2. Nancy Pelosi & Mitch McConnell, No More Cover to Hide Under

OFFENSES: a. Conspiracy to assist Trump in imposing martial law; b. Sedition; c. Aiding and abetting to commit treason.

The *First Petition* showing how Trump committed fraud and treason to

impose the 2018 tariffs on U.S. steel and aluminum companies cannot be explained away. He based the tariffs on both industries as a matter of “national security.” Then in April 2019, Mitch McConnell announced the deal for the Russian company Rusal to purchase a 40% stake in the aluminum manufacturing start-up in Appalachia Kentucky, called Braidy Industries. And that 40% stake will only cost Rusal 11.7% at \$200 million. This give-away of a U.S. national security industry to Russia contradicts Trump’s stated purpose of the tariffs on steel and aluminum.

And it’s been very painful for the U.S. Since then, General Motors has closed five manufacturing plants in the U.S. with a reported loss of \$1 billion. In June 2019, all three steel producers in the U.S., U.S. Steel, Steel Dynamics, and Newport Steel reported heavy financial losses. U.S. Steel is closing a production smelter in the UK.

Yet McConnell & Pelosi still refuse to remove Trump on that fraud and treason. **Pelosi gives the flimsy excuse** that she does not want to upset



Trump’s voter base. But even Trump’s own internal polling says he cannot win in 2020. **Moreover**, he can’t run in 2020 if he’s in prison for “provable treason,” ETC.

So if upon the herein 2nd Article-1 Petition Pelosi and McConnell does not remove Trump, then the nation must call for their resignations and convictions, too.

3. Trump Forcing Iranian Poverty to Start War While Iran Offers to Negotiate w/ Commitment to Not Build Nuclear Weapons (Iran: We are Ready for Negotiations if You Lift Sanctions)

OFFENSES: a. Conspiracy and fraud to start a war; b. Acting to degrade U.S. national security; c. Fraud to declare martial law.

On July 8, 2019 when Iran announced it would enrich uranium past 4% but will not build a nuclear weapon, that became the negotiating point for the Trump administration to offer scaling back sanctions (to let Iran breathe again) and enter into negotiations. 90% grade for enrichment is needed for a nuclear weapon.

Then on July 19, 2019 Iran's Foreign Minister to the U.S., Mohammad Javad Zarif, said **"Iran will accept inspections of its nuclear program in return for lifting sanctions."** This again is a point for the U.S. to begin talks with Iran. Yet instead, the U.S. says it will send 500 more troops to the region. Trump continues his unnecessary drum-beat towards war. ²

² The only practical way to deal with Iran's power (its oil and 70 million people) is to "arrange a seat at the table" to share power if it will abandon "sharia law" for its proxies. For example, Iran can manage a Marshal Plan within each nation of its proxy militias. In this way, these militias can be replaced with officially recognized Iranian security forces (but give the *Revolutionary Guard* a friendlier name - ☺). A nuclear deal can extend to 30 years with options for extensions for if things go well.

Still, what makes conspiracy plausible between Trump and Iran is the Taliban in Afghanistan gets much of its support from Iran as Trump cozies-up to the Taliban with negotiations while leaving-out the voter-elected Afghan gov't. Have you wondered why he's leaving out the Afghan gov't? . . . which makes no sense at all unless he is conspiring with the Taliban, and Iran to make war. Then this puzzling scenario makes sense. (Source: Tower.org) If so, he will ultimately give over Afghanistan to the Taliban **for more suffering of the Afghan people.**

But with the offer to negotiate, Trump must reasonably give Iran the benefit-of-the-doubt unless Iran shows that it's not serious about further enrichment. Again, this is the point for the U.S. to negotiate through leverage. **For example,** Iran can normalize relations by agreeing to not provide military assistance to its proxies in other nations.

There was never a cause for Trump to back out of the nuclear deal to renegotiate anew, but only to add to what was half-achieved in the 2015, 10-year, Obama deal with Iran. 2015 was an interim deal, at best.

This is the basis for Attorney General Barr, Mitch McConnell, and Nancy Pelosi to charge removing Trump based on his intent to start a needless war. Then **Congress should immediately vote** to relax sanctions and allow Mike Pence, as President, to begin negotiations.

4. The Fake But Dangerous Cable Feud Between Trump & UK Diplomat Kim Darroch (Yet Another of Trump's Cons)

OFFENSES: a. Conspiracy to sabotage U.S. foreign relations; b. Weaken U.S. national security; c. Abuse of gov't resources; d. Aiding and abetting to commit treason.

In early July 2019, the Trump administration decided to make a big deal of intercepted communication cables from the UK ambassador in the U.S. to his home nation. These are the confidential cables of UK Ambassador Kim Darroch beginning f/ **2017**. (Can you believe that?). The cables state Trump is "in-ept," "in-secure," & "his administration will end in disgrace."



Darroch further described the economic policies of Trump as "chaotic to the world trade system." UK Prime Minister Theresa May said his comments are "frank assessments." She stated she appreciates the frankness of Darroch. — For sure enough, the world is suffering significant down turns in trade.

To name a few instances: on July 15, 2019 China reported a .2% downturn in its economy attributed to the trade war; as reported in above Section 2, the U.S. steel industry reported heavy losses since

Trump's fraudulent tariffs on steel and aluminum in 2018; oil prices are up sharply due to the manufactured, unnecessary tensions with Iran to start a war.

Yet only now is this old 2017 news of Darroch's remarks being publicized, with Trump acting surprised, raising hell, and implicitly calling for Darroch's resignation. On July 10, Ambassador Darroch resigned his post in the U.S.

But Trump's game of creating chaos to weaken America, by creating a wedge between the U.S. and our allies, is apparent, here, too. For whoever leaked the aged Darroch cables, whether on the U.S. or the UK side that supports Trump, has widened the wedge. The UK will now think twice about helping the U.S. if Trump goes to war with Iran, of which is apparently his strategy so he can go-it-alone to increase American vulnerability for when declaring martial law. (And it is likely that Iran wants a war to see Americans under martial law.) — **For example**, on July 23, 2019, the UK announced it is discussing a multinational oil tanker patrol with the E.U. for the Strait of Hormuz but without U.S. involvement.

As indicated, the fact that these old cables were leaked at this opportune time, for exploiting U.S. tensions with Iran, etc., indicates the scandal was indeed planned by Trump and allied operatives within the UK gov't. It's even more reason that we all demand Trump's removal from office.

5. Erasing U.S. Gains in Afghanistan and Surrendering to the Taliban After 18 Years (This Will Increase Anxiety in Americans)

OFFENSES: a. Conspiracy to sabotage U.S. foreign relations; b. Weaken U.S. national security; c. Abuse of gov't resources; d. Aiding and abetting U.S. adversaries ; Treason.

In Section 3, we've already shown the motive for Trump to give-up the hard-fought gains in Afghanistan. It is in and of itself treason being committed here. He is abandoning the core Western rights of women acquiring education, voting, etc. Yet most frightening is his desire to leave the Afghan people solely in the hands of the tyrannical Taliban who ruthlessly rule similar to ISIS by sharia law. He is violating the standing U.S. policy of not negotiating with terrorists, as the Taliban routinely takes responsibility for bombings in Afghanistan. It confirms his disregard for Western values and how he enjoys the values (or lack thereof) of Communism and Fascism. His behavior is unbecoming of an American President and thus the Afghan situation demands his removal from office, and we must keep demanding until he is gone (imprisoned or sent to Russia).

The fact that neither the Republican or Democratic parties are openly railing against him on Afghanistan, their not calling for his removal, is suspicious and speaks to the danger we are creating for ourselves and others around the world. For other leaders tend to gauge their behavior depending on how the U.S. behaves; i.e.,

will we chide and seek to correct the wrongful policies? Trump is actually ignoring the duly elected Afghan gov't to support the Taliban. This is woefully unacceptable and violates the very norms of democratic values. He is anti-democratic, a communist.

Yet, **moreover**, he is ignoring all the thousands of fallen American and Ally soldiers and civilians and of these countless others who live from their wounds today from over these 18 years. If we allow him to abandon Afghanistan in this manner, our service members will have died and suffered for absolutely nothing. Then President Bush's invasion into Afghanistan in 2001 will be an abomination. This will come back on haunt America and forever stain our national character, most especially as we watch Afghanistan seep further into deterioration by the Taliban.

Thus we must remove Trump and at-least again conduct the troop surge that was successful in 2004 (with 28,000 troops). But this time an additional five-year campaign should be initiated that combines special-forces, covert surveillance, and a special forensic investigative police operatives-force for hunting down terrorists; to not wait for them to come to Afghan neighborhoods and U.S. targets, based on General Colin Powell's war doctrine (called the Powell Doctrine) of overwhelming force. The West can then provide a low-cost Marshal Plan that guarantees loans for businesses in the country (for those with completed Business Plans with Balance Sheets submitted from standardized templates) and a micro loan program

for farmers, home businesses, and employed citizens (micro loans have shown to be very successful in helping to raise people out of poverty).

One of the most important tactical moves we can do for peace in the Middle East is to help stabilize Afghanistan by upholding the most basic human rights, including women's rights to vote and education.

Either way, it's an act against the U.S. Presidency, itself, for Trump to behave in this manner, to give-up the 18 years of blood and treasure to the ruthless Taliban. Yet it will only take a little longer with a visionary President to get the job done. — America will lose her soul and increase the already rampant anxiety and mental depression that plagues our society if we walk away from Afghanistan in this manner. We have to stay and finish the job. But this time with a discrete Marshal Plan and aggressive hunt-them-down security plan.

Even further, if we leave the Afghans in the hands of the Taliban with no civil support, Afghanistan will become a nation that hates Americans, a nation of potential terrorists against the United States. Americans and its interests abroad will not be safe and become a bed of our own making. We should remember the reason we went to Afghanistan, by the 9/11 attacks. — So again, we must demand the removal of Trump and promote discrete, long-term policies for giving the Afghans reasons for wanting to ally with America, not against us as enemies.

6. The Fake July 14, 2019 Migrant Arrest Roundup (More Evidence of Weakening America)

OFFENSES: a. Conspiracy to sabotage U.S. foreign relations; b. Weaken U.S. national security; c. Abuse of gov't resources; d. Aiding and abetting to commit treason.

This, too, is one of the classic cons of Trump, to make his followers believe he is serious about cleaning-up illegal migration. If he were serious, he would not announce the roundup but act quietly to conduct arrests, such as President Obama quietly rounded-up and deported record numbers of illegal migrants.

By publicly announcing the roundup, migrants will move around and hide until it the raids die down. Sen. Amy Klobuchar (D-MN) stated this very point on *ABC This Week*, July 14, 2019. So he is not serious about stopping illegal migration. If he were, deportations would be underway without public announcements, and he would stop them from entering the U.S. at the border and work with the economies of Central America. But manufacturing the crisis adds to his intended chaos. — In fact, consistent with Trump's behavior in weakening America, he has not made a priority of deporting migrants. Again on July 14, 2019 on *ABC This Week*, Acting Director of USCIS (U.S. Citizenship & Immigration Service) Ken Cuccinelli confirmed that Trump has not kept pace with the amount of deported migrants under President Obama. Then to further affirm

Trump's con, on July 15, 2019, *NPR* (Nat'l Public Radio) reported that there was no appreciable activity of deporting migrants as he had declared.

Instead, for those migrants turned away by the Mexican authorities, Trump has allowed more in the U.S., to exceed 140,000 in June 2019 alone (**the yearly limit under the *Refugee Act of 1980* is 50,000 migrants**). By not deporting, he allow migrants to overrun the U.S., threatening national security. He is achieving his aims of weakening America. — On this basis, too, **he should be impeached and run out of America, sent to Russia where he really wants to be.**

7. Japan is Joining to Start an Economic Recession for Lowering Interest Rates in the U.S. (Or It's a Disturbing Correlation)

OFFENSES: a. Conspiracy; b. International securities fraud; c. Abuse of gov't resources; d. Aiding and abetting Trump in committing treason.

There is strong circumstantial evidence that Japan is helping Trump to create an economic recession on the basis for lowering the Fed prime interest rate in the U.S. For without good reason, Japan is threatening to reduce three key commodities for South Korea's electronics industry. These commodities are 1) fluorinated polyimide (used in smartphone displays), 2) photoresist, and 3) high-purity hydrogen fluoride. Japan is a key supplier of these items. South Korea says these trade restrictions, especially if prolonged, can

hurt the world markets to drive down trade in electronics. — Japan gives the excuse that the restrictions are for its own national security. But Korea says the friction is due to the a Korean trial court ruling requiring Japan to pay damages to Korean slave labor victims from World War II.

But it's not likely that Japan would threaten the world economy over a period in history. There must be more to it than that. For Japan has called for an arbitration panel to help settle the slave labor matter.

So why is the need to restrict exports to So.Korea? Why would Japan, at this point in time, hurt its own markets for this reason? It seems the reason is much bigger such as the intent to start a global recession for acquiring low cost loans in the U.S. Japan already has negative interest rates that suppresses growth in its own economy. So its companies would enjoy lower rates in the U.S. of which the cost of capital is reduced on the global stage, i.e., with the U.S. dollar. — Just as during WWII, Japan does not seem to consider its relationship with the rest of the world, just as it does not consider the prosperity of its own people today. This thinking correlates with Donald Trump's behavior acting to exploit the Federal Reserve for lower rates that will surely injure the U.S.

As pointed out in the *First Petition*, the perpetrators have to create the conditions for a recession as an excuse to lower rates. Prolonged tariffs will do that (recall that the three steel manufacturers in the U.S. are doing badly from the tariffs). And Japan restricting mainstream critical commodities in the electronics industry in

conjunction with tariffs will do it, cause a recession. When the economy tanks, then the biased pundits will claim that rates need to be lowered to rebound the economy. Though an economy cannot rebound from low rates (as shown in Japan today).

To the contrary, the U.S. economy began to take off in 2017 thru 2018 as Federal Reserve Chairman Jerome Powell incrementally raised the prime interest rate. It's a natural occurrence for the economy to improve with increased rates.

In a July 16, 2019 NHK News report, Executive Economist Takahide Kiuchi at the Nomura Research Institute in Japan said its never good for politicians to manipulate monetary policies for exploiting central banks for political gain. He said "Central bank autonomy should never be violated . . ." such as Trump is pressuring the U.S. Federal Reserve to lower rates. — A further case-in-point is the European Union (ER) Central Bank having a 0% prime rate that has not had growth in its economy for years. — Low rates are a way of transferring currency wealth to corporations thru low-interest debt/loans that prevents currency distribution to the people/economy at-large. Refer to footnote 1 on page 7 re: the three bad U.S. policies.

If the U.S. maintains its bad monetary policies, it's only a matter time before China's economy (with a normalized prime rate) will overtake the U.S. economy, just as Japan was overtaken by China. Whereby, it's apparent that Trump is conspiring with Japan to start another recession. And again

they will then falsely justify that low rates are needed to grow the economy even though the historical evidence shows just the opposite results of low or no growth economies. So Trump must be impeached on this basis, too, to protect the U.S. from yet another needless recession.

8. Corporate Broadcast Media Refusing to Report Crimes of Trump, Etc. (The Case for Breaking-up Broadcast Media Into Independent Outlets)

OFFENSES: a. Conspiracy; b. Weaken U.S. national security; c. Aiding and abetting to commit treason.

In June 2019, *CBS This Morning (CTM)* terminated much of its investigative production team and finalized its shake-up of co-hosts for the new makeover of the show. *CBS* broadcasting is the last bastion of the major networks to report "real news" to the public. CTM is famous for reporting nuanced "news you can use" on Gov't reports and its behavior. CTM routinely forwarded the reports of newspapers from around the country, with a mix-up of human-interest stories that are specialized by the other major networks.

But by June 27, Sara Nathan at PageSix.com reported that CTM viewership was down in June. And more curiously, by the week of June 17, the viewership was markedly down for all the three major morning shows. — Another curious matter is that none of the networks are mentioning the word "impeachment" based on the crimes of Trump even though the public is

calling for impeachment. Could it be that Americans see the corporate networks touting the political establishment to help avoid the impeachment of Trump? For the networks have the inside facts and research on the crimes of Trump well beyond the information given in the herein Petition. The alternative media, such as PageSix.com, is reporting these facts but not making it to the broadcast networks. And thus the local affiliate broadcast stations are following the networks. — Per Section 1 (pg. 7), this conspiracy with Trump began at the very beginning of his presidency where the networks failed to point-out his terminating PIP would weaken the U.S. military. That Trump is acting against service members and military readiness. — So could it be that Americans are growing weary of the media, too? This may account for the low viewership despite the marketing efforts of the networks; very pissed-off Americans.

Since CTM's make-over, we cannot learn what Gov't is doing "behind the scenes" through the networks. They are acting as though Trump is legitimate. For example, the CAATSA (pg. 17) requires Trump to terminate the sale of U.S. F-35 fighter jets to Turkey. But the networks (and Congress not shouting loud enough) are allowing him to skirt this illegal sale that would endanger U.S. security. He once again would be committing treason and acting to weak-



en the U.S. by selling F-35s to Turkey while operating Russian S-400 missiles.

It's already pointed out (pg. 6) that the Robert Mueller investigation is fake news. All of it. (Recall that there's no probable cause, not even during the FBI's undercover investigation of the Trump campaign.) But the media is reporting as though everything here is legitimate. — Another case-in-point, the networks are not reporting on the fake migrant roundup earlier this month. Apparently the Trump administration is not even doing the minimal deporting of migrants through the regular course of ICE and Border Patrol. For here, too, treason is being committed by jeopardizing the national security of the U.S. through essentially open borders. — The media networks allow all of these falsehoods (while at the same time conning Trump's base supporters).

It makes the glaring case that broadcast media is not serving the public. Since the public owns the airwaves, the Supreme Court specifies that broadcast stations must operate within the interests of the public; they cannot legally operate against public interests for political gain. So per the violations of public interest identified in these Article-1s, they should be broken-up into separate, independent entities, to not be affiliated with other corporate interests. For example, the *ABC* broadcasting network, now owned by Disney, should divested from Disney. *ABC* should be a separately independent company not affiliated with another corporation. Furthermore, a broadcast company should be a corporation with "open stock offerings" for

anyone to buy into it. And no stockholder should be allowed to own/purchase more than 1% of that media stock so that “dis-tributive ownership” is achieved.

Through these independent and limited competitive ownerships, only then will the broadcast media have interest in protecting the public’s interest. Attorney General Barr should recognize this dangerous influence by the corporate media.

9. Why Trump Does Not Nominate Dept Heads for Key Cabinet Positions; It’s Easier to Impose Martial Law, But Violates U.S. Constitution

OFFENSES: a. Conspiracy; b. Weaken U.S. national security; c. Aiding and abetting to commit treason; Violation of Article 2, Section 2 of U.S. Constitution.

President Trump has no Senate-appointed heads for the Secretary (Sec.) of Defense, Sec. of Labor, Sec. of Homeland Security, White House Chief of Staff, UN Ambassador, OMB Director (Office of Management & Budget), and the SBA Administrator (Small Business Administration).

Also there’s no administrators heading ICE (Immigration & Customs Enforcement) or FEMA (Federal Emergency Management Administration). On July 14, 2019, Rachael Bade of the *Washington Post* told *ABC This Week* that the Senate has been pushing for confirmations for awhile now but Trump has stated he likes having “acting heads” because it’s easier to get things done. I.e., there’s less accountability to the Senate. There is less

push-back from acting heads when decisions are made. (For example, during the last fiscal year, Trump ran-up budget deficits to \$730 billion.)

The other grave security issue here is these acting heads have not been vetted by the Senate and thus there is potential for security risks that can pop-up when least expected such as during a war with Iran of not having a Secretary of Defense or UN Ambassador. The public does not know who these people are without Senate public proceedings.

And yet the most critical danger we’re in regarding the acting heads is Trump can more easily impose the martial law of which he is apparently planning. When the Senate does not confirm acting heads, they have no direct accountability to Congress and serve purely as appointees by Trump. Senate-approved Dept Heads are needed to help keep the President accountable. **For this, too, violates the Constitution and grounds for impeachment under Article 2, Sec. 2.**

During martial law it will be more difficult for Congress to remove his acting heads So the danger is apparent. For example, the Secretary of Defense would play a critical role in checking the President during a war with Iran (**such as Trump is now supposed to enter negotiations upon Iran’s latest requests**). And a Senate-approved Secretary of Homeland Security can rail against the fake migrant policies of Trump; recall that he is not deporting many migrants and will exploit this

condition during martial law.

Director of the OMB is yet another critical position needed for push back. The OMB alerts the public of the spending levels of the President. For example, despite the so-called strong economy, our debt continues to grow, though he promised the economy would decrease the debt. This negligence and ineptness, too, are grounds for impeachment with the \$730 billion in deficit spending already cited.

And here, too, the corporate media and Congress are supporting these unlawful acts of not appointing and confirming dept heads for protecting Americans. So having a gov't of mostly "acting dept heads" is grounds for impeachment.

10. Trump Intending to Violate CASTSA that Blocks Sale of U.S. F-35 Fighter Jets to Turkey When Operating Russian Missiles (To Further Weaken U.S. for Comm. Takeover)

OFFENSES: a. Conspiracy; b. Weaken U.S. national security by assisting adversaries; c. Treason.

On July 17, 2019, Trump announced that Turkey cannot receive the F-35 fighter jets from the U.S. while taking delivery of Russia's S-400 missile system. That announcement is consistent with the 2017 "Countering America's Adversaries [Thru] Sanctions Act" (CAATSA) that bars the sale of U.S. military equipment when the nation is buying significantly from a U.S. adversary. The CAATSA was signed by Trump.

But in his typical waffling fashion, on July 19 Trump announced hesitancy on stopping the F-35 deal to Turkey. This is even though the CAATSA by law requires the deal to be stopped. He said Turkey was not treated fairly since President Obama made the deal without U.S. Patriot missiles for Turkey's President Recep Tayyip Erdogan. **(It's complicated.** It's very likely that President Erdogan is moving away from U.S. dependence so he can use Russian hardware to attack the Kurds in Turkey's northern district. For decades the Kurds have wanted to breakaway from Turkey. Against Erdogan's wishes, they allied with the U.S. to help drive ISIS out of Syria. So the U.S. owes the Kurds; essentially, they are U.S. heroes. So during Trump's typical waffling, President Vladimir Putin offered to sell Russian jets to Erdogan.)



The situation reflects the usual U.S. foreign policy of wanting to "eat its cake and have it, too." When doing so, other nations are left "holding the bag." Now the U.S. Senate must force Trump to uphold CAATSA or move to impeach him for yet another illegal policy that threatens U.S. security. We cannot allow Erdogan to have F-35 technology while armed with Russia's S-400 missiles.
