

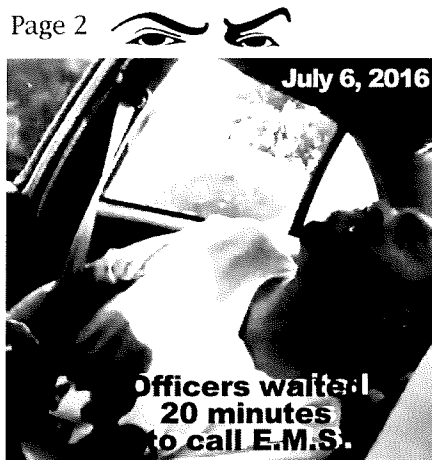

•PHILANDO CASTILE, ALSO GOV'MT-ORDERED EXECUTION

The first evidence of Castile's death being an execution is the police officers' (Jeronimo Yanez & Joseph Kauser) false statements to the media (**official misconduct**) stating they stopped the car for a broken tail light. 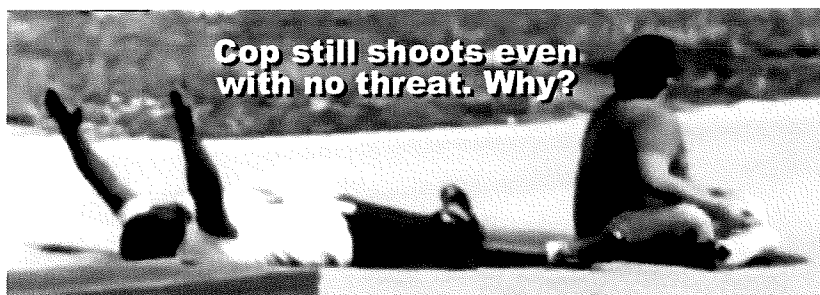

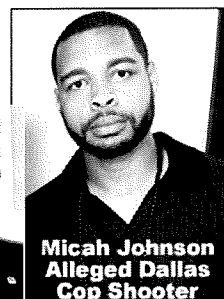
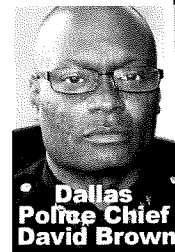
•ORDER GIVEN TO EXECUTE CAREGIVER CHARLES KINSEY

Because the officer officially said he aimed for the sitting autistic man but missed and shot Kinsey in the leg. But if that were so, then why didn't he shoot again to hit the sitting man he said "was a threat." For further contradiction, he later told Kinsey, "I don't know why I shot you." -- The officer **could not carry-out the Order**, of which he did not personally know Kinsey.



•WHAT IS REAL EVIDENCE ON MICAH JOHNSON?

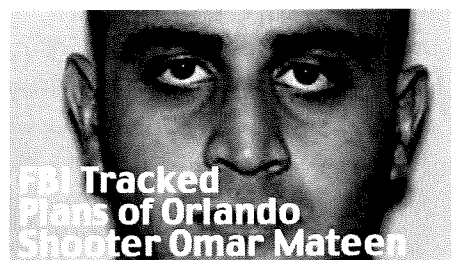
We're told shooter **Micah Johnson** did all the damage on July 7, 2016 by killing 5 cops and injuring 6 others, & one civilian. But given the culture of deceit amongst U.S. police, can we really trust the **hearsay information** from **Dallas Police Chief David Brown** that Johnson did all the killings? Thus, we / you should ask Chief Brown to release the 90-minute audio transcript of the negotiations with Johnson. - Publishing the actual evidence would clarify July 7 for us.



We should also request the **forensic ballistics** on Johnson's weapons to verify that all the bullets in the 12 victims match-up. - Furthermore, Chief Brown violated the law when he gave the Order to kill Johnson. The robot could've been fitted with tear gas or other arresting agent to take Johnson alive. Then we would've learned first-hand of his intent, for future incidents.

GOV'MT COMPLICITY W/ORLANDO MASSACRE (see EVIDENCE for yourself)

To follow evidence of gov't complicity with the June 12, 2016 Orlando *Pulse Nightclub* massacre, you have to think like Lt. Columbo; you must piece together the little but obvious details.



Recall that Orlando shooter Omar Mateen visited gun shop *Lotus Gunworks of South Florida* in Jensen Beach, FL, approx 5 weeks prior to the massacre (WPTV-5 News, FL). Shooter Mateen's request for "body armor" prompted shop owner Robert Abell to contact law enforcement. Though not reported, obviously Abell gave surveillance video of Mateen to FBI, and, too, Abell and his employees were not taken to FBI headquarters to pick-out Mateen. This was the **evidentiary lead** that Mateen, **an already FBI-known radicalized Arab**, was planning a violent crime. Yet law enforcement did not intervene and allowed Mateen to go forward.

This material lead "in-hand" is also evidence the FBI / Gov't must've continued to follow Mateen up to the June 12 massacre. Furthermore, Abell is not allowed to discuss which law enforcement agency he contacted. – **Pres. Obama is directly implicated**, here, because after each Gov't-licit shooting occurs, Obama attacks the 2nd Amendment for gun control without taking any action to respond to these crisis. – Wherefore, **all citizens** should submit this evidence w/Petitions (**attached**) to U.S. House Speaker Paul Ryan and U.S. Senate Leader Mitch McConnell, to charge FBI Director James Comey, U.S. Attorney General Loretta Lynch, and Pres. Barack Obama w/ **complicity to mass murder, negligent homicide, & treason**.

Your Petition should also request an independent Counsel to "gather" the details.

•ALTON STERLING, GOV'MT-ORDERED EXECUTION

Here again, follow the small but obvious details. On July 5, 2016, Baton Rouge police officers (names mysteriously not available) were told by 911 Dispatch that 37-year old Sterling had a gun (alleged witness reported he was brandishing a gun).



With this information, proper protocol for the officers is to "cautiously approach" Sterling and ask, "**Do you have a gun?**" If no answer from Sterling, the officers would order him to lay "face down" (on his stomach) to be handcuffed. If Sterling still does not comply, then officers must consider Sterling a danger, draw their firearms, and again order Sterling to comply with "verbal threats" of firing their firearms, "**Please comply, or we will fire on you.**"

However, this protocol was violated. Instead, these officers, amidst the "alleged" potential threat of Sterling's gun: approached & grabbed Sterling without their guns drawn, wrestled Sterling to the concrete, and then **pretended surprise** by shouting "**He's got a gun,**" and then shooting Sterling in a fatal body area (the chest), even though they were both on top of Sterling, able to grab any such gun from Sterling. – This evidence of events clearly demonstrates the officers' intent to murder Sterling. And because these officers did not personally know Sterling, it is also evidence they were ordered from higher-up gov't to execute Sterling prior to arriving at the scene. – With the Orlando massacre being gov't sponsored, Sterling's execution is "prima facie" evidence of hierarchal connection to Orlando.

– **Gov't motive:** With glaring evidence of the next-day execution (July 6) of Philando Castile in another city (St. Paul, MN), the only obvious motive of Gov't is to incite **national race riots** to impose "martial law." This motive, of course, reaches Pres. Obama, since only he can impose martial law. Wherefore, we / you must demand his removal from office.
